

Two fatal accidents cause two Mount Vernon deaths

A Mount Vernon resident died from injuries, Tuesday, February 13th, after his Toyota Rav4 truck hit a tour bus carrying a well known country music entertainer from Garrard County head-on.

According to a Kentucky State Police report, James McPheron of Mt. Vernon was traveling West on South Wilderness Road in Rockcastle County when he lost control of his vehicle and crossed the center line, striking the tour bus head on.

Rockcastle EMS, KSP Post 11 personnel Kentucky Commercial Vehicle Enforcement, the Mount Vernon Police Department, the Mount Vernon Fire Department and the

Rockcastle County Coroner arrived at the scene to find McPheron badly injured from the accident. EMS crews transported the Mount Vernon native to the Rockcastle Regional

Hospital, where he succumbed to his injuries.

The tour bus was being driven by Roger Miller of Lancaster. Also

Eight less days in school calendar for 2024-25

The school calendar for the 2024-25 school vear has been approved and there were several changes, including a shorter school year.





(Coninuted from A2) cans and 80% of adults overall believe that the government is doing a "very" or "somewhat" bad job of dealing with illegal immigration. Only 18% have a positive view of the government's handling of the border, with 1% claiming that the government is doing a "very good" job.

You would think, particularly in an election year, that the DC regime would be making some fast moves to remedy the catastrophic situation they have created at the border. Are they? No they are not!

Their party line is that Republicans are at fault because they wouldn't support a \$115B funding bill that included an additional \$60B for Ukraine, besides the \$113B already sent to them (to be laundered by their puppet Zelensky and the DC crowd's share returned to them). Of course there was \$20B included for our border and a great deal of that was to hire thousands of more border agents. You know, those who have been directed, by the federal regime, to help illegals across the border.

I'm tired of it. I'm tired of the Director of Homeland Security Alejandro Ma-yorkas telling Congress that "the border is secure" when that is the farthest thing from the truth possible. The House has impeached Mayorkas, the first sitting cabinet member to be impeached, charging him with willfully refusing to enforce border laws and breaching the public trust.

Of course, the charges against Mayorkas will, no doubt, be rejected in the Democratic-led Senate where conviction would require a twothirds majority and where even some Republicans have called the effort dead on arrival.

But, never fear, the New York Attorney General Letitia James, District Attorney Alvin Bragg and Mahattan Supreme Court Judge Arthur Engoron combined to hit former President, and leading candidate for the Republican nominee in this year's Presidential election, with a \$363.9 million judgement against him and his co-defendants, including his sons Eric and Donald Jr., or about \$464 million with interest which is being calculated from 2019.

Engoron ruled before the trial that Trump and his co-defendants committed fraud with his financial statements. This was in spite of no criminal complaints from any financial institutions that Trump dealt with. In fact, several banking officials testified on behalf of Trump during the trial saying there was no fraud involved in the transactions and they were well satisfied with the repayment of the

Trump will, no doubt, appeal the verdict, to which 9% interest is being added daily. But to do so, he will have to put up cash or assets in the amount of the verdict and the appeal will take about a year before a decision is made.

Several prominent

businessmen in New York have denounced the verdict and the obvious vindictiveness of James, Bragg and the judge. One pointed out that there is currently only 52% occupancy of business buildings in the city and he expects more businesses to leave the city over this travesty of justice.

I know I am hung up on the illegal immigration issue but it breaks my heart to sit back, unable to do anything but bemoan the demise of our country. The saddest thing is realizing that the majority of our leaders in DC lack the will to fight against this invasion. Time will tell if the majority of voters also lack the will to replace them at the polls.





(Continued from front) on the bus was Miller's son, and former American Idol Season 1, contestant Alex Miller, and several members of his country music band, who were on vacation at the time of the accident.

According to police reports, no one on the bus was injured.

At press time, officials say they still do not know what caused McPheron to lose control of his vehicle and the accident is under investigation by Post 11 Trooper Arron Jones.

The Rockcastle County Sheriff's office also reported another fatal collision that occurred on US-461 near Doc Adams Road Monday night.

The Kentucky State Police and the Sheriff's office worked the scene closing lanes of the roadways involved.

Deputy Sam Brock said the accident involved only one vehicle. The name of the driver, who was killed in the accident, has not been released pending notification of family members.

Brock said he is currently reconstructing the accident and an investigation is underway.

At press time no further information was available.

The calendar has shortened the school year by eight days. However. state law requires 1,062 hours of in-class instruction so officials have worked out a daily schedule that will effect each school differently. "We can't really say a specific time school will start and end next year because when you consider class time and the time for buses to get from one school to the other, start times and end times will be very hard to explain," said Reppert. In order to keep confusion to a minimum, Reppert says each school will contact all parents and explain the start and end times for their students at each school. "Rather than list a time in the paper and let people assume that applies to everyone, we will have to handle it individually,

All board members except Chairman Angela Mink, voted to accept the new calendar. Mink said she liked most things about the calendar but could not make herself vote for it only because she was concerned about cutting the number of days some students may have a safe place to be and a hot meal.

According to Reppert, all students will meet the 1,062 hours of required instruction under the new calendar.

Records

obtained a copy of a subpoena, served to the current Mayor Larry Davidson and City Clerk Samantha Smoker, requiring them to turn over any and all material relating to financial actions taken by the previous administration of Mayor Duane King and City Clerk Amanda Thomas.

The Criminal Subpoena lists the Commonwealth of Kentucky versus an unknown defendant and was issued on January 17. The subpoena commanded officials to appear before the Rockcastle County Attorney on January 24 to provide any and all records, including bills, receipts, etc, from any bank accounts of the City of Livingston for January 1, 2021 to December 31, 2022. The subpoena goes on to say that material should include, but is not limited to the general fund, police and tourism bank accounts.

On Monday, February 12 the sheriff's department arrived at Livingston City Hall and took possession of the city's computer system.

Current officials in Livingston have apparently cooperated fully with the investigation and there is no investigation into financial records of the current administration.

A Livingston city officials told the *Signal* that investigators intended to clone the computer system that was confiscated so that the system could be returned and used for city business while investigators examine the cloned computer files.

Current city officials say they do not know what investigators are looking for and the county attorney would only verify that there is a criminal investigation underway.

tendent said her conversations with both elected officials and others have led her to believe the grant will likely be extended and increased.

During the meeting Ballinger showed a video sent directly from the White House, congratulating Rockcastle County officials on receiving the federal Innovation and Modernization Program Grant. The spokesperson from Washington told the large crowd she and federal officials were proud that Rockcastle County's school district was focused on innovative ideas and the redesign of the workforce systems. "This grant will change the face of what Rockcastle County High School looks like," said Ballinger. "This is an opportunity for us to fight to see that our students graduate and then go directly to work in good paying jobs without having to leave the home they love."

Other guests at the meeting were Mount Vernon City Administrator Jim Bowman, County Judge/Executive Howell Holbrook, Jr. and RCIDA Executive Director Jeff VanHook. "We are simply here to celebrate the positive communication and collaboration between the school district, the city and the county," said VanHook, "The grant we received from the Governor last week for the regional industrial development park is just another example of us all working together to provide those jobs that will be waiting for our local graduating seniors. The youth of Rockcastle County and this entire

VanHook pointed out that 3,410 Rockcastle County residents wake up every morning and leave the county to go to work. "Our goal is to provide work right here in Rockcastle County for residents and then make people leave their community to come to Rockcastle to work," he said.

Bowman also expressed his appreciation for the willingness and interest of the school board to collaborate with local government. "The partnerships we have with the city, the county and the school board is what makes all this possible and we appreciate the work the school board has done to get this new grant that fits exactly into the idea of providing work for Rockcastle County graduates."

Holbrook agreed. "Every day I hear officials from other counties or in Frankfort bragging on our school district," he said. "We are all working toward the goal of trying to get something in place that this generation of kids can stay home and find work." Ballinger said.

Also at the meeting were representatives of the RCHS FCCLA (Family Career and Community Leaders of America) who presented studies indicating that 30% of Rockcastle County residents live at or below the poverty line. Club representatives said there are 204 businesses in the county but 67% of those employ four people or less. According to their studies, over 170 students in the county are considered homeless. The group challenged the board and community leaders to address the problems of poverty homelessness in the county.

Board members accepted the challenge and promised to keep such issues as a priority.

"This grant is a huge step towards attacking just such issues," said Ballinger. The superintendent indicated the collaboration between the board, the city and the county is one of many steps planned that will attack the problem of poverty and home-lessness.

Ballinger said the grant will have a major impact on the local school district and through innovation, creation and modernization, graduating students will find work in their hometown with high paying salaries for established companies a much easier task.

Some specific plans for such innovative modernization are expected to be announced once the grant has been received.

Sweet said the staffing guidelines were developed from previously adopted allocations and she plans to meet with principals to ascertain their needs for their school before bringing the tentative budget to the

Addressing monthly financial report, board member Matt Chaliff asked if it is normal for some of the budget items to show 100% or more of the budget used though the budget cycle is not over. Sweet explained that some items show 100% because they are complete and will not use more funds, others may have been miscalculated and cost more than expected due to recent inflation numbers. She also explained that some line items may show a negative number but that is typically one fund reimbursing another fund and can be a positive total balance.

In other action, Sweet asked the board to approve \$11,598 for a new, more robust accounting system. "The system we are using has been used for several years and needs to be updated to a more robust accounting system," she said. "We are also requesting an additional \$8,530 for technical support for the new system." This is Phase Iv of upgrading the system in the district. Sweet said next year she will ask for more updates and changes but the request will be for much less funds. "We need the newer system for many reasons but one of them is the reduction of paperwork," she said. "This new system will greatly reduce the amount of paper crossing our desks." Chaliff agreed with the idea. "We don't need to chase down a principal for a signature or create endless pieces of paper for every simple task. I am glad to hear we could simplify things for staff, students and parents as well as this board," he said. The request passed

unanimously.

It will open up opportunities for the medical community to provide necessary therapeutic treatment in a peaceful setting. Fox also asked for the support of the court in their endeavor.

Holbrook invited officials of the foundation to visit the building in question with him and a magistrate to inspect the facility. "It may or may not serve your needs," he said. "We will look at it and see if it is what you need." The court agreed. Holbrook said if the foundation requests to use the space, formerly used by Sheltowee Trace, he feels the court would "try to accommodate them" if possible. "It would be up to the fiscal court if that is what they need. We will look at it and bring it before the court if they tell us they need the space and it meets their requirements," said Holbrook.

In other action, the court received the monthly report concerning the gymnasium rental in Livingston which totaled \$1,100 for informational purposes only. The court also received the propane gas bill for the gymnasium during the same time which totaled \$4,280. Since the presentation was for informational purposes only. there was no action taken. However, more than one magistrate agreed that the court should look into the issue and consider changes to current procedures since rental fees are much less than expenses to operate the space.

The court also heard a report from the Rockcastle Animal Shelter which shows 17 dogs and six cats housed at the center at the end of the month. Over the month, the report shows 98 dogs and 11 cats that were disposed of through adoption, euthanization or death.

There was also a request to bring Lady Bug Lane into the county road maintenance system. The court agreed to visit the site to determine eligibility

Holbrook also reported total proceeds from the sale of 42 acres of county-owned property in Livingston was \$79,801 after fees and expenses.

The court also voted to transfer \$25,000 from the general fund to the 911 fund.

Having no further business, the court was adjourned. The next regular meeting is scheduled for Tuesday, March 12 at the courthouse.








Lady Rockets defeat Lincoln and Garrard







Rockcastle istorical aven

My father was a member of the Free Masons in Brodhead, Kentucky. I always teased him about secret meetings and funny hats. None of which he found amusing in the least. I often asked him about what happened at their meetings, but he would never divulge the events of the Lodge. He took their secrets to his grave. But that never stopped my imagination from going wild wondering about the mystery surrounding the secret society. Of course, Rockcastle History does have connections to organizations or social groups that existed for social, economic, and charitable reasons. These organizations are often secret organizations. With a membership that included many highly respected locals. Rockcastle County has been home to different fraternal organizations throughout its history. The June 26, 1908 issue of the Signal in a column titled "Mt. Vernon's Growth, Industries, etc." stated that Secret orders had a large membership. The Ma-

The Blue Lodge, Royal Arch Chapter, and Council, and another organization known as the Odd Fellows was also growing. Both the Masons and the Odd Fellows organizations were considering building larger facilities in the county.

While many are familiar with the Masonic Lodge, few know about The Order of Odd Fellows. This organization, according to the Library of Congress, was first founded in England in 1730. The organization began as a fraternal association that emphasized friendship among members. The Order followed many rituals and beliefs similar to those of the Free Masons.

The Odd Fellows organization came to America in 1819. The first Lodge was founded in Baltimore in the 1840s by Thomas Wildey of England. In 1843 the organization split over race issues. This resulted in two different Orders, the exclusively White Order of Odd Fellows and the predominantly Black Grand United Order of Odd Felsons had several lodges, lows. Membership in the

Odd Fellows lodges counted more than two million members in the 1920s. Even though the organization is not considered a religious organization, candidates for membership were expected to believe in a supreme being.

John Lair states in his book, "Rockcastle Recollections" that the "Odd Fellows Lodge was organized in Mt. Vernon in 1870. J.T. Clark, Charles Kirtley and J. L. Joplin were among the first members. Rooms were over the store of J. J. Williams..." The July 10, 1908 issue of the Mt. Vernon Signal in the Mt. Vernon Personals section ran a story about the first anniversary of the Mt. Vernon Lodge 319 I. O. O. F. "There were fiftyone Odd Fellows, with their wives, sisters, and sweethearts present. Mrs. Millie Miller, the hostess, had prepared a most delightful supper...Judge L. W. Bethurum acted as toastmaster...Dr. W. J. Edmiston, of Crab Orchard, district deputy, and Mr. L. K. Wells, also of Crab Orchard, was the first to speak, giving a brief history of the origin, progress, aim, and purpose of Odd Fellowship. Nex in order was Attorney C. C. Williams, who spoke for about ten minutes on the beauties of the order. Following were cashier M. B. Salin and Dr. A. G. Lovell, who spoke briefly of the purposes and aims of the order. Returning to the lodge room the District Deputy took charge of the meeting and proceeded to install the newly elected officers for the next term. They are as follows: Noble Grand, W. T. Davis; Vice Grand Dr J. F. Baugh; Secretary W. A.

Cox and W. L. Richards

Treasurer. Starting a year ter have a traffic of their fi ago with seventeen, the membership at the end of the first year was sixtyseven; a phenomenal growth."

The Independent Order of Odd Fellows (I.O.O.F) has several symbols: the scales of justice, the equilateral triangle, the hourglass which emphasized their duty to assist others quickly, the all-seeing eye, a hand holding a heart which symbolized charity, and a chain with three links that represents the organizations three core beliefs--friendship, love, and truth.


The chain with three links also directly connects to Rockcastle County. The area of Three Links where Rockcastle meets Jackson County was named for the Odd Fellows Lodge. As reported by Grant Martin in a 2015 Facebook post titled "Where in the World is Three Links" Martin states that the post office

was named around 1918 after the Odd Fellows Lodge that was located where a church stood in 2015 (not sure if the church is still standing). The post differs slightly in the representation of the three links. Martin stated, "Their official symbol was three links of a chain--in each link was a word which was to have been faith, hope, and love." The original building was believed to have been a two-story multipurpose building: a church, a school and the lodge all used the facilities there.

Jill Halcomb Smith, of the Rockcastle County Historical Society and Museum recently posted pictures of members of the Odd Fellows Lodge in Rockcastle County including her Grandfather, John Sherman Halcomb.

While the Masons were named because original members shared a common profession-masonry or related trades; the Odd Fellows' name is thought to have come from the "odd" works they did for society. The website, dustyoldthing.com gives a brief history of the organization. At the time of the organization's inception in England, the idea of welfare did not exist and the idea of helping those in need was something of a novel or odd concept. According to the website, "The goal of the order was not only to form a brotherhood in personal ways but to embrace their faith through acts of service to others."

There are still Odd Fellows Organizations in the United States and in Kentucky. Unfortunately, the Rockcastle County Odd Fellows dwindled and eventually died out, but I am certain that the County Rockcastle Lodge served through friendship, love, and truth, just as the three links symbolize.





Cheerleaders come home to Rockcastle as National Champions

Several years ago, a group of girls yelled with pride and enthusiasm during the football games at Rockcastle County High School. At least one of the girls took the experience very seriously. For Joanie Alexander Lake, being a RCHS cheerleader was one of her passions. She loved every minute of it.

Lake went from the RCHS cheerleading squad to the Lindsey Wilson College cheerleading team and her passion never abated. "Yes, it is a sport and it is very competitive. But more importantly, it is life lessons. It is learning how to be part of a team and how to grow as a human being and a citizen of your community."

Lake's passion continued to grow until she became Head Cheerleading Coach in Adair County and taught gymnastics at the same time. After one year of that experience, Lake came home and bethe Head came Cheerleading Coach at RCHS with the very capable assistance of Assistant Coach Vee Anderson. For the past seven years she has worked to develop and grow the team to be among the best. Last week her team, the RCHS Cheerleading squad, became National Champi-

"I love what I do but there is nothing better than doing it here at home," she said. "It is a dream come true to provide the opportunities to these girls that I never had. It is the goal of every cheerleader to be the very best and to see it happen for these girls is an amazing thing they will never forget"

Lake said the national win in Florida last week was icing on the cake. "I have done my job if the girls learn about life and grow as members of society and add to their community. But this win is a big deal too," she said.

The 26 girls (two are out with injuries) who competed for the championship were among 1,200 teams in 76 divisions, and faced a formidable foe. "Our top competition was a team from Colorado," Lake said. "They were actually two points ahead of us and I think were favored."

However, going into the final competition, those two points were negated and both teams started fresh from zero. "We ended up winning by 0.4." The team erupted with jubilation when the final score was announced, "We were National Champions," Lake said with obvious pride.

Did the RCHS squad think they were going to win? "We thought we had a chance but there was no doubt that competition was going to be tough. The Colorado team was excellent," said Lake.

The squad won the national championship in the Super Large Division II NT Game Day Division and won third place in the Medium Division II NT 2.5 Traditional Division.

Word spread through Rockcastle County quickly and, by the time the team made it back to London on their way home, four Kentucky State Troopers, led by Detective Ryan Loudermilk, were waiting to escort the RCHS Cheerleaders and their coaches home to Rockcastle County. When the team hit the county line, fire trucks from nearly every fire department in the county joined the parade line. By the time the line reached Main Street, fans and students were waiting along the roadside and at the high school for the arrival of the National Champion RCHS Cheerleaders. "We got the best reception we could imagine," said Lake. "We were treated so well and our girls deserved it."

Tuesday evening the squad was invited to the monthly School Board meeting. During the meeting the agenda was put on


hold and Superintendent Dr. Carrie Ballinger told the crowd there were some special guests waiting in the back of the building. The squad and coaches then entered the board room to a long standing ovation from a full board room. "I am incredibly proud of the hard work, determination and the grit of our RCHS Cheerleaders and their coaches," said Ballinger. "This squad has made not only their school, but our entire community proud. Congratulations on an extremely well deserved honor."

Chairman Angela Mink said she is aware of the difficulties involved with being on the squad. "You fought through the 6 a.m. practice sessions and incredible challenges to become the best of the best," she said. "We could not be more proud of each one of you."

School officials agreed that the squad will be the "talk of the town" for quite some time and will be remembered at the school for decades. Hazardous Fire Season is once again underway in Kentucky, including Rockcastle County.

Local fire departments have reported several grass, brush and forest fires recently and local officials ask that all residents obey the rules during fire hazard season.

According to Kentucky statutes, fire hazard season began on February 15 and lasts until April 30. According to the statute, even if a resident follows all burning restrictions, it

is unlawful to set fire to any materials, capable of spreading fire, within 150 feet of woodland or brush area, except between the hours of 6 a.m. and 6 p.m. or on snow covered ground.

Officials say all fires should be attended until completely extinguished.




