

Vandalism becoming expensive problem in city and county

Editor's note; This story was written with the assistance of Mount Vernon City Administrator Jim Bowman. **Rockcastle County** and the City of Mount Vernon have experienced a sharp increase in vandalism across the county since the COVID pandemic has ended and, if local officials have their way, vandalism will be greatly reduced soon. "It has gone on for years but it has gotten worse recently," said **Rockcastle County** Judge/Executive Howell Holbrook, Jr. "It is a tremendous amount of

time, effort and expense to replace steel road signs and repair or replace other damage done by vandals."

Thursday, July 27, 2023

According to Holbrook and several magistrates, road signs and other signage is stolen on a regular basis and other county property is damaged often by local vandals.

Mount Vernon City Administrator Jim Bowman says the problem of vandalism has become a more serious issue in the city limits as well. "We see spray painted walls, missing signage, damaged equipment, cut fences, profanity carved into picnic tables and dismantled playground equipment quite often. It is not just a nuisance. It is costly and dangerous."

Bowman said neighborhoods with higher rates of vandalism suffer from decreased property values and uneasy residents, higher insurance costs, a loss of recreational opportunities and the need for increased police patrol, as well as costly emergency repairs and city staff overtime pay.



In 2020 Andrew married Amy Uhlman, whom for DuPont Manual High School in Louisville. Amy is an elementary school principal in Jefferson county. They have a son, Luke James, a 2 year old toddler and one of five grandchildren, four of which are boys.

Since moving to Louisville Andrew has left behind more than 10 years as WKU mens basketball team chaplain and the Bowling Green Hotrods. In 1974 my husband, Eddie, was called to ministry while working in North Carolina and attending church there. He has always maintained that God called him to be a missionary. He has made short term mission trips to Haiti and Honduras. He has also promoted missions in every church we've served and introduced us to missionaries around the world. Some of the people who have gone on short term trips have returned to full time service. But it's through our son we believe God Is fulfilling that calling. We named our son Andrew after one of Jesus' disciples. Andrew was the brother of Simon Peter. Andrew was always bringing people to Jesus. 

The Importance of Perseverance



(Continued from front) tem. "There have been so many delays that I am not going to promise anything," he said. "But allegedly, we should get approval to move forward with the bid process soon."

Once the bid process is complete, the city will learn of the updated cost estimates and make decisions from there concerning funding, officials say.

"The city council is doing everything in its power to move this project forward and we are all very anxious to begin this water project," he said.

In other action, representatives of the American Legion informed the council that a Bradley Tank has been approved to be located in the new Rockcastle Veteran's Memorial Park. According to Bowman, Mount Vernon is the only city to receive a 27 ton Bradley Fighting Vehicle (tank) for memorial park display. The tank, named after General Omar Bradley, is known for its 600 horsepower propulsion and its 25 mm M242 Bushmaster Chain Gun as well as anti-tank missiles.

The council agreed to pour a required concrete slab at the park to display the donated tank. Bowman said the work of Kathy Bobo and State Representative Brandon Storm made the display possible through the Department of the Army.

Bowman also said officials have worked closely through Storm to have the National Guard transport the tank to Mount Vernon. "This will be a memorable and powerful addition to

+

the memorial park and we are blessed to be the only city who will have a Bradley Tank on display," said Bowman. "Kathy Bobo, Brandon Storm and the American Legion made this possible and deserve a big thank you from everyone," he added

On a motion from council member Lonetta Daugherty, the council voted to reinstate the 3.9% credit card fee on payments to the city using a card. The fee is apparently charged by the credit card companies but the city had eliminated the fee during COVID as an effort to assist Mount Vernon customers. However, now that COVID has officially passed, the council voted to reinstate the fee to customers rather than pay the fee without reimbursement. The fee will not apply to checks, cash or echecks.

The Mount Vernon Fire Department is attempting to acquire 500 emergency alert system kits to provide to students at MVES. Some funds have been raised through county donations, business donations and individual donations, according to officials. However, the department has not raised enough funds for the 500 kits planned. The council agreed to consider helping the department reach their 500-kit goal.

The council also heard departmental reports.

Having no further business, the meeting was adjourned.

The next regular monthly meeting is scheduled for Thursday, August 17 at 6 p.m. The public is invited to attend.

son ran into the room and the officer then secured the son and gathered the suspected meth.

In an interview, Mullins then gave the officer permission to search the room. During the search, the citation says King located 2.56 grams of meth along with numerous pipes and digital scales as well as marijuana and "spice," (a combination of various chemicals to simulate THC), in the apartment.

Mullins was arrested and transported to the Rockcastle County Detention Center where she was charged with trafficking in a controlled substance, possession of marijuana, possession of a controlled substance, possession of drug paraphernalia and public intoxication.

Bowman and Holbrook agree such destructive behavior tends to increase on weekends and school holidays.

All three police departments in the county, and members of the sheriff's office, have agreed that vandalism seems to be on the rise throughout the county at certain times of the year.

"Vandalism is a crime and can carry a hefty fine along with jail time and even prison time in some cases," according to Mount Vernon Police Chief Joe Rush. In fact, Kentucky Revised Statutes strictly forbid vandalism, including graffiti. Though minor vandalism is considered a misdemeanor and punishable by a fine and time in jail, major vandalism that causes serious damage to valuable property is considered a Class D felony in the statutes. According to some news reports, "valuable property" is property considered to be worth over \$1,000. But this estimate may also include the labor to repair the damage, according to

the KRS.

Bowman says the City of Mount Vernon has developed a strategy to combat vandalism that includes increased police patrols, surveillance cameras, improved lighting and encouraging neighborhood watch programs, among other plans.

Mount Vernon Mayor Tim Roberts agrees the city must combat the issue of vandalism. "There isn't a simple fix to prevent vandalism," he said. "but collectively city government, with the assistance of concerned citizens and businesses. can build awareness. We should all be working together to make our parks safer and inviting places to enjoy."

Police say they plan to increase patrols, with random routes at susceptible sites for vandalism and "crack down" on vandalism in the county.


contractor. Miller will continue to handle all other treasurer duties along with some other duties she previously had as County Court Clerk.

Farm Service Agency Now Accepting Nominations for Farmers and Ranchers to

Serve on Local County USDA is now accepting

nominations for county committee members for elections that will occur later this year. Additionally, USDA's Farm Service Agency (FSA) is unveiling a new GIS tool to make it easier for producers to participate in the nomination and election processes for county committee members, who make important decisions on how federal farm programs are administered locally. All nomination forms for the 2023 election must be postmarked or received in the local FSA office by Aug. 1, 2023.

Elections will occur in certain Local Administrative Areas (LAA) for members. LAAs are elective areas for FSA committees in a single county or multicounty jurisdiction and they may include LAAs that are focused on an urban or suburban area. Customers can locate their LAA through a new GIS locator tool available at fsa.usda.gov/elections. Agricultural producers may be nominated for candidacy for the county committee if

they: ·Participate or cooperate in a USDA program; and •Reside in the LAA that is up for election this year. A cooperating producer is someone who has provided information about their farming or ranching operation to FSA, even if they have not applied or received program benefits. Individuals may nominate themselves or others and

qualifying organizations may also nominate candidates. USDA encourages minority producers, women and beginning farmers or ranchers to nominate, vote and hold office.

Nationwide, more than 7,700 dedicated members of the agricultural community serve on FSA county committees. The committees are made up of three to 11 members who serve three-year terms. Committee members are vital to how FSA carries out disaster programs, as well as conservation, commodity and price support programs, county office employment and other agricultural issues.

More Information

Producers should contact their local FSA office today to register and find out how to get involved in their county's election, including if their LAA is up for election this year. To be considered, a producer

must be registered and sign an FSA-669A/nomination form.

Nomination forms and other information about FSA county committee elections are available at/ fsa.usda.gov/elections. Election ballots will be mailed to eligible voters beginning Nov. 6, 2023.





-Yards to Paradise

By Max Phelps Gothic Landscaping: A Popular Theme Garden

The Goth Garden is the modern term for a type of landscaped look called Gothic-a common theme of gardens in the Victorian Era. For some, writer Mary Shelley's "Frankenstein" might come to mind. Trendy things come and go, but this theme is making a comeback, though it never actually disappeared.

Not your formal garden, the Goth is either whimsical and airy, containing some mystery or serene, some arcadian and placidity, and likely some gloomy, decaying, dark or spooky elements. The formal garden might feature a prominent statue and carefully manicured shrubbery-the Goth garden may have half hidden stones and statues and walls and gates obscured with ivy or lots of natural growing plants.

Gothic Landscape designs typically attract attention. On way to witness this is on a garden tour or an organized tour of an ancient mansion, and notice where the crowds migrate to.

Victorian architecture, some old furniture or stones or statues, some urns or old pots, perhaps a bat or scarecrow, and of course some dark or what we call black plants: these are all part of the Goth theme.

The Gothic brings to memory trials, wars, plagues, and gloom. Historical or antique are additional words one might employ to describe the tone of the Goth garden. Old furnishings, dead trees, bones or tombstones, and definitely a few dark flowers or plants are utilized in creating the Goth landscape.

Leaving those grimmer elements, let's concentrate on dark colored plants. A previous column covered dark plants, and it may be about time to revisit that article to refresh our memories, for black plants are still in high demand in today's gardening and landscaping. Here is a list of some of the deep red, deep blue, purple, burgundy and almost-black plants you may consider if you want to incorporate a bit of this trendy theme into your landscape.

Black perennial and woody plants include: black tulips, iris, hellebores, hollyhocks, coral bells, purple oxalis, canna, calla lilies, purple clematis, black Colocasia or elephant ear, black mondo grass, black roses, black columbine, black centered cone flowers or Mexican hat, black bat flower, black cohosh (cimicifuga), black Pennisetum, burgundy loropetalum, and many others. Black annuals include

black coleus, black pansies, black petunias, dark sage, black sweet potato, black corn (and black cane and broom corn), purple cabbage and kale, purple/black tomatoes, purple peppers, red lettuce, red okra, burgundy castor beans, purple pole beans, etc.

Dark shrubs and trees might include loropetalum, dark leaved crepe myrtles, cotinus or smoke bush, red obelisk (black) beech tree, black elderberry, and some of the plums or apples with red or purple foliage and fruits.

Deep green, as in English ivy, is considered a Gothic element also. Yew trees, witch hazels, heathers and hollies may fit easily into the Goth design.

NOTIFICATION OF FERPA RIGHTS and CHILD FIND

for CHILDREN WITH DISABILITIES IN NEED of SPECIAL EDUCATION or 504 SERVICES

Notification of FERPA Rights

The Family Education Rights and Privacy Act (FERPA) affords parents and "eligible students" (students over 18 years of age or students who are attending a postsecondary institution) certain rights with respect to the student's education records. They are:

1) The right to inspect and review the student's education records within forty-five (45) days of the day the District receives a request for access.

Parents or eligible students should submit to the school Principal/designee a written request that identifies the record(s) they wish to inspect. The Principal will make arrangements for access and notify the parent or eligible student of the time and place where the record(s) may be inspected.

Children eligible for 504 services include those children who have a current physical or mental impairment that currently substantially limits some major life activity, which causes the student's ability to access the school environment or school activities to be substantially limited.

The Rockcastle County School District has an ongoing "Child Find" system, which is designed to locate, identify and evaluate any child residing in a home, facility, or residence within its geographical boundaries, age three (3) to twenty-one (21) years, who may have a disability and be in need of Special Education or 504 services. This includes children who are not in school; those who are in public, private, or home school; those who are highly mobile such as children who are migrant or homeless; and those who are advancing from grade to grade, who may need but are not receiving Special Education or 504 services.

The Rockcastle County School District will make sure any child enrolled in its district who qualifies for Special Education or 504 services, regardless of how severe the disability, is provided appropriate Special Education or o cost to the r arents of the child

2) The right to request the amendment of the student's education records that the parent or eligible student believes are inaccurate, misleading, or in violation of the student's privacy or other rights.

Parents or eligible students may ask the District to amend a record that they believe is inaccurate, misleading, or in violation of privacy or other rights. They should write the school Principal, clearly identify the part of the record they want changed, and specify why it is inaccurate, misleading, or in violation of their privacy or other rights.

If the District decides not to amend the record as requested by the parent or eligible student, the District will notify the parent or eligible student of the decision and advise him her of the right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when notified of the right to a hearing.

3) The right to consent to disclosures of personally identifiable information contained in the student's education records, except to the extent that FERPA authorizes disclosure without consent

One exception that permits disclosure without consent is disclosure to school officials with legitimate educational interests. A "school official" is a person employed by the District as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel); a person serving on the school Board; a person or company with whom the District has contracted to perform a special task (such as an attorney, auditor, medical consultant, or therapist); or a parent or student serving on an official committee, such as a disciplinary or grievance committee, or assisting another school official in performing his/her tasks.

A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his/her professional responsibility to the district.

Upon request, the District shall disclose education records without consent to officials of another school district in which a student seeks or intends to enroll or is already enrolled or to other entities authorized by

Disclosure of information is provided to those whose knowledge of such information is necessary to respond to an actual, impending, or imminent articulable and significant health/safety threat.

4) The right to prohibit the disclosure of personally identifiable information concerning the student to recruiting representatives of the U.S. Armed Forces and its service academies, the Kentucky Air National Guard, and the Kentucky Army National Guard.

Unless the parent or eligible student requests in writing that the District not release information, the student's name, address, and telephone number (if listed) shall be released to Armed Forces recruiters upon their request.

5) The right to file a complaint with the U.S. Department of Education concerning alleged failures by the District to comply with the requirements of FERPA. The name and address of the Office that administers FERPA is:

DIRECTORY INFORMATION

The Superintendent or the Superintendent's designee is authorized to release Board approved directory information. "Directory Information" is information contained in an educational record which would not generally be considered harmful or an invasion of privacy if disclosed. This information may be released without consent. "Directory Information" includes the student's name, address, telephone listing, date and place of birth, major field of study, participation in officially recognized activities and sports, weight and height of members of athletic teams, dates of attendance, degrees and awards received, and the most recent previous educational agency or institution attended. The parent, guardian, or eligible student currently enrolled may request that all or part of the "Directory Information" be withheld.

Rockcastle County School District's process for any eligible student, parent, or guardian who does not wish to have directory information released shall make a written request to the Principal within thirty (30) calendar days after the Annual FERPA Notice has been distributed. The written request must specifically state what information may not be classified as "Directory Information".

CHILD FIND

The Rockcastle County School District will keep educational records in a secure location in each school and Board office.

The Rockcastle County School District obtains written consent from a parent or eligible student (age 18 or who is attending a postsecondary institution), before disclosing personally identifiable information to an entity or individual not authorized to receive it under FERPA.

For students who have been determined eligible for Special Education, educational records will be destroyed at the request of the parents when they are no longer needed to provide educational programs or services. The Rockcastle County School District may destroy the educational records of a child without parent request three years after they are no longer needed to provide educational programs or services. Parents are advised that data contained in the records may later be needed for Social Security benefits or other purposes. The Rockcastle County School District may retain, for an indefinite period of time, a record of the student's name, address, telephone number, grades, attendance records, classes attended, grade level completed, and year completed.

Children eligible for Special Education include those children with disabilities who have autism, deaf-blindness, developmental delay, emotional-behavior disability, hearing impairment, mental disability, multiple disabilities, orthopedic impairment, other health impairment, specific learning disability, speech or language impairment,

Parents, relatives, public and private agency employees, and concerned citizens are urged to help the Rockcastle County School District find any child who may have a disability and need Special Education or 504 services.

Letters and phone calls are some of the ways the Rockcastle County School District collects the information needed. The information the school District collects will be used to contact the parents of the child and find out if the child needs to be evaluated or referred for Special Education or 504 services.

If you know of a child who attends a private or home school within the boundaries of the Rockcastle County School District, who may have a disability, and may need but is not receiving Special Education or 504 services, please contact the appropriate district at the numbers listed below or send the information to the appropriate Board office: A.C. 



FRANKFORT, Ky. (July 24, 2023) A longawaited interchange and road widening project that will bring greater safety and less traffic congestion in tourism-rich Pulaski County was ceremonially opened today by Kentucky Transportation Secretary Jim Gray, U.S. Rep. Harold Hal Rogers and area officials.

Our roads arent red or blue. Theyre for the people of Kentucky and the millions of visitors that come to our great state, said Secretary Gray, representing Gov. Andy Beshear. The Beshear administration knows that well-built and well-maintained transportation infrastructure is a key that unlocks economic development opportunities and adds to the quality of life in Kentucky.

The event marked the completion of two new interchanges at the juncture of KY 80 and KY 461, two routes that see stready streams of traffic, including vacationers going to and from Lake Cumberland. Also in the project is the widening to four lanes of more than 3 miles of KY 461.

This monumental transportation project is a stamp of economic success and growth for southern and eastern Kentucky, and were far from finished, said Congressman Rogers, who is Dean of the House. Southern Kentucky needs a fourlane highway that runs east to west, attracting new business and tourism dollars through the most beautiful parts of our state. We are making significant progress towards that goal as we continue strategic planning across

the federal, state and local levels.

The KY80/461 project, a \$51 million investment, was funded in part with a \$25 million federal grant from the program known as BUILD -- Better Utilizing Investments to Leverage Development. The remaining \$26 million came from statefederal apportionment and a local match. While most of the funds went to the two interchanges and lane widening, funds also will be used to purchase new intelligent transportation systems including improved lighting, electronic messaging boards, camera monitoring systems, and upgraded signage.

Valley Oak Complex is an industrial park on KY 461 that has over 3,000 employees. More than a thousand tractor-trailers travel to and from the site weekly. That number will soon grow with the planned construction of a multi-million dollar apartment complex and a childcare center.

Rockcastle County Schools will offer virtual school options (My Rock Online) for students grades 6-12 for the 2023-24 school year. Anyone interested in participating in virtual classes must complete an application, meet a set of qualifications set by the district for the program, attend an orientation session and sign a contract in order to be accepted for virtual learning, according to the district website.

Officials wish to inform all students and parents that applying for virtual classes does not mean the student will be accepted into the program.

Applications must be received by August 4, 2023 and each application will be reviewed by the district. Those students accepted into the virtual school program will be notified by the school after the August 4 deadline to discuss application status.
