City of Livingston water rates to increase, nuisance ordinance to be strongly enforced

With the absence of Mayor Larry Davidson, Mayor Pro Tem Sandi Singleton / led // the Livingston City Commission's regular monthly meeting last Thursday night at City Hall.

Commissioners discussed several issues, after water and sewer reports and the police report. Singleton opened the floor for public comments, but no guests spoke up.

The Mayor Pro Tem announced that the city is taking bids for a side by side vehicle for sale by the city and the Book Box announced last month is expected to arrive next week.

Singleton publicly thanked Nathan Carter, Jeff Carpenter and the Rockcastle County Detention Center's Work Release Program for their help with city beautificamany more such projects are planned.

As part of the beautification projects planned, the commission announce the city is about to become much more strict concerning the nuisance ordinance and enforcement of the regulations included in the ordinance.

Mahaffey read an addendum to the existing ordition projects and said nance which greatly increases fines for those who do not comply with the ordinance. "We have announced the need to clean up run down areas many times, we have provided free dumpsters and have bent over backwards being fair and open with everyone," he said. "But the time has come to be serious about cleaning up the dilapidated structures and trash areas around town. We are going to have to move on this in order to create a better, cleaner more attractive

city." According Mahaffey, some of the fines in the ordinance will increase 400% for first time offenses. According to the addendum, those who are a cited for violating the ordinance will have a fine schedule to follow for each offense.

Fiscal Court receives excess fees and deals with several issues

Member of the Rockcastle County Fiscal Court held their regular monthly meeting last

week. After hearing the Livingston Trail Town reports for January and February, the court next agreed to provide \$1,172 to the Rockcastle County Development Board. The court invited Development Board Chairman Lynn Tatum to the court meeting months ago to explain how the monthly support is used and to ask for assistance on some projects in Brodhead.

The court then heard the monthly report from the Rockcastle County Industrial Development Authority (RCIDA). The two development boards are separate entities with similar goals, according Judge/Executive Howell Holbrook, Jr.

The court also received a check from the Rockcastle County Sheriff's Department for excess fees from mineral tax settlements in the amount of \$5,698. The department had already returned excess fees but found some that were re-

Mount Vernon Police Chief Joe Rush was transported by ambulance to Rockcastle Regional Hospital Monday after his police cruiser was purposely rammed at a high rate of speed by Scott Edward Martin, 40, of Brodhead, according to a uniform citation.

Rush, who says he has several bruises and was still very sore on Tuesday morning, and Mount Vernon Officer Dylan Hensley, had responded to a domestic dispute on Chickadee Lane, near Brodhead just before the incident occurred.

According to Rush, officers informed Martin that he was not welcome by the owner of a residence there and had to leave the premises.

However, when police officers and Martin left the home and reached US-150, Martin rammed his 2007 Malibu Chevrolet into the rear of Rush's police cruiser, the citation said.

(Contined from front) maintenance crew that a motor on the heating and cooling system had over heated which sent a small amount of smoke spiraling through the air vents, making it appear to be a bigger issue.

The maintenance crew shut down the motor and stopped the smoke.

Holbrook said a simple fuse had blown causing the blower motor to receive inadequate electrical power, which caused the over heating. "We replaced the fuses and the problem was resolved," Holbrook said.

Holbrook has been advocating for a new HVAC system throughout the courthouse since the existing system was installed nearly 60 years ago. However, since the cost will use most of the COVID Relief Fund, some magistrates have not expressed the same interest in the idea.

Loudermilk had been called to the scene to assist MVPD personnel and arrived shortly after the ramming incident. He then located Martin, who had traveled further along US-150 to Dug Hill Road, where Loudermilk caught up to him.

The citation says the detective attempted to perform sobriety tests on the suspect but Martin "continued doing the tests improperly."

Martin was then transported to Rockcastle Regional Hospital for blood tests where Martin consented to the tests.

Officer Hensley ob-

served the crash and provided a statement to Loudermilk which identified Martin as the driver of the car that struck Chief Rush.

The citation says Martin admitted to ramming Rush's cruiser intentionally after he was read his Miranda Rights. The report says damage to the cruiser is in excess of \$1,000 and the intentional act caused injury to Chief Rush.

Martin was transported to the Rockcastle County Detention Center where he was charged with Assault of a police officer in the second degree, criminal mischief, failure to produce an insurance card and operating a motor vehicle under the influence of a substance.

Rush was back home Monday evening and said he is thankful to his fellow officers and to God for protecting him from more serious injury.

The fine will increase for
the second offense and
increase again for all offenses thereafter.

However, the addendum says if the citation is appealed, and the enforcement board must hold a hearing, fines for those same offenses will increase more. The fine for violating the structure code, first offense will now be \$100. However, if the enforcement board holds a hearing after an appeal has failed, that same offense will be \$500.

However, two offenses, such as garbage offenses and weed offenses, decrease after a board hearing, according to the fine structure.

Commissioner Greg Carpenter expressed his concern that handicap or elderly residents should be excluded under the proper conditions. The commission assured Carpenter that the ordinance provides exceptions under hardship conditions.

The addendum also clarifies the city's right to place a lien on property that does not meet ordinance requirements.

This was the first reading of the addendum which passed unanimously. The second, and final, reading is expected at the next regular meeting in April.

One of the audience members spoke up asking if a warning process is involved in the ordinance. "We have been warning people for about a year," said MaHaffey. "We have to move forward now."

Singleton also said the city has reached out to several potential city attorneys to find representation should the need arise. Singleton said two have responded and the city will look into starting the interview process.

In other action, Singleton told the crowd that there will be a change in water and sewer rates soon. "I know this is the bad news but we don't have any choice," she said. "I pay a water bill too and I don't want it to rise any more than it absolutely has to."

However, according to City Clerk Samantha Smoker, the city now charges only about 20 cents more per 1,000 gallons than the water costs the city. "We aren't making enough profit to keep things operating properly," said Singleton.

Smoker said the rate has not risen since 2006. "We have one of the lowest rates in the state but we just can't keep this up," said Singleton. "We simply have to raise the rates and split it between the water and the sewer rate. But we will make it as small an increase as possible and still be able to operate the water and sewer system properly."

The commission also appointed former mayor Jason Medley as the Livingston Homecoming Director. "We have talked with him and we believe he will do the best job and keep our traditions in place," said Singleton.

The commission then entered closed session to discuss personnel. Once the meeting was re opened, no action was taken and the meeting was adjourned. The next regular monthly meeting is scheduled for Thursday, April 11 at 4 p.m. at City Hall. The public is invited to attend.

(Contined from front) County Attorney Jeremy Rowe said he will apply

for any such grant.

The court also voted to provide \$7,500 to Hospice Care since the Richmond-based facility renders care to several Rockcastle County residents. Last year's annual donation was also \$7,500.

The court had also applied for a grant from the Department of Local Government, involving a Land and Water Grant. Holbrook read a refusal letter to the court and said the court would reapply for future grants.

Holbrook also pro-

vided the court with a letter from the Daniel Boone Back Country Byway Development Project, which includes road and byways in several counties as part of the Daniel Boone Back Country Byways. The letter informed the court of many roads in Rockcastle County that are about to be included in the Byways project.

However, Holbrook said some of the many roads involved are dead end roads and he intends to inform the project leaders of that fact soon. "We don't want people touring the Daniel Boone Byway to end up at a dead end and opening gates and getting on private land," he said.

The court heard the Animal Shelter report which showed 23 dogs and 1 cat housed at the end of February.

In other action, the court heard the Livingston Gym report which showed a total of \$800 in revenues for the month of February. Since heating costs are sometimes four times the revenues, the court also discussed a potential new internet-based thermostat system that would allow the court to keep better control over the heating

system in the gym. "It is easy to forget and leave the system on or have guests turn it up without our knowledge," said Holbrook. "This way we could control when the heat is on and off." More discussion is expected concerning the issue.

The court approved the county's March financial statement and approved the payment of four months of accumulated claims which totaled slightly over \$221,164 with \$69,918 of that coming from the General Fund alone.

Rockcastle County Treasurer Vickie Miller then requested a transfer of \$115,000 from the Occupational Tax Fund into the General Fund.

The financial statement showed that \$234,609 was disbursed from the General Fund in February but only \$70,665 remained in the account to begin March. The request was approved unanimously.

Having no further business the meeting was adjourned. The next regular meeting is scheduled for Tuesday, April 9 at 4 p.m. in the third floor conference room of the courthouse. The public is invited and encouraged to attend.

However, this attack was fake as a test to discover how teachers and staff should be trained to avoid such potential cyber attacks.

Reynolds said throughout the entire school system, only 35 of those who received the email actually clicked on the fake link. "Of course this cyber attack didn't do any damage when they clicked on it," Reynolds said. "We simply needed to know how well our teachers were trained in avoiding such cyber attacks."

Reynold said his department received 130 calls from teachers and staff within two hours after the email trap was sent, informing him that a risky email had come through. According to Reynolds, of the 35 who clicked on the test, over 1/3 of them had been with the school system less than two years. "Obviously we do a pretty good job in training our people to watch for such attacks. Mostly the newer ones clicked on it. The rest knew what to look for."

Ballinger, too, was

proud of the outcome. "The fishing email was very convincing. It was a great test," she said. "I knew it was coming and I still almost clicked on

Reynold said his department plans to begin training on potential cyber attacks sooner with new hires. But, another such fishing attack is planned in the future. "We have to see if what we do to prevent cyber attacks is working," said Reynolds.

Board Chairman Angela Stallsworth-Mink asked about attendance performance this year. Director of Student Services Marcus Reppert said attendance is improving. "We are better off than last year," he said. "We need to keep getting better each year."





NATURALISTIC LANDSCAPING: The Woodland Garden

Woodlands are typically associated with a rustic or unique home, but this naturalistic option for landscaping can be used with most homes if planning and details are done with thought and care. The object is to create something a little wild, something natural—yet tamed by using some modern plants to go among native ones. Keep some trees if you already have a lot that has trees; plant a few to get this started if that's what needs to happen to begin the creation of a forested garden in your yard. And plenty of mulch, some winding pathways, and being sure to eliminate things like poison ivy can result in a tranquil woodland just outside your house.

This landscape needs some trees, not all the same size or species. Then some small trees. Then some shrubs. Finally native flowers, some grasses, and a few shade lovers that happen to be your favorites or desired for some sentimental or whimsical reason. If some big canopy trees already exist, you may have realized lawn grass doesn't grow well under trees. Adding some shrubs and perennials and mulching takes care of trying to raise grass and cuts the hours every week mowing.

It's pretty easy if you. already have some forested spots in the yard to begin.

But, what if yours is a newer house and has maybe a tree and a half foundation plants—or nothing at all? Or perhaps you're just

tired of all the yard maintenance. We'll take a look into how to create a woodland garden where there is no lawn,


Let's assume you'll buy and plant at least two or three larger trees, maybe six to twelve feet tall. If the soil is too heavy, adding some good soil and raising the surface a few inches may help a lot. Planting these in some informal arrangement in a portion of your property that you'd like to begin this woodsy spot will get you on your way.

Shade is created in these types of landscaping. If you're starting from scratch, planting a little each season and slowly growing the natural area is probably best. Trying to convert a whole yard from scratch could be very expensive and still you'd not get the mature forest look. Some of the shade loving plants could probably be safely installed if the slope the the yard is to the North even if there's but little shade early on in this planting and installation process.

So, let's start by a quick study of trees. Trees that have smaller leaves let more light through. Trees that have long deep taproots don't hinder smaller trees and shrubs nearly so much, so choose some of those. Red or Scarlet oak, some of the pines, gum trees, birches, honeylocust, ginkgo come to mind.

Once your bigger and taller trees begin to produce shade and darken the light hitting the ground, think of some understory trees. Serviceberry, snakebark maple or some of the Japanese maples, maybe redbud or fringetree

You may need to put it off for three or more years, but adding viburnums, azaleas, hollies, Carolina allspice, symphoricarpos, hydrangeas, and some berry producing plants as edibles for both people and animals helps flush out the look of a forest.

The final plantings can be done over the years. These may be garden plants such as hosta, daylilies, toad lilies, bee balm, columbine, and so many other diverse shade-loving blooming plants.

At some point paths should be installed. These can be simple, even moss or leaf covered, or a different shade of mulch from that around and under the trees and other plantings in your freshly created forest.

Making paths curve around a group of plants that you cannot see past makes people curious to see things beyond the bend, so create some mystery as you lay out your paths through your forested garden.

Thought out and carefully executed, this type of naturalistic landscaping only gets prettier and more elegant as the years go by. The cool shade may convince you to put seating, a gazebo or other amenities out in this naturalized area.


Yes, all added up it is a chore. But so is cutting the grass 30 or 40 times every year. Just add some improved soil if needed, get out the hose if it's a dry spell, mulch recently planted things, and be patient before adding the things that must have shade to thrive.

So, are you ready to get started for the long steady planting of a forest, or are you going to go all in and get rid of the grass and create a natural ized yard at once? It might be the talk of the neighborhood, but some other folks may desire to do the same if your project turns out to be a beautiful paradise.



\$1.7 million needed to operate jail for one year

One of the largest annual expenses for the Rockcastle County Fiscal Court, is the support of the local detention center. However, according to Judge/Executive Howell Holbrook, Jr. and Jailer Nathan Carter, such support is required by law and state regulations and strict requirements mean that local officials have very little input as to how much that expense may be.

"There is a lot that the county has to provide to operate the detention center and the county tax payers have the burden of that expense, but none of the authority to change any of it," said Holbrook.

Carter has started more than one internal program in an attempt to raise funds for the operation of the local jail to help ease that burden upon taxpayers, but even those activities and procedures are overseen and regulated by the state.

Typically, officials agree that the local jail costs the fiscal court budget nearly \$1 million each year, above and beyond the funds paid to the jail by the state. "Without the jail to support, the county would have about a million dollars in the budget each year to use for a lot of things that could really benefit the county," said Holbrook.

As it stand currently, the City of Mount Vernon, the City of Brodhead and the City of Livingston provide no support specifically for jail expenses, according to county officials. Each of the three major cities in the county have a police force and house those arrested in the local facility, but are not legally responsible for any of the expense involved in the operation of the detention center.

"By law, none of the cities have to provide any funds for the jail. The expense is solely

on the fiscal court," said Holbrook. "It is a shame that the fiscal court has to foot the bill but has no say in what is done or how it is done.' Some fear that if cities in Kentucky were


forced to pay the jail for each person arrested inside city limits, it may become tempting for city officials to arrest fewer criminals during a budget shortfall.

Currently, the state reimburses the detention center with about \$34 per day for each state inmate but there is no reimbursement for local arrests.

Last week. Carter provided the court with his proposed 2024-25 budget. The budget is in its early stages and will be used by the fiscal court to help prepare the county budget. "This just lets us know what to expect with the jail so that we can plan the fiscal budget," said Holbrook.

According to the proposed jail budget, total revenues and expenditures for fiscal year 24-25 will be \$1,760,250. Of that budget, \$766,500 will be actual jail revenue. With the \$55,000 in carry-over from the previous year in the jail budget, the fiscal court will need to transfer \$938,750 into the jail account to satisfy the needed \$1.7 million total budget.

According to the proposed jail budget, the 51./ million is divided into six funds. Personnel will cost \$790,000, operating expense, \$445,200, equipment, \$4,000, juvenile detention will cost \$2,000, debt service, \$89,000 and administration, \$430,000.

According to Singleton, professionals will talk with anyone who comes to the event about many possible programs that would help in very specific or in broad conditions. "If you just come, they will tell you all you need to know and can give you advice on so many programs that people qualify for and don't even know it," said Singleton.



Clean used motor oil may also be dropped off at the Rockcastle County Road Department Garage.



Legislative Update

State Senator Week 11 of the 2024 Legislative Session

The Kentucky General Assembly has wrapped up the 11th legislative week of the 2024 Regular Session.

I am pleased to say my Senate Bill 127 to grow and strengthen the Education and training pipeline of aviation professionals within Kentucky was approved by the House Appropriations and Revenue Committee. on Tuesday. My bill sets up the framework for the 650-plus businesses that employ nearly 100,000 Kentuckians, which directly feeds into \$20 billion of exports in the aviation industry. This bill is vitally critical, because the current metrics and analysis estimated nearly 600,000 pilots and 650,000 aviation mechanics will be needed over the next ten years. SB 127 will play a significant role in filling this workplace pipeline. In addition to pilots and mechanics, other aerospace jobs will include sheet metal fabricators, avionics mechanics, powerplant and airframe mechanics, fixed base operation management, and flight engineers. I appreciate the support of the aerospace and aviation caucus legislators, the industry, and educational institutions such as Morehead, EKU. Madisonville Community College, Somerset Community College, and others that will set up the framework and establish two pots of money. It will create the Kentucky Aerospace, Aviation, and Defense Workforce Investment Fund. Under the bill, at least 65 percent of the funds, which could be up to \$8.25 million, will be used to encourage aerospace, aviation, and defense partners to team up with educational programs to pledge funds. Matched dollar for dollar, these state funds would establish scholarships for the aerospace and aviation industry. The other 35 percent would be available to reincentivize universities and training programs to invest in building a faculty, providing equipment, and other trainingrelated assets. I am optimistic about SB 127's ability to pass out of the state House, and I will update you next week.

After weeks of deliberation, the Senate approved its version of the two-year state budget this

week. The main focus of the two-year spending plan (House Bill 6) is to ensure we provide critical government services and further reduce the state income tax so we can leave more money in your pockets. Another budget bill, House Bill 1, uses funds from Kentucky's budget reserve trust fund toward transformational one-time investments. One of those includes an emphasis on road, bridge and highway repairs. As the Senate Transportation vice-chair, I thank Senate leadership and our Senate Budget Chair, Chris McDaniel, for their support in facilitating the transfer of approximately \$890 million from the budget reserve trust fund to the state road plan. These funds are crucial for addressing infrastructure needs in rapidly growing counties and supporting key industries. This injection of one-time funds will prioritize projects to improve our statewide infrastructure, particularly addressing the long-standing issue of overdue road resurfacing, which is nearly two decades overdue for repair. I am optimistic about this investment's positive im-

pact on our communities. Key Senate bills passed this week include:

SB 3 reorganizes administrative duties of the Kentucky Horse Racing Commission and Department of Fish and Wildlife, transferring oversight to the Department of Agriculture.

SB 128 broadens youth employment opportunities by enabling nonprofit organizations to establish tailored work programs for minors aged twelve or thirteen.

SJR 170 directs the Council on

Postsecondary Education to study expanding postbaccalaureate programs at Kentucky's comprehensive universities.

SB 232 introduces changes to decision-making processes regarding public school buildings in Kentucky,

SB 317 establishes property rights for individuals in their name, voice, or likeness.

SB 319 aims to strengthen support for victims of crime.

SB 349 establishes the Energy Planning and Inventory Commission to evaluate Kentucky's energy needs and oversee power plant retirements.

SB 368 mandates informing the Kentucky Department for Housing, Buildings, and Construction about a property's



The reality is that our world may look rosy, (and who can be depressed when shrubs and trees and daffodils are blooming?), there is a foreboding in the air. And a trend that continues is more security and taking precautions. Making the home safer. Making the food in the freezer or cupboard safer. Stocking up for that next "100-year" event that seems to happen every 3 to 5 years anymore.

Only the surface has been explored as we try and peek into a new season and visualize the possibilities. May your home and garden edge closer to paradise this year. -0-







The promise of spring is in the air, the days are getting longer, the sun is shining a little brighter and the buzzer sounds the start of yet another basketball game...clearly, it is March in Kentucky and everyone's eyes are on the court and everyone has their favorite player. The stars of the game may be playing their hearts out, but, the truth is behind every star player is a coach with a clipboard demanding they play harder! Here Rockcastle County, we are right there with the rest of the country watching the seemingly neverending games of March. I am certain one can find a couch-coach in almost every household shouting "Foul" at the screen. Love them or hate them, the coach is oftentimes the unsung hero of the game. When those talented stars are up before the crack of dawn at practice or in the gym well after dark, the coach is right there with them, pushing them to be better than their best. Here in Rockcastle, before there was a Chrysti Noble or an Andrew Cash other coaches were pushing and pressing those Rockcastle players to win. SALISBURY STEAK

BAKE I package condensed French onion soup mix 1 and 1/2 pound ground

beef 1/2 cup dried breadcrumbs 1 egg

salt and pepper to taste 1 bag (1-pound) frozen hash browns, thawed 1 onion, roughly chopped 1/4 cup ketchup

1/4 cup water tablespoon Worcestershire sauce 1/2 teaspoon yellow mus-

1 tablespoon all-purpose

1 tablespoon butter, softened

2 tablespoons heavy cream

Preheat oven to 350°. Lightly spray a 9 x 13 baking dish with cooking spray. Setaside. In a bowl, mix half of the soup mix with the beef, breadcrumbs, egg, and salt. Shape into 6 oval patties. Brown patties on both sides in a skillet over medium-high heat. Set patties aside. Pour off and discard any excess fat. In the same pan, mix the remaining soup mixwith the ketchup, mustard, water, and Worcestershire sauce. Add the butter and whisk until melted and smooth. Reduce the heat to low and whisk in the heavy cream. Spread the hash browns over the bottom of the baking dish. Top with the chopped onion. Arrange the browned meat patties over the potatoes.

Pour sauce over the pat-

ties. Bake for 30 to 40 minutes until the potatoes are golden and the sauce is bubbly. Serve immediately.

HAMBURGER STEAKS WITH ONION GRAVY 1 package (1 pound) ground beef 1 egg

1/3 cup breadcrumbs 1/2 teaspoon black pep-

1 teaspoon salt 1/2 teaspoon onion pow-

1 clove garlic minced 1 teaspoon Worcestershire sauce

1 teaspoon oil 1 and 1/2 cup thinly sliced onion

2 tablespoons all-purpose

flour 1 cup beef broth

1/2 teaspoon salt In a large bowl, mix the ground beef, egg, breadcrumbs, pepper, salt, onion powder, garlic, and Worcestershire sauce. Form into thick patties. Heat the oil in a large skillet over medium heat. Fry the patties and onion in the oil until patties are nicely browned. Remove the beef patties to a plate and keep warm. Sprinkle flour over the onions and drippings in the skillet. Stir in flour with a fork, scraping bits of beef off the bottom as you stir. Gradually mix in the beef broth. Season

with seasoned salt. Simmer and stir over medium-low heat for about 5 minutes, until the gravy thickens. Turn heat to low, return patties to the gravy, cover, and simmer for another 15 minutes.

issue of the Mt. Vernon Signal featured an article titled "Friday Night Is "End of an Era" For Basketball at Ml. Vernon School" The article details the history of basketball at Mt. Vernon High School and the career of Coach Jack Laswell. Laswell was one of the longest-serving coaches at the school, according to the Signal. "This Is one of the longest careers of any coach In Kentucky High School Basketball at one school" the article stated.

From the article: "Coach Jack Laswell came in at the start of the 1947 season and It was during the 50*s that Ml. Vernon had outstanding teams, especially during the Earl Noe • Ken Cornelius years. During this period, the Devils went to the regional tournament eight straight years. The team that was the pride and Joy of Mt. Vernon and Rockcastle County was the only team to ever represent Mt. Vernon In the state tournament, the team of 1953 was composed of: allstate center Earl Noe, Charles Baker, Charles Shepherd, Manuel Shepherd, Earl Plttman and a freshman starter Kenneth Cornelius. Cornelius was selected four straight years as an all-regional player and In 1956 as an all-state player."

Laswell was a coach to emulate, he respected his players, in the 1972 Signal article he stated, "During my 25 years at Mt Vernon, I have had the privilege of coaching some fine boys. There have been a lot more victories than defeats — but to me all boys who played the sport and worked hard to develop their basketball skills were winners." Laswell took the 1953 team to the State Championship and they held on for the Sweet Sixteen. Members of Laswell's 1953 Red Devils team included Jimmy Cummins,

Earl Pittman, Charles Shepherd, Bill Chaney, Ken Cornelius, Jack Laswell, Bobby Fields. Manuel Shepherd, Earl Noe, Bobby Spears and Charles Baker, As published in "Before Consolidation: The Golden Age of Rockcastle County Basketball" edited by historian David Owens, Charles "Tuck" Baker was known as "Playmaker" by the team. Baker would go on to be Laswell's assistant coach in 1962.

According to David

Owens in "Before Consolidation: The Golden Age of Rockcastle County Basketball", the name that stands out in Livingston Basketball history is Coach Preston Parrett. "When you think of the Livingston Basketball program, the first name that comes to mind is Coach Preston Parret." Parret coached the Blue Devils through the 1965 District Championship. Members of the 1965 46th District Championship team included: Danny Hinton, Phil Childress, Billy Wyatt, Joe Bowman, Delbert Owens, Ronnie Taylor, Jerry Poynter, Billy "Red" Bryant, Lonnie Vanzant, Bert Newcomb, Vernon Sams, and Gary Mink. Parret would continue to coach at Livingston Elementary after the consolidation and would remain at the school until retirement in 1987. "He finished with 33 years coaching in the Rockcastle County Schools system."

Brodhead Tiger's Coach Bill Riddle took his team on to win the 1972 Region 13 Finals and won. It was the first time the Brodhead Tigers had ever made it to State. Members of the 1972 team included: Clayton Cash, Ronnie Arnold, Tommy Mullins, Darrall Proctor, Dewayne Mink, Terry Burton, Dennis Harris, Ronnie Brown, Pat Crawford, Gary Smith, and Larry LaFevers. According to an article in the March 16, 1972, Mt. Vernon Signal this team, this coach, and this season generated a sense of unity in Rockcastle County Schools, "The enthusi-


asm which has been engendered county-wide by the team has probably never seen its equal in the history of basketball in Rockcastle County." It seemed fitting as well, This was the last year that the three high schools would be separate, as consolidation would take place the following year, creating the Rockcastle County Rockets from Red Devils, Tigers, and Blue Devils. Also fitting, Coach Bill Riddle would be named the head coach of the first Rockcastle Rockets basketball team. Interestingly, Clayton Cash, a member of that


winning team, would re-
