Informal Main Street Committee holds third meeting to discuss potential project ideas

The third Main Street Committee meeting was held Monday night with many local officials present to discuss countless possibilities and ideas for the growth and development of Main Street in Mount Vernon.

Vitalize Mount Vernon Director Lynn Tatum said the meetings provide extremely useful information and the sharing of ideas concerning changes and upgrades to historic Main Street.

"At this meeting, we

were able to look at the list we had created at the first meeting and discovered that most of the plans and ideas have been completed as discussed at that time," said Tatum. "Being able to talk openly and discuss what is going on and what business owners and building owners want to see happen, provides a wealth of ideas to improve our beautiful Main Street to make it more attractive to tourists, more interesting for potential businesses and more convenient for those who live and work in the area."

But there are still many more ideas that the committee continually address. Among them are ideas for Art Alley, which is the space located between buildings on the south side of Main Street, next to Coffey & Ford Law Office. There are already many decorations and beautification additions inside the alley but the committee is discussing a possible covered

stage area and a metal grid system to display local artwork.

Newer ladder truck coming to MVFD to replace older truck

The Mount Vernon City Council called a special meeting Monday evening with one item on the agenda.

According to City Administrator Jim Bowman, the meeting was called to hear a request from the Mount Vernon Fire Department for a newer ladder truck for the department.

Bowman said officials of the department had found a ladder truck for sale by the City of Independence, that is about 10 years newer than the current ladder truck used by the local department. The newer truck is apparently in noticeably better condition due to its newer status, is a bigger truck and has more modern equipment. Department officials decided to attempt to acquire the truck.

According to Bowman, the department now plans to sell the older exist-

ing ladder truck to pay the city back for the help in purchasing the newer truck.

Officials expect about \$20,000 for the MVFD truck and the cost of the newer truck is \$29,000 leaving about \$9,000 difference.

The newer truck is a 2003 Spartan with an additional 20 feet of ladder and a bigger, stronger water pump, according to MVFD Major Adam Bales. "This will upgrade the department's capabilities with a 10-year newer truck and full pump and ladder certifications," said Bales.

City Clerk Crystal Rush said the city will provide the \$29,000 for the newer truck and the existing 1993 truck will be sold at public auction. Those funds will then be deposited back into the city

ing both lanes of traffic for well over three hours. The accident occurred near the entrance of Old Somerset Rd. causing first responders to detour traffic headed in both directions.

According to Brodhead Police Chief Gary Alcorn, a Pit Bull Terrier dog inexplicably attacked 55-year-old Jiles Carpenter last week, causing serious injury to his shin and right leg. "I've known that dog for years," said Alcorn. "I've seen it sitting around and walking through town for years and he has never threatened to harm anyone that I know of. No one seems to have any idea why he attacked Mr. Carpenter."

According to a report from Chief Alcorn, Carpenter was walking along Cash Street in Brodhead last Wednesday when the owner of the Pit Bull service dog was outside with the animal. Alcorn said the dog was on a leash controlled by the owner

as Carpenter began to pass the residence.

However, according to reports, without warning, the dog began to struggle to get to Carpenter as he passed the home. Alcorn said

Aces Over

It was a big deal. Every time we turned on the television set for the nightly news or Saturday morning cartoons, there were announcements on our screen. It was the talk of the town across America. All the kids at school were talking about it and we couldn't wait.

Each week there was something similar to a countdown. "Just three weeks to go..." Then just two weeks and finally we heard the final announcement, "coming tomorrow."

We knew that everyone would be talking about it Monday at school. It would be the topic of every conversation for some time to come.

And sure enough, I was ready. Local, Kentucky television was about to be broadcast for the first time...in color. In those days it was called, "living color."

We had heard of color tv but none of us had ever seen it. Color tv had been released in California in the late 1950s but no one I knew had ever seen a color movie. The first ever all color, prime time broadcast was in 1966. But not in our community. Just a few big cities had the pleasure. But it was coming and I was ready.

That may have been

the most disappointing night of my young life. What we didn't know was that you had to purchase a "color tv" to see color pictures. None of the commercials mentioned that.

So for me and most everyone that attended my school in 1967, there was no difference in our tv that night. The next day at school all the kids and teachers were asking what went wrong. No one knew we had to have a special tv to be able to see color movies. I know that sounds pretty ignorant now. But in those days, it was cutting edge technology and no one understood it.

It wasn't until that weekend that we discovered the price of a color tv. Our black and white tv cost about \$200 (a fortune in 1967). But a color tv averaged about \$1,000. That wasn't going to happen in my home. Dad had paid just over \$1,000 for our F-100 Ford pick-up truck.

Luckily for me and most of my friends, living color caught on really, really fast. The popularity of it was overwhelming. This caused the high price to come down very fast. By mid 1968, a color tv averaged about \$700. By 1969,

Rockcastle Historical Haven

As we move into November we leave behind the dark side of Rockcastle County and move on to topics of home, family, and the holidays. Throughout the month of November, I would like to turn my attention to the history, home, and hearth.

As mentioned in an earlier issue, it is believed that Rockcastle was founded by Stephen Langford. The Langford family came to Rockcastle County by way of Virginia and North Carolina. Peter Langford, author of the book: The Langfords of Rockcastle County: The Trials & Tribulations of a Backcountry Clan, has done extensive research into the first family of Rockcastle County. According to Peter Langford, Stephen Langford was the second son of Benjamin Langford of Virginia. It is believed that he traveled into North Carolina where he eventually held land deeds in the southwestern part of the state, around 1777. During this time Stephen Langford and his brothers-in-law Daniel and John Singleton all served in the same militia supporting the Patriots. Interestingly, both Stephen and his brother-in-law Daniel switched sides and joined the Loyalist militia around 1780. Both men fought in the battle of Kings Mountain. Peter Langford states in a 2021 Facebook post, "Stephen and his brother-in-law Daniel were captured, but according to legend, their Maj. Richard Singleton, on the Patriot side, helped them to escape. Stephen and Daniel were indicted, and had their land...confiscated." As a result of losing his land deeds in North Carolina, Langford left the state,

traveled through the Cumberland Gap, and eventually settled in what is now Rockcastle County.

History is a fickle friend and oftentimes hard to follow. Again there is dispute as to which Stephen Langford was the actual first settler of Rockcastle County. According to Kentuckyhistory.com, One Stephen Langford arrived in Rockcastle around 1790, "Records also show 400 acres near Little Clifty Creek, near the Rockcastle River." another Stephen Langford owned land and built a large white house in what is now Mt. Vernon, Ky. According to a Facebook post by Linda R. Ashley on the Rockcastle County Kentucky History and Genealogy page, "People said it reminded them of George Washington's home, Mt. Vernon, and from that came the name of the town". It is assumed that the two were related, at least securing the assumption that the Langford family was the founding family of Rockcastle County.

The Mt. Vernon Stephen Langford and the home, once known as Langford Station, both have an interesting history. The house itself was

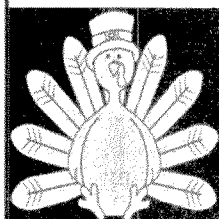

built to allow inhabitants a way to hide and escape from Indian attacks. It is said to have had tunnels built under the house for that purpose. These same tunnels are also believed to have been used for escaped slaves as a stop on the Underground Railroad. Despite the connection to the underground railroad, the house was also connected with slave owners.

Stephen Langford, like many other white men who lived during the 1800s did own slaves. Sherlene Bartholomew reports on her connections to the Langford family and the descendants of freed slaves in an article titled, "Slavery and Redemption on Every Family Tree" on the website, <https://latterdaysaintmag.com/> in March 2006.

Rockcastle's founding family, the Langfords, have an interesting history. Feuds, slavery, and politics are all linked to this family. The Langford family, like many other American families, have their heroes and their black sheep. Peter Langford writes about the bloody feuds between the Langfords, the Mullins, and several other families while Sherlene Bartholomew follows a different historical trail. She found links to Fanny Langford, a freed slave who is believed to have had children who were fathered by either Liberty Langford or an-

other Langford man. Despite the idea that slave owners fathered children with their slaves the Langford family is also connected with abolitionist ideas and beliefs and antislavery enthusiasts.

Every family has its fair share of proud moments and moments that many would prefer remain with the skeletons in the closet. The Langford family is a part of the long lineage of Rockcastle County and we must accept the good with the bad. History is what it is, whether we like it or not. As we sit down to Thanksgiving dinner later this month we will break bread with cousins and in-laws, family and friends, and I, for one, will give thanks for the families that were brave enough to forge this rough rocky land that is my home, Rockcastle County, Kentucky.

they were down to a reachable goal but still about the same price as a new motorcycle at the time.

Finally, in the Spring of 1969, while I was in school, mom and dad went to town and borrowed the money for a color tv without telling me. I walked to and from school in those days. On that day, I walked home and saw mom and dad waiting outside as I turned down our road. I knew something was up. I actually thought I was in trouble for something.

The next few minutes were talked about at family get-togethers by my mother for the next 40 years. She told the story a thousand times. But I entered the house and as I walked across the living room, the tv was to my back, so I couldn't see it. But somehow I knew something was different. Perhaps the color cast on the wall in front of me, I

don't know. But I stopped in my tracks and turned to face our new living color console tv in a real laminated, simulated wood cabinet.

I froze on the spot and stared as people on the television were talking about the news and they looked like real, live, human people. Yes, in living color. My life was never the same. To my recollection, that is the last time I cried. But they were tears of joy and I would spend every night over the next several years sitting on that linoleum floor about two feet away from our color tv.

We were one of the first families in our neighborhood and my neighbor friends would come to our house to watch the Disney Movie of the Week. I felt like the King of our entire community. I could even hear kids at school saying "Mike has color tv." I was all that!

By 1972, just three years later, 50% of televisions in America were color and 50% were still black and white.

It was a day none of us ever forgot. I really had no idea at the time that it was the best of life. I took moment by moment and all was well with the world from my vantage point in front of that RCA color console tv.

That was the first of countless more life changing events in my life. It was a time when the world was changing around me and I was still able to keep up.

But alas, I am now in my latter years and such times are a frost-covered memory. Almost as if looking through a glass, storm door on a cold January morning and trying to see through the patchy frost.

But I know one thing, without a doubt. I was a blessed child to grow up in an America that was growing and changing every day. In my short life, we moved from no running water to DNA sequencing. From encyclopedias to the World Wide Web. From counting on fingers to home computers. And from a world of shades of grey to a world of vivid color.

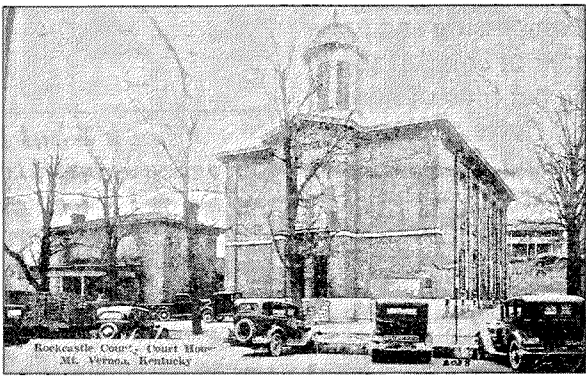

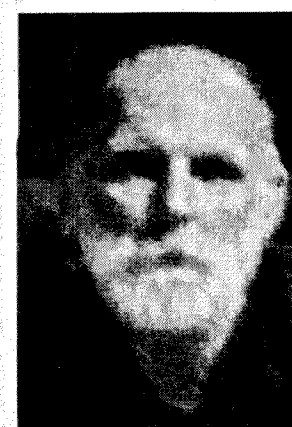
Jon Sanders

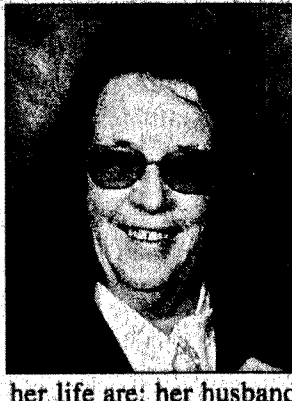

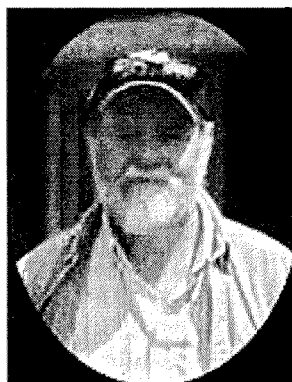

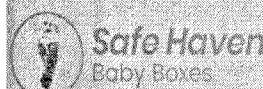

budget, according to Rush.
The motion passed unanimously.
Bales said the department plans to take possession of the newer truck this week and put it into service after a few days of preparation.

Towing, were able to raise the truck and trailer onto its wheels and clear debris and chemicals from the roadway. Once fire department personnel mitigated the diesel leak, the road remained closed while EcoTech Environmental Services took care of final clean-up due to the environmental impact on the soil, according to MVFD Major Adam Bales.

While this accident was being serviced, another accident on KY-70, involving an ATS equipment hauler with rollback equipment, and a standard pickup truck occurred near Hwy. 618.

Kentucky State Police, Brodhead Fire Department, Kentucky Vehicle Enforcement, Western Rockcastle Volunteer Fire Department and Rockcastle EMS were called to the scene after the pickup truck, driving approximately 40 mph, accidentally drove up the rollback who had stopped to load heavy equipment, according to reports.

Sheriff Shannon Franklin said the operator of the rollback had lowered the rollback and had stepped away from the cab of his truck to prepare to load the equipment when the pickup truck shot up the ramp on the semi.

The cab of the semi was destroyed by the pick-up truck as it reached the end of the ramp. Those on the scene said the semi driver would likely have been killed had the driver still been inside the cab.

The driver of the pickup was transported to Rockcastle Regional for treatment. His condition was not known at press time.

Officials say the names of those involved will likely be released later this week when a press release is generated. This story

was written before the press release due to the Signal's press times.

the unidentified owner of the dog reported that she fought to hold the dog back as it was struggling to get to the pedestrian. Alcorn said the dog's leash then broke causing the dog's collar to come off. The animal then rushed towards Carpenter and attacked him biting his shin and his right leg, Alcorn said.

The report said the owner of the dog was able to interrupt the attack and get the dog back under control. When Alcorn arrived on the scene, the dog was inside the home and Carpenter was in need of medical attention, in a gravel area, near the home.

Alcorn said the dog has been quarantined for ten days in an effort to make sure the animal does not have Rabies.

"If the dog does not have Rabies, then it will be up to the county attorney and the victim how to proceed after the ten-day wait," said Alcorn.

According to hospital records, Carpenter was treated and discharged from Rockcastle Regional.

No charges had been filed at press time.

"A stage could be very useful for beginning entertainers to get used to being in front of a crowd or perhaps some local artists could sell their projects on a weekend in the space. There are many other possible uses as well," said Tatum. "The Rockcastle Arts Association would be in charge of organizing the use of that stage area and

the possibilities are endless."

Tatum informed the crowd that the Volunteers of America may move into the former Joe Clontz building and members of the committee hope to see other businesses coming to the Main Street area as well.

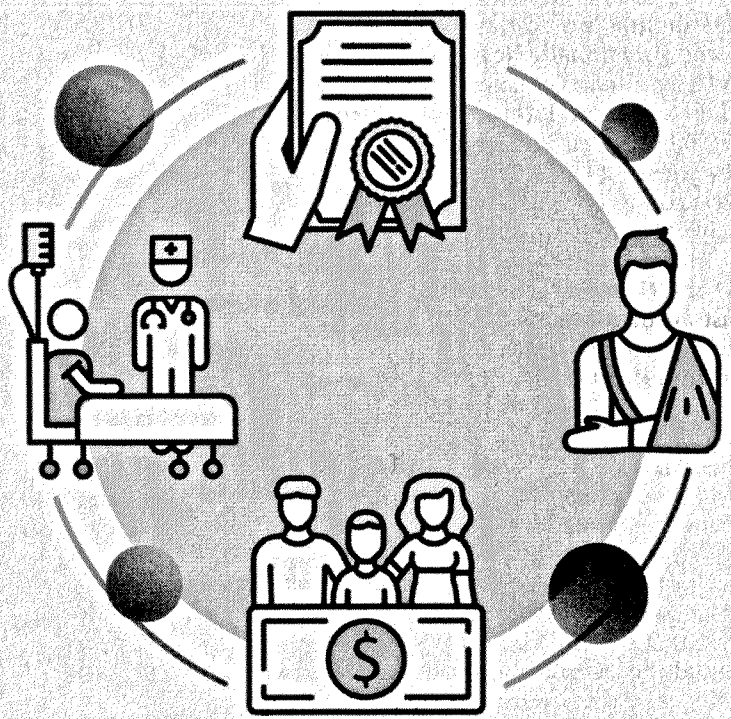
One of the most difficult areas of concern has been how to have better access to the high side of Main Street. "We have met with the Department of Transportation, city officials, engineers and others and there is simply no good answer to that problem," she said.

"We have talked about a lot of possibilities but none of them are feasible or even realistic at this point." However, Tatum says there is a handicap ramp planned, as well as a crosswalk connecting the courthouse with the city parking lot. "There is a lot of pedestrian traffic there and it needs to be addressed," she said.

The group is currently working on a "Phase II" list of projects that are expected to be approached soon and will include the crosswalk and ramp, among other ideas.

"We are just an informal group who cares about Main Street. Everyone wrote down some of their hopes and dreams for Main Street and we will compare ideas and discuss them at the next meeting," she said. "It is always helpful to have different ideas and everyone thinking about the same things. We are expecting some real growth and development in the area very soon and it will benefit everyone if our historic Main Street is attractive and useful, charming and enticing," Tatum said.

The next meeting will be announced soon and Tatum hopes any city or county officials with ideas to help Main Street will take part.

Rockets finish regular season 9-1 with win over Casey Co.

A raucous crowd saw the Rockcastle County Rockets take down a stingy Casey County Rebels squad by a 27-13 final score on Senior Night.

The Rockets ended the regular season with a 9-1 record, which is their best regular season record since the 2016 season.

Casey County, which is now 5-5 on the season, proved to be a much peskier of an opponent than the record showed as the Rebels gave the Rockets all they could handle for all four quarters.

“I thought our kids fought hard and played well,” said Rockets head coach Chris Larkey. “I also think we got ahead and let our guard down and let them back into the game. Casey Co. had a good, big and physical team. I think that we have to keep improving and working harder each practice and not let up.”

Rockcastle County received the opening kickoff and methodically marched down the field and looked to be headed for the game’s first touchdown, but the Casey County defensive unit held their ground forcing the Rockets into a field goal situation.

Junior kicking sensation Benjamin Brenda stepped up to the point of attack and promptly gave the Rockets an early 3-0 lead with his third field goal of the season, which was good from 27 yards out with 6:56 remaining in the first quarter.

Neither team could muster much offense the rest of the opening period, but Rockcastle’s quick strike offense was on full display when on the first play of the second quarter, seniors Tucker Warren and Caleb

Moore connected on a 32-yard touchdown pass to give the Rockets a 10-0 lead.

The defensive squad for the Rockets held the Rebels in check and pitched a first half shutout thanks in large part to forcing the Rebels into multiple turnovers in key situations and some prolific tackling displays by Warren and Hunter Pingleton.

Sophomore all-purpose back Isaiah Jackson stepped up in the absence of an injured Christian Larkey and added a long touchdown run of 55 yards when he took the handoff from Warren and got around the left side of the Casey County defense before zooming his way into the end zone with 2:24 remaining before half-time.

Casey County opened the second half with a 65-yard touchdown run before adding on another rushing touchdown in the early moments of the fourth quarter to cut the Rockets’ lead down to 17-13.

Rockcastle then responded with a drive that took 6:01 off the clock and culminated in another Brenda field goal to push the lead to 20-13.

“Brenda, as I have said all year, works hard and does a great job,” Coach Larkey mentioned about his kicker that is believed to have set a single-game school record with two successful field goals. “The team of Isaiah Phelps at long snapper, Carter Powell at holder and Brenda at kicker just have to keep doing what they are doing. Coming in and kicking two field goals in a game I am sure hasn’t been done in a long time, but as I have said before, every point matters. Brenda kicked those two field goals and gave us six points when we may have ended up with zero mattered in the game Friday.”

Senior fullback Anthony Goodin put the game out of reach when he blasted his way through the line to score from 35-yards out for the

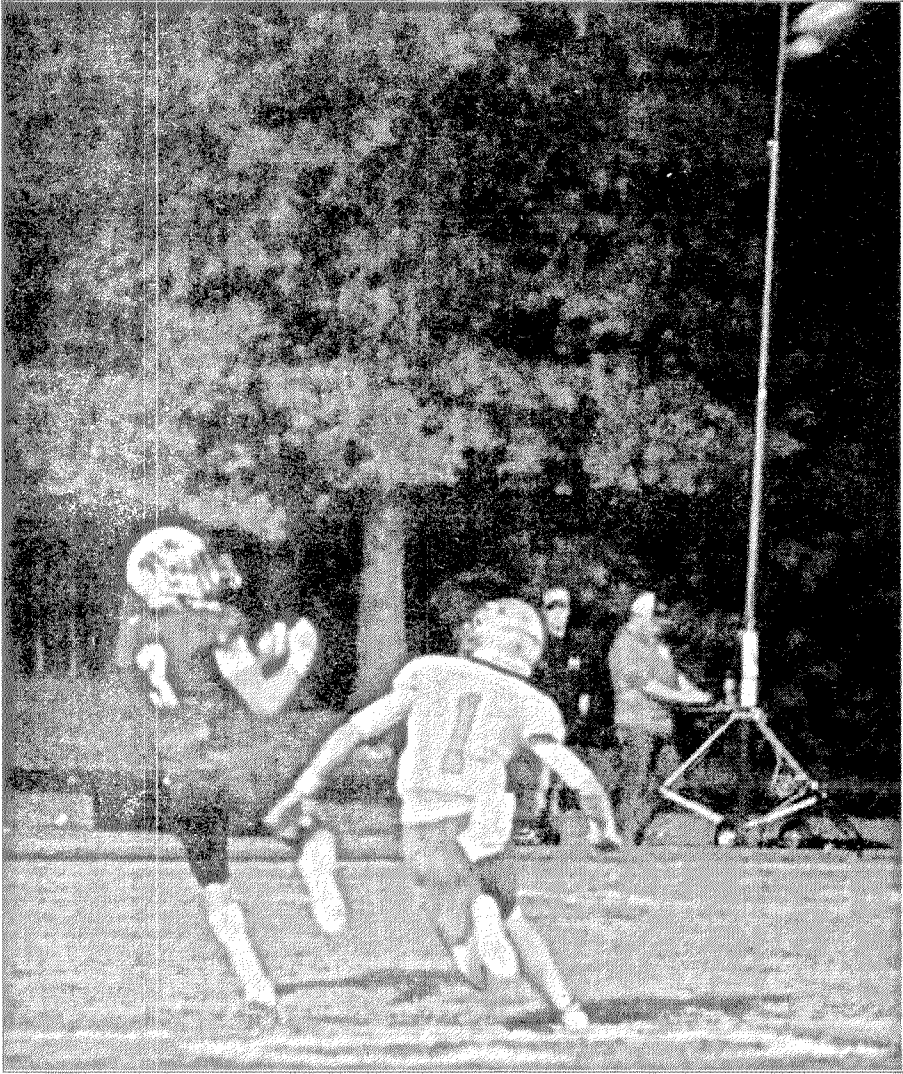
“Those coaches have done a phenomenal job with those kids,” Coach Larkey proudly boasted. “To be in the Final Four in the state is something huge. The team they beat, Union, was a very good team. We held on to win by two points and what a game it was. One of the opposing coaches messaged me on how well coached our kids were and how respectful our kids, coaches, and fans were.”

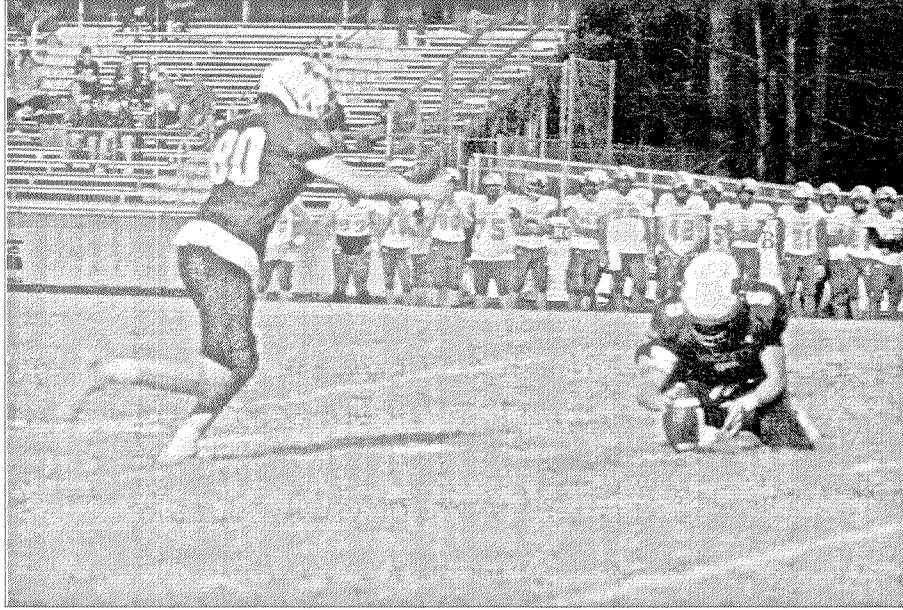

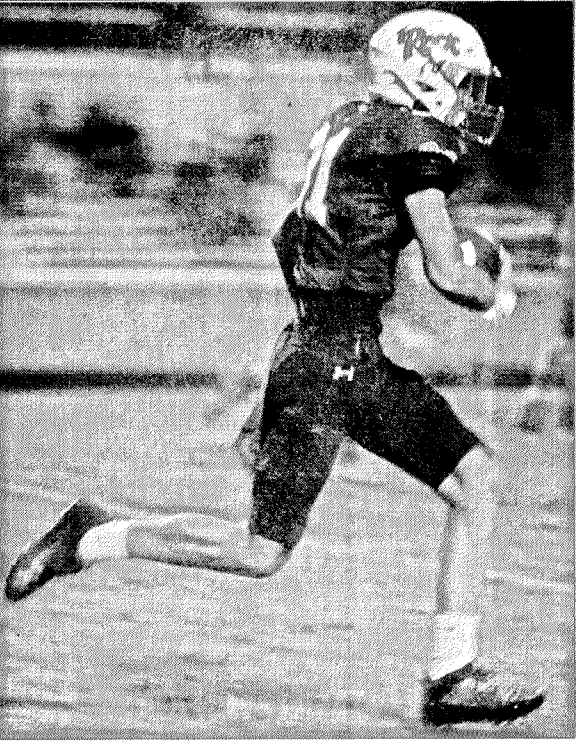

final margin of 27-13 with 2:04 left in the game.

Warren once again led the offense from his quarterback position as the senior signal caller was 13-for-22 passing for 141 yards and one touchdown along with one interception.

Moore led the receiving corps with 94 yards on seven receptions with one touchdown while Cameron Smith and Jackson recorded three catches apiece for 24 and 20 yards, respectively.

Goodin hauled in the remaining reception for nine yards.

Warren rushed the ball 15 times for 74 yards and was assisted in the rushing attack by Goodin and Jackson with four carries and one touchdown each for 51 and 49 yards, respectively.

Carter Powell had the remaining carry that went for one yard.

“Tucker, Anthony, Caleb and Isaiah all stepped up and played well,” said Coach Larkey of his skill position players on offense. “Playing both ways does take a toll on the kids, but we have to have the best players on the field at all times. They play so hard all the time and work hard. They are picking up for those kids that have a bad play and have to come out.”

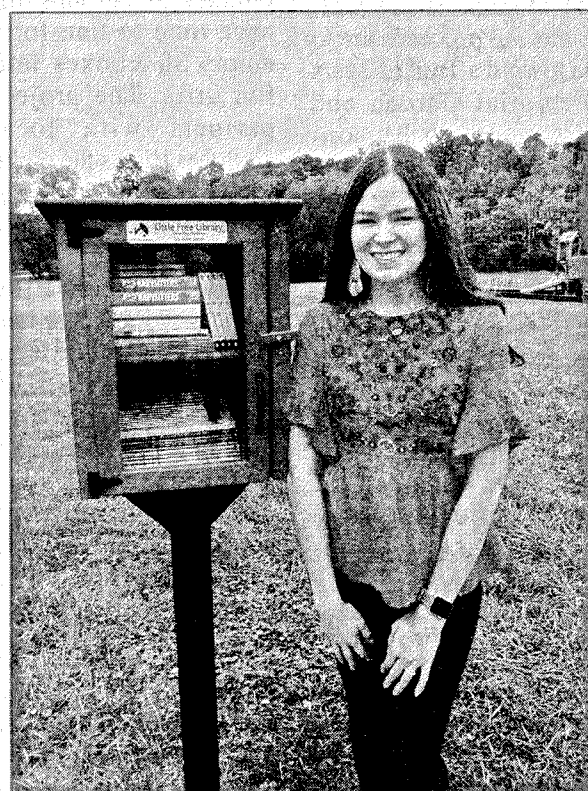
"A reader lives a thousand lives before he dies," said novelist George R. R. Martin.

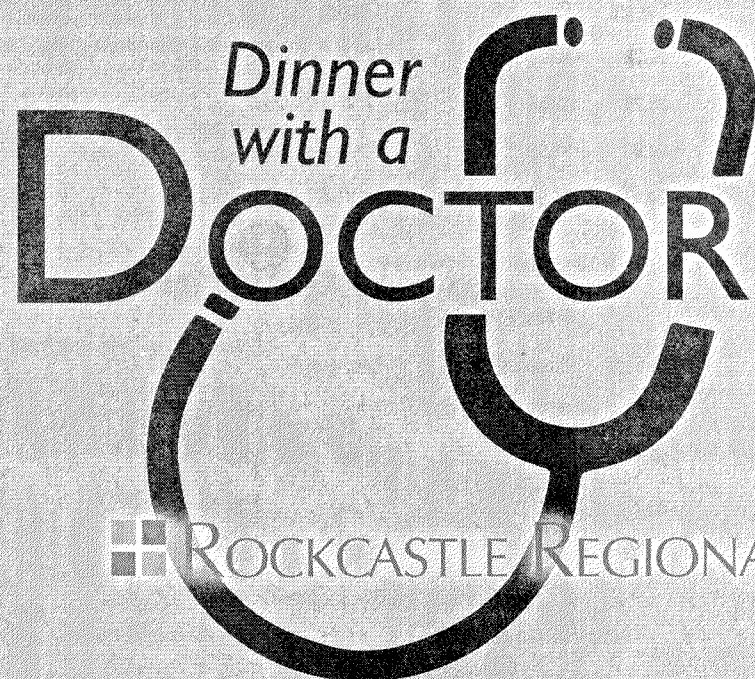



cations across the county and children may come to any of the locations any time they like and take a book home to read and to keep. "They don't need to replace any book they take," she said. "We hope to help build up their home library and add to each child's life with the world of books."

The most recent public free book library was placed at Lake Linville Park and is available to anyone 24 hours a day/seven days a week. "You can come anytime you like and as often as you like," Sweet said. "

The program does not accept book donations from individuals since several large companies donate the funds or the books to keep the five local free book libraries stocked on a bi-weekly basis, Sweet said.

The free book libraries are now located at Rockcastle Regional, the Christian Appalachian Project office, the Mount Vernon Health Department and the Rockcastle County Library. But the most recent placement at the Lake has been by far the most successful. "The one at the park has been wildly successful," she said. "I guess it is the 24 hour access and the convenience of it. But whatever the reason, we are very happy that so many children are coming to get free books and taking them home."

Parents may take their children to any of the locations as long as the business where the book library is located is open for business. But the Lake Linville library is always available.

Sweet has a social

media page where she provides information concerning the book libraries, and other issues that may be beneficial to local children or parents, and she invites everyone to visit "Rockcastle Community Collaboration."

Sweet is a graduate of RCHS and the University of the Cumberlands and an employee of the Rockcastle County School District and she is pleased with the success of the program locally.

"About anyone can purchase these free book libraries on line and set them up," she said. "We are very glad that our outlets are doing so well. We refill them bi-weekly and they are usually about empty by the time we get back to them."

Any parent who believes that reading helps the educational process of their children, is urged to visit one of the free book libraries and let your child pick their favorite book. The process is free and all children are welcome to go back as often as they like.
