New \$58 million RCMS project now underway

Editor Dignitaries representing the State of Kentucky and Rockcastle County

filled the side yard at the Rockcastle County Middle School (RCMS) last week for the longawaited groundbreaking

ceremony for the new \$58 million RCMS project. "There were times that I didn't think we would get here," said Superinten-

dent Dr. Carrie Ballinger. "But thanks to so many who worked so hard, including Josh Bray and Brandon Storm, today we

cross the finish line and break ground on our new, modern middle school project."

The new middle school has been in the works for several years but had a difficult start. By the time the school district raised the funds and was able to bring all the

agencies and entities together to make the dream a reality, inflation had risen at an unexpected rate and the price of the

project became unrealistic. "It is horribly disappointing, but I would rather not build it than to build anything less than what our students deserve," Ballinger said after receiving the unexpectedly high bid packages. The project was put on hold.

Months later, through detailed budget actions and restructuring, countless meetings and weeks of lobbying in Frankfort, the school district was

able to raise around \$38 million toward the project. When Kentucky State Representative Josh an-Bray nounced he

was able to introduce legislation that would provide an additional \$20 million in state grant funding, the project was on again.

Members of the Rockcastle County Fiscal Court held their regular monthly meeting last week with a short agenda.

To open the meeting, the court approved minutes, received three months of Livingston Trail Town reports, approved the monthly development board program support, reviewed reports from: the animal shelter, the Livingston Gym rental report, solid waste department and Quail Park.

Judge/Executive Howell Holbrook, Jr., also gave the court an estimate from Herren Industrial Group for road department grader repairs for \$10,707. The expenditure was approved.

The court also approved several other requests and approved program support as well as approved the payment of claims.

The court officially added Kelly Ponder to the check signing registry since she will be the new County Treasurer and

County Court Clerk when long time county employee Vickie Miller retires at the end of Decem-

Ponder has been training for several months for the position and has already been playing a role in fiscal court meetings. Miller says Ponder "has done exceptionally well" and will be a strong addition to the fiscal court.

The court also heard from special guest Al Cross who provided a presentation to the court and to the Rockcastle County

Industrial Development Authority (see the RCIDA story for details.)

Holbrook requested a transfer of \$135,000 from the general fund with \$100,000 going to the Jail Fund, \$25,000 to the LGA Fund and \$10,000 going to the 911 Fund. The request was approved.

Having no further business, the meeting was adjourned as members of the court rushed to the RCMS groundbreaking ceremony immediately after the meeting.

Mamaw's Kitchen

AUNT ETTNA'S FRUITCAKE 4 cupspecan halves 2 cups walnut halves 3/4 poundcandied cherries 1/2 poundcandied pineapple

1 and 1/2 cup golden rai-

1 cupflour 1 and 1/2 cups of butter, room temperature

1 and 1/2 cup sugar

2 T lemon flavoring

2 cups flour, sifted 3/4 teaspoon baking pow-

Preheat oven to 325°. In a

large mixing bowl, combine pecans, walnuts, cherries, pineapple and raisins. (I always halve the cherries and cut the pineapple into segments.) Toss with the 1 cup flour. Set aside. Cream together the butter and sugar until light. Add eggs, one at a time, beating well after each addition. Stir in lemon flavoring. Sift together the 2 cups of flour and baking powder. Add in thirds to creamedmixture. Mix well after each third.. Add batter to fruit, mixingwell to coat all fruits and nuts. (I do this with my hands since it's a very large mixture.) Transfer batter to a well-greased 10" tube pan. Covertightly with foil. Place a pan of hot water on bottomrack of oven. Bake cake on rack above water for 2 1/2 - 3 hours. Re-

move foil. Bake 3 to 5 minutes more or until topis slightly dry. When thoroughly cool, remove cake from pan. Brush with light corn syrup and garnish with candied cherries. Store in tightly covered container.

FLORIDA WHITE FRUIT CAKE

1 pound candied pineapple 1 pound candied cherries 4 cups chopped pecans

2 cups flour 1/2 pound butter

1 cup sugar 5 eggs, beaten

2 tablespoons lemon flavoring

2 tablespoons vanilla 2 tablespoons almond flavoring

I like to line the tube pan with brown paper and grease with Crisco®. This keeps the cake from getting dry and makes it come out of pan easier. Using a sharp knife, chop fruit and put in largemixing bowl with the pecans. Add flour to fruit and nuts; try to coat each piece of fruit with the flour. Mix until each piece stays separate. In another mixing bowl cream butter, sugar, and beaten eggs. Add flavorings. Combine with fruit, nuts, and flour mixture. Stir until mixed. Pour into prepared pan. Placein cold oven and bake at 225° for about two hours.

Cool on rack before removing from pan.





BEER BEEF BRISKET

Joanne served this at our first Progressive Christmas dinner after we moved into the neighborhood. Everyone loved it. I got the recipe and fixed the brisket for our New Year's Eve dinner when Lawerence and Lelia spent the holiday with us. 3/4 cup firmly packed dark brown sugar

3/4 cup chili sauce 3/4 cup ketchup

1 pack (1.4 ounce) dry onion soup mix 1 bottle (12 ounce) beer not light beer

1 beef brisket, 3 to 4 lbs 15 small red potatoes 1 and 1/2 lbs baby carrots

Preheat oven to 325°. Stir together first4 ingredients; gently stir in beer. Place brisket, fat side up, in a large Dutch oven or roasting pan; pierce several times with a fork. Arrange potatoes and carrots evenly around brisket; pour beer mixture over brisket, potatoes, and carrots. Bake uncovered for 3 and 1/2 hours, basting occasionally with sauce. Remove from oven, and let brisket stand in pan, uncovered, 20 minutes. Remove brisketfrom pan; cut into slices. Return to pan with potatoes and carrots. Cover; bake for another 30 minutes or until vegetables are tender.

BROCCOLI SALAD 1 small head of broccoli, 1 small head of cauliflower, chopped 2 tomatoes, diced 1 can black olives, halved

1/2 red onion, diced 1/4 cup sunflower seeds 6 slices bacon, cooked and crumbled 1/2 cup prepared ranch

Combine the veggies; toss with both dressings. Add sunflower seeds and crumbled bacon. Salt and pepper to taste.

4 eggs 2/3 cup oil 1 container (8 ounce) light



Finding that private

as secluded. Privacy outside the home is often missing. If you have a garage attached to your home, that may be as close as you can come to finding a moment in private.

The smart phone or the laptop do entice some to ignore even a crowd and give the illusion of privacy to the younger folks—but you do know the device is listening and recording all the time, right? And the home that has the fashionable open floor plan is all the more likely to impede any thoughts of intimacy.

Yards to Paradise

For a couple, I suppose there's the bedroom with blinds and thick drapes—but so much of one's waking hours are spent elsewhere.

So, if secluded spots are scarce or non-existant, how can we make some areas conducive to privacy and relaxing? And, this being a landscaping column, outdoor settings for privacy is our objective. Let us begin with a few ideas, and you'll probably think of additional ideas on your own once you give it further consideration.

One idea is fencing. From solid barriers to lattice types, fences are useful for creating private spots.

But, fences can make a small yard feel even more tiny. And codes in towns may limit the height so that you don't get the result you sought. Growig vines on fences and planting hedge plantings just inside or outside the fence (if allowable in your city) can help in gaining privacy by fencing or partitions.

Structures of varying types can give us a private spot in a gazebo or behind a shed. Outdoor rooms can do the same, especially if strategically placed shrubs or hedgerows are included.

Blocking of view has at least two purposes; blocking out undesirable views, and blocking others from viewing us or our place. Trees are a means to accomplishing this. Still, trees take time to grow large, so multiple smaller trees both evergreen and deciduous can create a thicket that is hard for neighbors or passers-by to see through. This idea can deter everything from salesmen to trick-ortreaters to the prying eyes of "street view" of your home by Google.

Recently we;ve realized flying drones are another hindrance to intimate moments in our own yards. Satellites and aircraft have for a long spell been spying on us...but out of sight is often out of mind. Finding relief from eyes in the sky will be a more complex undertaking.


Possible solutions to this as well as some of the other ways we lose our privacy or feel failed by walls, fences and hedges might include an allee of trees that droop or weep to make the area under them hard to see from overhead. A picnic table or a childs sandbox under large trees can afford screening from eyes above. Going partly or even completely underground with our patio or outbuilding or 'man cave' is an option unless there are restrictions on such where you reside.

A sunken patio surrounded by a wellplanted berm may be a workable option. Or even a depression that is still planted in lawn grass surrounded by evergreen trees or hedge plantings can be a simple remedy if you can't get permission for a sunken patio or structure. (A giant 'tornado cellar' should be acceptable to most zoning folks-just call it a storm shelter and it'll probably meet with approval of your codes enforcement officials and homeowners associations.)

Large plants in containers, rooftop gardens, multi-purpose greenhouses and sheds may also be possible actions you can take.

Providing eclosed spaces and other spots offering privacy and opportunities for intimacy with a partner or just a commune with the creation can really help make our yards more like paradise.





Rocket season ends with 21-13 loss to Belfry

Despite a valiant effort against a formidable foe, the Rockcastle County High School football team saw its season come to an end by a 21-13 score as the Belfry Pirates advance to the region finals of the KHSAA Class 3A Playoffs.

The win will allow Belfry to host the Russell High School Red Devils in the next round, which would have been the situation if Rockcastle had won the contest."

"We went into the game knowing that Belfry was very fast and big," mentioned RCHS head coach Chris Larkey of a Belfry squad that had scored a minimum of five touchdowns in each game things season. "We also knew that in order to stay close and have a chance, we had to run at them. their overall team defense speed is just as good ours is. I thought our kids played exceptional. Once we got into the flow, we moved the ball on them and actually ran 20+ more plays than them. We are only the thirdteam to rush for over 200 yards on them this year and we held them to their lowest total all year. It's a testament to how hard our kids played and executed the game plan to win. In the end if we make a couple of plays here and there we win, but we had a chance and against a good team like Belfry at home, that's

all you can ask for." That chance came to be after Rockcastle had trailed 21-7 late into the

fourth quarter before Isaiah Jackson bullied his way into the end zone to cut the deficit down to 21-13 with just over three minutes to go.

Unfortunately for the Rockets, the ensuing onside kick would not bounce their way and the Pirates took the ball, gained a first down and ran the clock out for the victory.

"We knew going in we had to counter Belfry's speed by attacking them head on," Larkey stated. "It has been our strength all year. Our offensive line made some good holes and lanes to run through and allowed Carter Powell and Isaiah Jackson to keep moving the chains. We actually kept the ball out of Belfry's hands for the most part and allowed for the game to stay close. I just can't say enough how proud I am for the kids to play so close to such a good team. We tried getting outside some, but their speed slowed that down a lot."

That outside speed on the defensive side of the Belfry because Rockcastle would have had numerous plays go longer first downs if not touchdowns.

From the opening kickoff, it was evident that it would be a battle of two teams that were going to step up to the line and show the others just who wanted it more.

During the pregame coin toss, Belfry had the beginning of an atypical

spirit line like all teams do especially when at home and in the playoffs. The Pirates, however, extended theirs well past midfield and deep into the area the Rockets would run through thus not allowing for a Rockcastle spirit line while the coin toss was about to commence so the PA announcer knew whether to announce the Belfry defensive or offensive start-

A Belfry senior lineman ran from his endzone towards the Rockets in a poor showing of sportsmanship trying to forcefully get our players to move all while the referee crew stood there taking it all in.

"The stuff Belfry did before the game should have gotten them a penalty to start the game," Larkey 'added about Belfry's pregame shenanigans. "Teams and fans aren't allowed past the 50-yard line. They more than exceeded that and allowing their players to run down to our huddle to taunt us is classless."

That extra motivation ball was paramount for for both teams to come out firing on all cylinders led to a masterclass in hard-nosed, bruising, aggressive and powerful but clean hits from both teams. Things may have been chippy prior to the game, but it was evident that the Rockets showed that they were in it for the

long haul. With the game being scoreless late in the first quarter, Belfry returned a punt over 30-yards for outstanding field position at the Rockcastle 25. One play later, it was Belfry leading 7-0 3:36 left in the first quarter.

It wasn't until a long, sustained drive late in the second quarter before Rockcastle was able to finally crack the scoreboard when sophomore quarterback Caden Lovell scored from 2-yards out with about 0:30 left before

halftime Belfry would take the lead and eventually extend it to 21-7 before the Rockcastle touchdown late in the contest provided the final margin.

Even though the offense struggled at times, the effort that many of those same players

showed while in the defensive side of the ball was the most impressive showing in holding a staunch offensive team like Belfry to its lowest scoring total of the sea-

"Our defensive coaches did a great job on the game plan of stopping Belfry," praised Larkey. "You're never really going to stop them 100 percent based on what they do, but to limit them so much and give us a chance is all we could ask for. They run the hardest offense in the state to stop and all it takes is one misread and they score."

No defensive stats were available in the KHSAA scoreboard site at the time of printing this article, but offensively, the Rockets were led by Powell's 116 rushing yards on 26 carries. Jackson was close behind with 88 yards on 20 carries and one touchdown.

Lovell had four carries for nine yards and one touchdown and was 1-6-1 passing with the one completion going to Jackson for a yard.


Creed Gabbard

Gabbard was the state. sack leader going into Friday. His speed and strength and blocking from tight end and just this personality will be greatly missed. He played so awesome this year.





that burden of living up to


the expectations set before us by past teams and success for us is playoff wins. No one feels worse when it's over than me. No one can imagine the pressure we put on ourselves to win for this county."
