

An annexation proposal of one kind or another has been before the city council in the past four years. ## **Attention Burley Tobacco Growers**

Exactly one week after Kentucky Gov. Wallace Wilkinson proposed a 7-cents-a-pack tax hike on cigarettes, representatives of burley growers from five states unanimously opposed

The governor had recommended

The governor had recommended the cigaretic pair increase, Jan. 16, as part of his \$1 billion tax package (or he state's General Assembly, which convered its biennial session this month in Frankfort. The following Tuesday, however, director's of the Barley Tobacco Growers Cooperative Association unanimously authorized its officers, during the board's Jan. 23 meeting, to oppose the cigarette portion of the Bluegrass governor's tax package. The 49-year-old cooperative repre-sents burley growers, not only in sents burley growers, not only in Kentucky, but also in West Virginia, Ohio, Indiana, and Missouri. To clarify the cooperative's stance, BTOCA President John M. Berry, Jr.

said that the board elearly recognize Kentucky's need for increased reve nue, but its directors fear the national message that Wilkinson's cigarette proposal sends

The attack on tobacco is probably greater today than it has ever been in the past," Berry said. "Right now, we're facing about 120 bills in Con-gress that have to do with either taxing or regulating tobacco out of exis-tence. So whether the additional tax

ing or regulating tobacco out of exis-tence. So whether the additional tax on cigarettes in Kenucky is justified or not -- in terms of the revenue that icculd produce or the revenue that is governor to go on the ani tobacco forces." Pro-tobacco Congressmen have cautioned, Berry said, that a cigarette like Kentucky will make it "far more fifficult" for them to defend against similar measures in the nation's capi-al. "They're going to say," the BTGCA president predicted. "You you folks in Kenucky are doing it. And if if's on going to hart tobacco to do it in Kenucky, then why will it hurt tobacco if we do it in Washing-ten?"





#### As Good As A Mix

As Groot A With the fast pace of todays life-styles, we rely more and more on uckaged and already-prepared foods. In the process, we often overlook-how casy many of these products are to prepare ourselves with just a few common ingredients. Mixes and particibly repared foods usually are a little quicker and easier to prepare, but require similar cook-ing ume. The particibly repared foods are more expensive since you are paying for the convenience as well as special packaging. Also, one has no control over the added preservatives, type of fat and other ingredients in-cluded.

cluded. Many of these foods are so easy to prepare in the microwave. One of the nice things about some of the micro-wave mixes is that they are devel-oped to perform yery well in the microwave oven. However, the spe-cialty deviced billion areas areas cially designed baking pans are as important as the mix with cake and brownie products. Our recipes, when combined with these pans, achieve similar positive results to the mix products. You will be pleasantly surprised at how moist and tender the products cakes are and how moist and chewy

cakes are and how most and chewy the brownies can be. So, when you need a quick dessert or entree, you have a choice of using a microwave mix or making your own creation from scratch. Either way, you are in for some good eating with minimum preparation and clean-

up. Microwave macaroni and cheese

mixes are fairly new on the market mixes are fairly new on the market. We found this recipe to be as quick and easy as the mixes and we prefer the flavor. Processed cheese gives a creamier consistency and is less apt to overcook than natural cheese.

Microwave Macaroni and Cheese

1 cup uncooked elbow macaroni 1 cup hot water 1/2 cup milk 2 tbsp. butter or margarine 1 cup (4 oz.) cubed pasteurized process cheese spread




