# In Mt. Vernon **Council passes** first reading to increase their occupational tax

Workers within the city limits of Mt. Vernon will see a little less in their paycheck come July 1st if the Mt. Vernon City Council approves the second reading of an ordinance Thursday morning at a special meeting, which will increase the city's occupational tax from a half percent to one percent.

The first reading of the revised occupational tax ordinance was held at a special meeting last Thursday night where the city also approved an ordinance adopting the city's budget for fiscal year July 1, 2008 through June 30, 2009.

Mt. Vernon Mayor Clarice Kirby told council members that the council needed "to make preparations ahead so we won't be in the shape the county finds itself in now." The mayor also told the council that she had put off bringing the matter before them because discussions with the county had led her to believe that they would pass an occupational tax which would encompass the city -- thus giving the city the chance to actually do away with their tax and receive their share from the county's tax.

in and stopped the renovation project on the pool because Rapids Recreation Center, who not bring the pool into compliance, the cost of the renovation project on the pool more than tripled. Mahaffey told the group the board had a contractor who had given them a bid of \$68,000, which they thought would fix any problems at the pool but, when the contractor tried to obtain permits from the state, through the local health department, the project was stopped and the club was told there would be much more work

"I realize this is going to be hard on low-income people but we have city trucks that workers are falling through the bed, employees have not had a cost of living increase since I came in office," Kirby told the council. "You have to have money to match grants you apply for and I feel the fire department chief's position should be a paid position, which would make them more accountable," Kirby added.

She also mentioned that the city would need to expand services if they were successful in extending the city limits. "I always think about residents of Rose Hill Road for whom we haven't done anything since they came into the city limits,



"Old Fashioned" Strawberry Shortcake

When my brother Al was about eight or nine years old, he was in the local 4-H Club in Rockcastle County. He recently reminded me of the story of his first job, raising strawberries -I was not even alive at the time.

Bob Spence, the county extension agent, came to the school to inform students about strawberries and to provide plants for the 4-H Club members. Parents were also present at the meeting to make sure that the club members knew exactly what to do with their "berry projects." According to Al, "The students were sitting in the school desks, and the fathers were lined around the room."

Spence called each member's name and then asked if that child wanted a quarteracre or an eighth-acre. When he came to Al, he again repeated the question. Because he didn't want to take on more than he thought he could take care of, Al simply answered, "I think I want an eighth."

From the back of the room came an immediate loud remark from our Dad (Hobe Grif-

fin), "Son, you can't handle an eighth! Give him a quarteracre." Albert was so embarrassed that he wanted to crawl under his desk. Not wanting to call any further attention to himself, he simply took his quarter-acre of plants and went home.

Al read all of the information provided concerning the berry project and planted them on our small farm. My mother (Bee) and our grandfather (Pop) assisted with the initial planting.

The plants were set out during the first few weeks of April. When they began to flower, Al was instructed to pull off the flowers so they would mature.

By early June, the berry patch had been neglected enough that it was almost consumed with weeds. Bee made Albert crawl up each row on his hands and knees to pull every weed. He then carried them in a bushel basket to the edge of the woods that lined our property.

About the third week of June, Al said, "The patch was completely covered with suc-

### **More About Skin Cancers**

Presented by David Brabon, M.D.

Sun-induced skin cancers are common and well-known, but the skin can also show signs when there are various cancers of internal organs.

One of the most common of these is Paget's Disease of the breast. Here, a malignancy below the skin extends to the skin surface and causes a weeping, itchy, eczema-like rash of the nipple.

Occasionally a person will develop a darkening of the skin in the armpits which is called acanthosis. This is often associated with tumors of the hormone-producing glands. It can also be seen with be-

nign tumors as well as in people who are obese, have a family history of this trait, and in some hormonal abnormalities.

Dark spots called keratoses often develop on the backs and chests of people as they grow older. Having a few is normal, but when a great number develop suddenly they can be associated with cancers of the stomach, colon, or female reproductive tract.

Hives is another skin reaction that can be related to cancers. Although hives are most commonly caused by allergic reactions or viral infections, they can be seen in cancers such as Hodgkin's Disease, leukemia and others.







#### Judge responds to letter...

Dear Editor,

In last week's letter from Ms. Blair, the most telling statement she made was that she had finally "discovered the importance of being aware of the activities of (her) local government." My sincere thanks to Ms. Blair for finally recognizing what I have been preaching since my first day in office: the importance of local government. Only at this local level

does an individual citizen actually have a realistic opportunity to voice concerns and complaints. It is too bad that most of us sit idle and seemingly unconcerned until the local government is forced into action. Had she been carefully reading the Mt. Vernon Signal for the past 15 years, she would have been well aware of this county's financial problems. Rarely has a meeting of the fiscal court occurred that financial difficulties were not discussed and reported in the Signal (that's about 450 meetings). And the present financial condition of the county as overseen by the fiscal court is due to only one group in Rockcastle County: Persons who fail to keep themselves informed and are always opposed to any new tax or tax increase, yet want the community to maintain and construct everything from roads to water lines to fire protection to ambulance service to housing prisoners to...well, you just name it. These are also the very same citizens who would have always been against taxes in any form and would prefer that we operate on those taxes that were first imposed upon this county in 1810. And they are always uninformed as to facts while, at the same time, very aggressive in their mission to misinform others who are also uninformed. And they hope to carry the day. How dangerous it is to rely either on distortion of fact or

plain hearsay. Ms. Blair has, unfortunately, misinterpreted my action and those of the magistrates voting approval of the occupational tax. The state holds us under constitutional oath to see that Rockcastle County's taxes are able to maintain the minimum state requirements of county government. Under pressure from citizens for generations, this county's fiscal courts have been very reluctant to increase any taxes – even to keep up with inflation. This is the last county in the entire region to enact this tax. So that is why we are where we are. This has not been 'mismanagement'. If anything, Ms. Blair should

They want to keep their local government poor and then criticize the community for not thriving.

Unlike some, I know that my meager fifteen cents of every ten dollars I make cannot do much – even for myself. I do know, however, that when all of us pool our resources together – and work toward a common goal of making it possible for the first time ever in Rockcastle County to have funds to attract good paying jobs for those presently making minimum wage or having to work outside the county in Richmond, Lexington, London, or other places (3,100 do

that every day) - we can then help lift our neighbors up. I am in favor of using my fifteen cents (of each \$10) to build up my community (and that will take time). Some prefer to keep their fifteen cents of each ten dollars to themselves.

culent berries." He carefully picked them in order for my grandmother (Mommie Katie) to can and to make jam. He also sold them by the quart to our neighbors.

Every year that Al lived in Mt. Vernon, he was the caretaker of the berry patch. At the end of 1952, Al enrolled at Georgetown College as a fulltime student. The berry patch was not cultivated after he left the farm. For years the berries came up and served only as rabbit food.

By the time I was in the eighth grade, the strawberry

patch had become wild. The wild strawberries were very small and extremely sweet. The small plants propagated themselves by runners. The berries were also very aromatic.

Mommie Katie took me for a walk into the patch one summer, explaining, "David Joe, if you will pick a gallon of these berries, I will make us a Wild Strawberry Shortcake." I had no idea what she had in mind but I knew what a super cook she was. Without hesitation, I proceeded to the house and got a large metal bucket to hold the berries.

When Mommie first mentioned a short cake, I thought of the little round cakes that you purchase in a restaurant. How wrong I was! Her

shortcake turned out to be completely different from anything I had tasted before.

When we went into her kitchen, she took a large black iron skillet from the bottom of the kitchen range. I can only recall two ingredients that Mommie Katie used in the preparation of the shortcake: baking powder and flour. She called it a biscuit, but it completely covered the bottom of the skillet. She made two of these large "biscuits." Each biscuit was sliced into

two layers. The bottom layer was covered with the small berries which had been covered with sugar and placed in the refrigerator the night before. The other half of the biscuit was gently placed on the berries and more berries were ladled on the top. The concoction looked like a huge apple stack cake when she finished. At that point, she wrapped it in wax paper and gently placed it in the refrigerator to cool.

That night after dinner, Mommie Katie removed the Wild Strawberry Shortcake from the 'fridge and set it in the middle of the dinner table. Filling several small bowls, she passed them around for us to sample her creation.

I always loved desserts, but this was nothing short of amazing to my young taste buds. I remember it well to this day. The berries and the huge biscuits made a dessert that was like nothing I have tasted before or since. (Think of the purest, sweetest strawberry jam ever made slathered generously on a huge homemade biscuit.) I will never forget that experience. Regular strawberry shortcake pales by comparison.

Each summer after that, I picked the small berries and Mommie Katie "did her

we'd be about as close to the hospital in Owen County as we are in Paint Lick, that baby wasn't going to arrive within the next several hours anyway, that she'd call the cell phone if the situation changed and for us to get on up to the backwoods and sing the blues. She was so disgusted with the false alarms that she and hubby, Kevin Ochs, were planning on going out on one last pre-delivery date themselves.

In the spirit of what a shame it would be to let those tickets go to waste, Lo and I decided at 2:30 PM to go to a concert 100 miles away that was scheduled to start at 5:00 PM . We figured on giving the two extra tickets away to somebody standing in line at the general admission gate. But, as it turned out, that didn't happen. Simply put, there was no line and nobody waiting to get in. The music had begun.

Sonny Moorman, no slouch with a blues guitar himself was on stage. He was followed by Room Full of Blues and they were mighty fine. Then, just before 8:00 Buddy hit the stage and within seconds every person in the little valley, I'm guessing about 2,000 fans, were on their feet and we all remained standing for the next hour and a half.

Buddy Guy is in his early seventies but I'm telling you that there was not a soul on the premises with more energy. And I can count on fingers of one hand the number of times that I've felt that I was in the presence of that much greatness. He touched on Eric Clapton, John Lee Hooker,

Muddy Waters and several other great blues guitarists, but he mostly applied his own style. Lo and I are much bigger blues fans now than we were before Saturday night. Let me simply say that I have never heard nor ever expect to hear again a finer rendition of "Mustang Sally."

However, on the way out, with hundreds of people walking by, some goobers began setting of fireworks. Serious, big-time, very loud fireworks like the kind you see on the 4th of July celebrations at name your favorite city park. Said fireworks were not supervised by any fire department and they were exploding directly over our heads. Ashes and residue rained down on us and suddenly a bomb that failed to properly launch landed right beside the path. Had Loretta been a few feet closer she would be blind or much, much worse now. Somehow she managed to get her hands over her ears in the nick of time or she'd be deaf .

As it happened she took a small piece of shrapnel to the arm and a bigger piece slammed into her behind. Enough of us were cursing the morons engaged in arguably the most blatant example of public stupidity I've ever witnessed, that they stopped. They didn't offer any assistance but they did have enough sense not to cuss back.







# **Students honored in Art & Writing Contest**





# Father's presence produces benefits for young ones

Many parenting guides focus on the role of a mother in her child's life, but the father's role is just as important. The presence of a father during a child's early years provides tremendous benefits to the child's development. Studies have shown that children with involved fathers are more social. handle stress easier, have higher IQs, a greater sense of humor, longer attention spans, are eager to learn and are confident in their individuality and their values.

So how does a person become a good father? Fathers should become proactive in their child's life early on. One way fathers can be proactive is by being present in the delivery room when the child is born. The birthing experience establishes a father's immediate connection to the child and creates an experience between the father, child and mother that is solely theirs. Dr. Berry Brazelton writes in his book, "Touchpoints," that fathers feel a sense of "euphoria" after witnessing the birth of a child. He also mentions fathers who are present at childbirth are more likely to be more supportive of their wives.

Fathers should let doctors and nurses know up front that they want to be present for the baby's checkups and included in discussions about the baby's health and proper care. Sometimes doctors and nurses inadvertently talk only with mothers about the baby's health and care issues.

While becoming a parent may seem scary for new fathers, early paternal involvement helps ease the transition into parenthood. When fathers are involved with the care of their newborn, they tend to pick up on the child's "language" and body signals. This helps fathers know when the baby is hungry, needs to be burped or has a wet diaper. Brazelton said mothers who breast-feed can have an extra bottle available for the father to feed the baby once their milk supply is established. This gives the father a chance to take part in the feeding experience while giving the mother a break. Fathers should also participate in bathing, dressing, playing and other responsibilities that come with a baby. Studies have found babies with fathers who actively participate in these tasks are more socially responsive.

Fathers also play important roles as the child develops. Studies show fathers tend to encourage children to be more exploratory and independent. Fathers also help their children improve their motor and problem solving skills, encouraging them to keep trying even though they may be frustrated at first. Mothers have been known to give in to the child once they notice the child has become frustrated. Some mothers can be guilty of coddling their child, by continuing to feed the child when she can feed herself or permitting sleeping in the parent's bed rather than insisting the child sleep in his own bed. A father can help the child loosen dependency on the mother and can help the mother "let go."

It is important to acknowledge that no one can be a perfect parent. Parenting skills grow as parents learn from their mistakes. With a new child, mothers and fathers may find themselves competing for a child's attention and affection. Rather than be in competition, parents should appreciate one another's special abilities and find ways to split the responsibilities of raising the child. #### Kentucky Chatauqua® presents Abraham Lincoln: I, too, am a Kentuckian" **Discovery Festival at Renfro Valley, Saturday**

There will be a lot of activities at Saturday's Discovery Festival in Renfro Valley when it kicks off at 2:30 p.m., including a presentation on the 16th President of the United States, Abraham Lincoln and his ties to Kentucky.

Born on a farm in what is now Larue County, Kentucky, Abraham Lincoln (1809-1865) spent his early years in the Commonwealth. When he was seven, his family moved to Indiana and later to Illinois. But as his native brilliance and burning political ambition carried him to the presidency and greatness -- a panel of historians recently chose him as the most influential American who ever lived -- Lincoln always had connections with his native state.

In his law office in Springfield, Illinois, he had a partner, William "Billy" Herndon, who hailed from Greensburg, Kentucky. His best friend in Springfield was Joshua Speed from Louisville. His wife, Mary, was from Lexington, a daughter of the prominent Todd family. And his political role model, a friend of the Todd family, was the Kentucky statesman Henry Clay. During the Civil War, Lincoln was very unpopular in

Kentucky, but when he said, I, too, am a Kentuckian," no one could dispute it.

Though he never came close to winning Kentucky in a presidential election, and was reviled by some of the state's most outspoken citizens, Lincoln always regarded Kentucky with affection. And he never lost sight of its strategic importance in the Civil War. "I think to lose Kentucky," he said, "is the same as to lose the whole game. Kentucky gone we cannot hold Missouri, nor I think Maryland." Lincoln read Kentucky newspapers, knew the thinking of opinion leaders and was sensitive to the state's strong attachment to the institution of slavery. Despite imposing a sometimes harsh military rule, he was able to keep Kentucky in the Union, but few Kentuckians thanked him for it until after he was dead.

Abraham Lincoln is portrayed by Jim Sayre of Lawrenceburg. A retired transportation manager, Savre has been studying and portraying the great president for several decades.

needed to bring the pool within state guidelines.

New plans for the pool had to be submitted to the state and new bids solicited. New cost estimates to fix the pool and bring it to state specifications are approximately \$200,000.

Mahaffey told the group that, after paying off a \$30,000 note at Citizens Bank and paying all of the costs of improving the golf course, including an irrigation system, blacktopping and a new mower, a total of \$241,000 had either been spent or committed, leaving the board with \$133,000 to spend on the pool.

No one at the meeting had any solid answers as to how the additional \$70,000 to \$80,000 to fix the pool could be obtained, except to suggest possibly trying to partner with the Rockcastle Hospital and even to turn the Recreation Center over to the Fiscal Court, so money from the Kentucky Association of Counties could be borrowed at a much lower interest rate.

Board treasurer Joe Clontz

CRRC membership could then lease it back from the county on a long term agreement.

And, Mahaffey said he would attempt to talk with Rockcastle Hospital CEO Steve Estes about any possiblities of the two working together on a pool project that would benefit both the hospital and CRRC.

Mahaffey also told the membership that because of the cost of the needed renovations to both the golf course, pool, parking lot and cart paths, dues would go up. Mahaffey said that original plans were to raise the dues from \$550 a year to \$750 a year but, because of the extra costs now involved with the pool, that figure could go even higher.

CRRC now has approximately 128 family members and Mahaffey said any increase in dues would come next year, after the renovations were complete.

Those in attendance did agree to hire Goff Construction to begin excavaton work around the pool to see just how badly it was leaking and to give contractors a better idea as to how much the actual cost of the repairs would be.

Barring a miracle, the pool at CRRC will not open this year. However the Cedar Rapids Dolphins Swim Team will swim at away meets and at conference.

except remove snow and, of course, provide police and fire protection.

"Dennis (McClure) saves us a lot on equipment, using his personal equipment when needed plus others donate their equipment for our use, our fire department utilities are going to go up, gas prices are up from \$8,000 a year, six years ago, to \$30,000 this year and our audit will cost about \$45,000 (up from \$15,000 in 07-08) because we have federal funds that must be audited this year" the mayor added.

Some cost-cutting measures were discussed -- cutting the number of policemen on day shift from three to two and the number of cars down. "Terry (Jackson) has saved us a lot of money on equipment for the cars by getting grants and our overtime is paid by a grant," Kirby told the council. "But, when you have a job to do, you

must have the funds to do it with," she added.

However, Mullins told the council that if the ordinance was passed, he didn't want to see the money just dumped in to the general fund. "I would like to have a general outline of what the tax would be used for by the next meeting," Mullins told Kirby.

When Kirby asked the council about a motion for the tax ordinance, Councilwoman Shelly Lewis made a motion to approve it, thereby taking the half percent tax to a full one percent. There was no response for some time and Mayor Kirby had started to say that the motion had died for lack of a second when Mullins spoke up, seconding the motion, saying "I made the motion to impose the original half percent eight years ago, I guess I can second this one."

Councilwoman Lonetta Daugherty voted no on the measure, saying that with the restaurant just imposed, she just felt it was too much. Councilwoman Sharon Saylor voted yes and Councilman Wayne Bullock abstained, Councilwoman Willie French was absent and the measure passed by a 3-1 majority.

Kirby complimented the council on their leadership and told them that the city would "be responsible and every extra dime would be spent wisely but, she said, "if we don't invest in the future we will have no future."

The current half percent rate brings in about \$320,000 for the city.

The budget ordinance adopted by the council during the meeting, shows total revenue expected of: \$1,315,798 in the general fund; \$102,790 in the municipal aid fund; \$27,334 in Local Government Economic Assistance; \$1 960 500 water fund: \$2,134,000 sewer fund and \$43,281 in the UDAG fund.

The second reading of a one and half percent county-wide occupational tax ordinance will be held by the Rockcastle Fiscal Court at a special called meeting on Thursday afternoon.

The meeting will be held on the third floor of the courthouse at 1 p.m.. Last week the court voted by a 4-2 margin to impose the tax on wage earners, which will generate an estimated \$1,245,000 annually.

**Hepatitis A Health Alert**

County. Since Kentucky is a bordering state and vacation season has begun, the Rockcastle County Health Department is recommending that non-immune persons who have been at the campgrounds since May 14, 2008, receive a hepatitis A vaccination

Hepatitis A is a virus which attacks the liver. Symptoms include nausea, vomiting, abdominal pain and discomfort, fever, loss of appetite and jaundice (yellowing of the skin and eyes). The illness can last several weeks. It is spread through the feces of infected persons or through contaminated food or water. Although the source, or sources, of these eight con-



Thacker wins Sportsmanship Award

# Track team finishes third in state

Another very successful season came to a close this past weekend at the Class 2A State Championships for the RCHS girls' track team. The girls recently finished as the Class 2A Region IV Champions for the fifth straight year and have won eight of the last nine regional championships. Going into state, the girls hoped to win their first ever outdoor state title and had been ranked #1 in Class 2A for the entire season.

Smith finished second to teammate, Morgan Thacker, who claimed her second state title in the event. Smith also did well in the triple jump on Saturday, finishing 5th overall.



The state meet got underway Friday afternoon with very hot, humid weather conditions. The girls competed in preliminaries of several events, with the only finals coming in the 3200meter relay and long jump.

RCHS senior Morgan Thacker and sophomore Samantha Smith were completely dominant in the long jump competition with quite possibly the greatest series of jumps between two teammates ever in state competition. It's a rarity at the state level to have two athletes from the same school compete in a state event. Having two athletes perform at the national elite level in the same event is next to impossible. Both Morgan and Samantha easily made the finals in the event and went on to secure their place in state track meet history with incredible performances. Morgan won her second state championship title in the event with an unbelievable jump of 18'2.5". She recorded three 18' jumps on the afternoon, solidifying her national elite status that she earned with her 18'3" jump at regionals. Morgan missed the Class 2A state record in the event by a mere 1.5". Her best jump, had she hit the long jump take-off board, easily covered an amazing 19'. Samantha was very close behind, finishing as state runner-up in the event with an incredible new personal best leap of 17'6.5". Samantha posted several jumps above 17'. Her best effort was nearly a foot better than her previous best. She also earned national elite status for her awesome effort. Similar to Morgan, Samantha's best jump was easily 18' had she hit the take-off board a little better. Morgan will be an automatic first team all-state selection with her win, while Samantha will also make the all-state team in the event.

The first running event preliminary on Friday for RCHS came in the 100-meter hurdles. RCHS junior Sarah McKinney regarded by many as the best short hurdler in Class 2A, set her sights on making Saturday's finals. The top three in each of two heats, plus the next two fastest times overall qualified for the finals. Sarah ran a fast but somewhat conservative race, finishing a close 2nd in her heat with a time of 17.27 seconds, easily qualifying her for Saturday's finals. Next up for RCHS came Morgan Thacker in the 100meter dash preliminaries. Morgan ran a spectacular race in what turned out to be a loaded heat, finishing 6th in with a great time of 13.37 seconds. Although her time was actually 7th overall and better than all but one of the competitors in the first heat, Morgan did not make the finals in the event. This obviously flawed format for finals qualification is under review for next season so that the actual eight fastest competitors, regardless of heat, have the opportunity to make the finals.

McKinney, junior Katy Mattingly, and eighth grader Chelsea Payne ran a sensational qualifying race. The girls blazed their way to a time of 1:52.9, a season's best for this particular group. The girls entered Saturday's finals ranked 8th in the event.

The same four girls also ran in the 400-meter relay preliminaries which were immediately after the conclusion of the 800meter relay finals. With very little rest and the effects of the heat becoming apparent, the girls came through with another finals qualifying performance. They finished 3rd in their heat and 8th overall with a great time of 54.0 seconds.

Freshman Sara Hammond ran next in the 400-meter dash preliminaries. With a star studded field of competitors, the Class 2A Region IV champion in the event ran an easy qualifying race, finishing 2nd in her heat with a tremendous effort of 1:01.06. Her time ranked her 5th going into Saturday's finals.

Jessica Albright and Sarah McKinney competed in the 300-meter hurdles preliminaries on Friday. Both girls had the daunting possibility of competing in four events on both days of the competition. In the 300 hurdles, Jessica ran a superb race, qualifying for the state finals in 8th place overall with a great effort of 51.09 seconds. Sarah also ran a terrific race, finishing in 12th overall with a solid effort of 52.45 seconds.

In the 200-meter dash, Morgan Thacker and Samantha Smith hoped to make Saturday's finals. Morgan ran very well, finishing 7th overall with a finals qualifying time of 27.49 seconds. Samantha, this year's regional champion in the event, ran a great race as well, just missing finals qualification by two-hundredths of a second with a stellar effort of 27.52 seconds.

The final event of the day for RCHS came in the 1600-meter

son in the race and pulled away from the competition about midway through. She easily won her first state title in the event by over three tenths of a second, finishing in a blistering 15.93 seconds. Sarah will automatically make first team allstate in the event.



Only minutes before that record-breaking attempt, Samantha had established a new RCHS record in the event with a sensational effort of 35'2". She finished a close 5th overall with her new







personal best mark. Both girls will likely earn all-state awards for their impressive performances.

The 800-meter relay finals came next for RCHS. The team of freshman Jessica Albright, Sarah McKinney, junior Katy Mattingly, and 8th grader Chelsea Payne ran an awesome race and finished in 7th place overall. Their incredible effort of 1:53.44 earned the RCHS girls' team two points.

Next up came the 1600-meter run. Seventh grader Michaela Hunter, the defending state champion, and sophomore Laura Dollins came into the competition hoping to improve upon their impressive regional performances. Michaela got the race off to a great start and was the early frontrunner. After 800meters or so, she seemed overwhelmed by the heat and was forced to ease up. Laura kept up the torrid pace she began with and combined that with a strong finish. She placed an amazing 5th overall in a new personal best time of 5:40.46, over six seconds better than her previous best. Michaela finished 13th overall with a hard-fought effort of 5:55.18.

The 400-meter relay finals followed the 1600-meter run. The team of Jessica Albright, Sarah McKinney, Katy Mattingly, and Chelsea Payne ran a sensational race, finishing an impressive 8th overall with a time of 54.07 seconds.

Sara Hammond competed in the finals of the 400-meter dash. Despite being in a difficult outside lane for the race, Sara was certainly one of the favorites. After leading early on, Sara finished 6th overall with a great race. She was the top freshman performer with a time of 1:01.87. Sara also had a great performance in the high jump competition, an event she won at the regional championships. Immediately after the grueling 400, Sara had to complete her jumps. Despite this disadvantage, she leaped an impressive 4'10", finishing an impressive 9th overall.

Jessica Albright competed in the finals of the 300-meter hurdles, her seventh event in two days. One of the most versatile athletes in RCHS history, Jessica had a tremendous performance,

finishing 7th overall in an impressive 50.87 seconds and scoring two points in the event for RCHS.

Sophomore Laura Dollins continued her impressive state meet performance with an awesome race in the 800-meter run. Laura started out strong and held a great pace throughout the race. She finished 8th overall with a new personal best time of 2:29.62, the second fastest in the open 800 in RCHS history.

Up next for RCHS came the 200-meter dash state finals. Morgan finished her impressive state meet performance with another scoring effort in the 200meter dash. Morgan finished an awesome 7th overall with an exceptional effort of 27.55 seconds.

Michaela competed in the 3200-meter run, an event she won at the regional championships recently. One competitor was unable to finish due to heat exhaustion. Despite the unfavorable conditions, Michaela still managed a 13th place finish overall in 13:32.01.


With final team placement on the line, the RCHS girls' 1600-meter relay team looked to preserve a top-four team finish in the final event of the state competition. The team of Jessica Albright, Chelsea Payne, Samantha Smith, and Sara Hammond came through with a season's best performance, finishing in 4th place overall with an unbelievable time of 4:15.45.

The RCHS girls finished 3rd overall with 58 total points. Highlands, with twelve senior girls leading the way, won the team state title with an impressive 95 points, while eight-time defending champion Paducah Tilghman finished as runner-up with 71. RCHS had a great meet despite losing at least 45 points that they could have scored throughout the course of the competition. This marked the third straight top three state meet finish for the RCHS girls' team and the seventh top four finish at state in the last eight seasons. A remarkable accomplishment for a very talented, hard- working team that should be a strong contender next season as well.

RCHS senior Morgan Thacker ended her career on an even more special note. She was named the 2008 Class 2A Female Sportsmanship award winner. The award is given annually to the female athlete that exhibits good sportsmanship at

the state meet and throughout the season, along with her career. Morgan has exemplified those characteristics and has represented RCHS with nothing but class over the course of her

career. Her teammates and coaches wish her nothing but success as she prepares to enter college and begin another chapter in her brilliant track and field career.

to spend on landscaping. Cecil has gathered and laid the stone for several fountains, waterfalls, sidewalks, and a fire pit. He has laid mortar-free stone walls around the exterior landscape boundaries.

The Kings have planted the many perennials and some annuals, many of them transplants from other areas of the yard. Landscape cover consists of red mulch, black mulch, lava rock, Alabama pea gravel and chipped brick rock all strategically placed to highlight certain areas. Cecil has tiered off difference areas with landscape timbers and large stones.

Around the pool area and the house, Judy has planted some 600 annuals in pots, planters and hanging baskets with a bouquet of blooms everywhere. At the end of the pool, large circular brick flower beds contain perennials, spirals, mums, day lilies, and carnations for varied color.

Scattered throughout the landscape are life size statues and figurines of various wild animals. Other ornaments and features are placed throughout the areas.


The Kings also have two varieties of Florida palm trees, banana trees and elephant ear that must be kept indoors during the winter and transplanted in the spring. The banana trees and elephant ear continue to multiply and have been shared with many friends.

Judy says Cecil does most of the design and planting of the perennials, then the maintenance and trimming all becomes her job. The Kings have a passion for this and all the original ideas are interesting to see. This location is a must stop for those on the tour.

As a special bonus for the garden tour, Cecil plans to display some of his collection of antique cars in the yard for everyone to enjoy. Restoration and collection of old cars, mostly from the 50s, has been another hobby for Cecil since his retirement.

### "Pappy and Mammy's Place" has a lot of Rockcastle history

If you stop by Pappy and Mammys Place for a cup of freshly brewed coffee, some hot chocolate or delicious hot tea, you may also get a heaping helping of history.

Jones Conn Hiatt and his wife, Ramona, are nearing the end of a almost five-year remodeling and reconstruction project on Jones Conn's grandfather and grandmother, Jones A. and Maggie Hiatt's, house in Renfro Valley.

During that five years, they have found numerous historical items in the house, gathered information about many items they already knew were there and, also, on the property. The house is now listed on the National Historic Register.

"We had a lot of experts look at the house and the general consensus was to tear it down," said Jones Hiatt.

"But Ramona and I decided differently," he said.

"We're still not completely finished, but we are getting there," he added.

Built in 1819, the house is one of the oldest, if not the oldest. house in Rockcastle

County.

Abner Hiatt, who came to Rockcastle County to work in Saltpeter Cave making gunpowder before 1800, married Lucy Peasley in 1790 and obtained about 200 acres of land in the Renfro Valley area.

The farm covered much of what is now Lake Linville and was split up by Interstate 75.

Jones Conn and Ramona live in a house on the original farm, as does Jones' sister, Nancy Bradley and her husband, Coy. The Hiatts and Bradleys are the eighth generation of Hiatts to live on the farm.

The Pappy and Mammys house was built by Abner Hiatt for his son, Bennett Hiatt.

Only Hiatts have lived in the house since it was built nearly 200 years ago, but it was empty for about 40 years after the death of Jones A. Hiatt, Jones Conn's grandfather.

"When people come to the house they always share memories of their grandparents and growing up on a farm," said Ramona.

"The home-like surround-

ings keep people smiling and hanging around for hours - you hear a lot of funny stories," she added.

If you go to the house, you'll find a lot of interesting items, including a 1953 International Harvester tractor, which Pappy Hiatt owned and used on the farm, but never drove.

"He did a lot of farming, but his workers drove the tractor," Jones said.

There is a coal shed with coal in it from 60 years ago, bricks from the old Rockcastle County Courthouse, which was torn down in 1964, a wooden washing machine that still holds water, handmade quilts, cancelled checks and written receipts dating back to 1897. There are old wooden boxes that were used for shipping and an old rocking chair and many old books and history articles.

It was a monumental task to restore the kitchen where you'll now find freshly-baked items to go along with the fresh coffee, tea, hot chocolate and soft drinks.


The Hiatts had to shovel over 250 wheelbarrows of dirt from the floor before they could even start restoring the kitchen, which also has an old chest of drawers from the old Rockcastle Hotel in Mt. Vernon.


Steve and Sherrie moved into their new house about three years ago. One of their first goals was to enhance their yard, which as you can see, was beautifully mastered.






