Several road construction projects underway in county. . .

The new Hwy. 150 construction project has reached its destination at the junction of Hwy. 461 and Hwy. 150 above. According to the Kentucky Department of Transportation, 60-65% of the project is complete, with the most complete section from the county line to Hwy. 70 only needing guardrails installed. The contractor, L&M Asphalt of Lexington, says they are on schedule, with heavy work being done on the diversion shown above. Motorists will take the diversion to the right while the rest of the rock is cut away for the new road. Below, if you are a resident of the Wildie area, construction began on your main thoroughfare, Hwy. 1786, Tuesday. The Department of Transportation is taking off the existing replacement beams on the bridge, and will be replacing them with permanent ones. The road will be closed, except for local traffic, for up to 30 days.

The court also opened the three bids for various size culverts needed by the road department. Benge Farm Supply of London was the successful bidder.

Elmo Greer and Sons was the successful low bidder for surface blacktop with a fixed price of \$63.75 a ton, just below K&K's bid of \$64 per ton. The court accepted the fixed price instead of the lower index price of \$62.75 a ton since that price can fluctuate with the market price of oil.

The court also directed County Attorney Billy Reynolds to write a letter to former County Clerk Norma Houk asking that she remit her excess fees for 2010. County Judge/Executive Buzz Carloftis told the court that state law mandated that excess fees be paid by March 15th each

Reynolds complied, even to dictating the letter to his secretary, but it turned out to be for naught since the court learned after the meeting that Houk had taken a check for just over \$40,000 to the accounting office of County Treasurer Joe Clontz in payment of her excess fees for 2010.

The court also heard a report from RCIDA Executive Director Holly Hopkins who told the court that the company would know September 1st if the National Oceanic Atmospheric Ad-

Mt. Vernon receives new ISO rating

Residents in the city of Mt. Vernon should see lower insurance premiums come September 1st. Mt. Vernon Mayor Mike Bryant received word at the end of May that the city had improved their Structural Fire Suppression Delivery System Rating, or Public Protection Classification Program (PPC) from a Class 6 to a Class 5, which will result in the lower insurance premiums.

ISO is a company that provides insurance companies with information about a city's abilty to suppress structural fires and then the insurance companies use the PPC information as part of their decision-making when deciding what business to write, coverages to offer or prices to charge for personal or commercial property insurance.

PPC is important to communities and fire departments because those communities whose PPC improves may get lower insurance prices. PPC also provides fire departments with a valuable benchmark, and is used by many departments as a valuable tool when planning, budgeting and justifying fire protection improvements.

She had no enemies, only


those that loved her. I know I loved her very much and always will.



The "Uncola" Returns

Only a few days ago, I was casually strolling down the aisle at the local Kroger store to pick up a few items for the weekend when I noticed a display that caught my attention. I could hardly believe my eyes. The sign above the stack of familiar green glass bottles said, "Try the latest soft drink -7Up Retro!" Small print on the display declared, "This 2011 formulation uses sugar rather than high-fructose corn syrup as its sweetener and contains no caffeine. This product is available only in test markets." I quickly grabbed a few cartons before heading home. Then I got to thinking about the fact that it was being test-marketed, so I went back and bought several

7-Up was (and remains) my favorite soft drink. I was a very young boy living with my mother (Bee) and grandparents (Pop and Mommie Katie) in Rockcastle County when I became a fan. It was the "Fresh Up" drink of the 50's. When I was about 5 or 6 years old, I came down with a very bad case of a stomach bug that was accompanied with a high fever. Bee used her usual methods of treating such a condition, but when my fever did not subside, she called Dr. George Griffith.

That afternoon, Dr. Griffith made a house call after his regular office hours. He found me lying on the couch and gave me a thorough examination, followed by a "shot" in my behind. Bee had told the doctor that I was unable to keep anything on my stomach, and he instructed her to "Get some 7 Up and let David Joe drink as much as he wants. It will help to settle his stomach and will not hurt him in any way." Now that was the kind of medicine that any young boy wants to receive!

Bee did as the doctor suggested and allowed me to drink 7 Up's almost constantly for the next few days. I did not become nauseated anymore after beginning my regimen of the soft drink. I continued to be a fan of the 7 Up brand of soft drinks. I still am!

The history of 7 Up is very interesting. C. L. Grigg spent two years testing over 11 different formulas in search of a soft drink that was refreshing enough to prove irresistible to the people of Missouri and the world at large. In 1929, his bubbliest drink was born. The public quickly developed a taste for Grigg's caramel-colored, lemon-lime soda. However, the original name was not quite as popular as the drink itself - it was called Bib-Label Lithiated Lemon-Lime Soda (what a mouthful - pun intended).

Shortly thereafter the name was permanently changed to 7 Up. Can you imagine asking some store clerk where the Bi-Label Lithiated Lemon-Lime Soda is lo-

The pop (as we called it)

began to sell and to sell well. The original ad copy explained, "7 Up is a glorified drink in bottles only. It has seven natural flavors blended into a savory, flavory drink with a real wallop." By the late 1940s, the 7 Up brand had become the third best-selling soft drink in the world. In 1967, the company decided to separate its popular drink by declaring it the UNCOLA. That name caught on and has remained popular with 7 Up aficionados. The latest advertising slogan for the drink is: "America is turning 7 Up!" The company was purchased by the Dr. Pepper Snapple Group in

have no idea how this company is making money.





myself reading history because fact is often as entertaining as fiction. Let me share with you a couple of recent reads that I found difficult to lay down.

"Harrry S. Truman" by Margret Truman. Truman is, by far, my favorite president since Lincoln. I've read several other works. some critical and some worshipful, but this one is written by his daughter and only child. It is essentially an account of his political career and it is documented with a thousand or more pieces of correspondence that President Truman wrote to both national and world leaders as well as to members of his family. I already knew a lot of the political stuff but what makes this book so wonderful is the account of his absolute love and devotion to his family. You don't even have to have an interest in politics to enjoy this amazing biography which was a Number 1 National Best Seller when it was published in the mid 1970's. Stillness

Appomattox" by Bruce Catton. I also have a strong interest in the Civil War but the historical accounts are often so contradictory that it's difficult to know who to believe. I don't pretend to be a scholar of this horror, but this account of the last year of that terrible war is easily the best documented, best written and most believable piece I've yet to read. It focuses more on the Union Army and its lack of leadership and maintains that war would not have lasted nearly as long had there been more than three or four generals who had an inkling about waging war. But what makes this book such as easy read is the writer's style. What makes it so interesting is the incredible level of detail. It made me cringe every other page or so but I still found it difficult to lay down because of the emotions it aroused. The book is 438 pages, the last 64 of which are source documentation. It won the Pulitzer Prize for History in 1954. Read it and you will

know why. As I said before, if you want to take a break from fiction and get into facts--if you have the slightest interest in history---head to the library and check these two out or down them to your Kindle for nearly noth-



losis, and he died in Arizona, leaving a wife and two children. Lauviece was pregnant with Ann, so therefore, she never had the chance to meet her father. A church where they lived helped the family get back to Kentucky and back to their home where they could bury Ernest. It was a long and sad trip for the family. It took about four to five days by train. The casket was carried in the baggage car.

Some time later, Lauviece married Sam Roberts, and they had a small farm. They settled down in the county, in the area of Brodhead known as Chestnut Grove. It was located about three miles down a road near the current nursing home.

Ann grew up on that farm where life was much as it was for many in rural America: simple and uneventful, except for hard work, school, and the occasional trip to town. There wasn't much in the way of entertainment, except for church on Sunday. There has been generations, some of which are still living, who loved those days and would give all they have to return to them. These were the days of the Great Depression, and those days produced children that had what it took to survive. I heard a sermon this past weekend, and to use a quote from it gives a lot of insight to the times in which we're living: "The weakest generation is about to face the toughest time ever known to man." Ann went to school at

Ann went to school at Brodhead until she was sixteen, and a junior in high school. She had met a local boy there, Cecil Hampton, and they married fifty-eight years ago today, June 13. He had a job in Cincinnati at the Fox Paper Company. They soon moved there, where they lived for about fifty years. Jobs were scarce in the area, much as they are today, and many of the county's young people had to leave the area to find a

good-paying jobs. Ann finished school, and even took classes at the University of Cincinnati. Soon she was a real estate agent, selling property all over the area. If something didn't sell right away, Cecil would buy it and use it for rental property. I guess you could say that he was one of her best customers.

Now those days in Cin-

cinnati are only a memory, as the Hamptons have returned to their roots here in Rockcastle, where the shadows of their youth are plentiful, life is a little less stressful, and they are busy making new memories.





Protecting your family from the summer sun

Now that summer is quickly approach ing and days are getting hotter, it is important to protect our families from the sun. Sun exposure is important. It helps plants and flowers grow, and it helps us too! The sun actually provides us with vitamin D, which helps build stronger bones. It does not take a lot of time in the sun to get the needed amount of vitamin D.

If we do not protect our skin from the sun, we may get a sunburn.

Unprotected sun expo-

sure can lead to:

•Skin damage (sunburn)

•Eye damage

Skin cancer

If you have ever had a sunburn, you may remember it being itchy or even painful. Certain skin types tend to get sunburn easier than others. If you or someone in your family has light colored skin, eyes, or hair, it is more likely that a sunburn may occur to that per-

The sun's rays are stronger during certain parts of the day. The sun is the highest overhead and therefore the strongest from 10 a.m. to 4 p.m. During these times, extra care should be taken to prevent sunburn. However, most sun damage comes from day-to-day exposure, not being out in the sun at the beach, pool, or lake. Remember that you and your family could still get a sunburn when the day is cool or cloudy!

Wearing sunscreen

You may notice there are many sunscreens made for kids. Some have scents, some have colors, some spray on, and some are water and sweat proof. These are great if your child does not have sensitive skin. However, what matters

most is the amount of protection again the sun's rays that the sunscreen provides.

When choosing a sunscreen make sure to get a SPF or Sun Protection Factor of 30 or higher for children. Choose a "broad-spectrum" sunscreen that protects against two types of the sun's rays — UVA and

To get all of the benefits, sunscreen must be used cor-•Use sunscreen when-

ever you and your family will be out in the sun. •Put the sunscreen on at

least 15 to 30 min utes before going out. •Put sunscreen on any uncovered skin. Do not forget the hands, ears, feet,

•Reapply sunscreen about every 2 hours or after swimming or sweating.

Take a break

Remember, the sun is strongest from 10 a.m. to 4 p.m. It is important to protect you and your family from the sun's rays during this time. Tak ing a break from the sun is a good way to protect the skin. Go inside for lunch or a nap. You may also choose to do some indoor activities. If you are at an all-day outdoor activity, make sure to sit in the shade to get a break from the sun. If your family has a big umbrella or a tent that can give shade, bring it along.

Proper clothing shields the skin from the rays. Even though you may not be outside all day, wear light colored long pants and shirts if pos sible. Sunglasses are important for protecting the eyes from the sun. For more information on protecting your skin this summer, call the Extension Office at 256-



Free GED testing ends June 30th

Free GED testing in Kentucky will end June 30, but prospective GED test-takers still have time to prepare for and pass the test. Kentuckians taking the test before June 30 will not have to pay the usual \$55 fee, which is being paid by Kentucky Adult Education, a unit of Council Postsecondary Education. Free GED classes are

available through local adult education programs in all 120 Kentucky counties. To be eligible to take the GED, students must first successfully complete the GED Official Practice Test to make sure they are prepared for the actual test. In 10 years, 105,848 Kentuckians have earned a GED, ranking Kentucky 13th highest in the nation in the percentage of non-high school completers earning a GED.


On July 1, the test fee will increase to \$60 for the full five-part test. The new fee leaves Kentucky well below the \$75 national average GED test fee. Official GED test centers receive no state or federal funding. Test centers must operate on the test fees and contributions from their contracting entity - primarily boards of education and community colleges.

The GED tests provide adults who did not finish high school with the opportunity to certify their attainment of high school-level academic knowledge and skills. The GED consists of five parts - reading, writing, mathematics, science and social studies. Completing the entire test battery takes just over seven hours.

The GED tests are currently offered only in a paper-pencil format at official GED Testing Centers - the tests cannot be taken online. State GED administrators often receive reports from adults who have spent time and precious resources pursuing what they believe are accredited high school equivalency credentials online. Consumers find, after spending \$200-\$1,200, that these dubious credentials are not accepted by either employers, colleges or universities.

ministration (NOAA) jobs would be returning to SourceCorp. Hopkins said that the 93 employees who had been furloughed would be returning at that time if a final budget, for April 1, 2011 through March 31, 2012, was approved by Congress and if there were funding put into the budget by the House of Representatives. is presently \$4,000,000 in funding for NOAA in the President's budget but the funding by the House is necessary to fund the program for the remaining six months of the 2011-12 budget.

Hopkins also told the court that SourceCorp was expected to be able to hire an additional 90 employees because of a new contract from a merger of SourceCorp and HVO, which is awaiting federal approval, and seven new employees had already been hired because of another contract acquired by SourceCorp. All in all, there a possibility that

SourceCorp could have around 200 employees by September 1st. Meanwhile, SourceCorp will fulfill their contractual obligation to pay the county occupational tax, beginning August 1st, for 200 employees, Hopkins

As part of the program support for RCIDA, an additional \$100,000 will be paid on the SourceCorp construction loan to Community Trust Bank. SourceCorp presently pays \$25,000 a month as a lease fee and this money is applied by RCIDA directly to the loan. The additional \$100,000 pledged by the court from occupational tax money will allow the principal of the loan to be reduced so that when the seven year contract is up with SourceCorp, the principal owed will be of manageable proportion in case the county has to assume the balance.

Hopkins also told the court that there had been some interest shown in the former Plasticware building and that the contract with Fender/Siemens had been completed.

The company will construct a building on the acre of land they have purchased and will hire five employees initially to repair turbine en-

RCIDA has joined Blue Grass South, a consortium of 10 counties, which allows Rockcastle better access to site selectors who help companies find sites and allows

the counties to pool resources such as labor pools, etc, Hopkins also reported.

County Attorney Billy Reynolds told the court that he will file for an interlocutory judgement in the Lambert Road condemnation suits. The judgement, if granted, will allow work to begin on the road while two cross claims are being adju-

A motion by Magistrate Lee Earl Adams to accept the part of Chestnut Grove Road which is in the Brodhead city limits into the county road aid program died for lack of a second.

As one of their final items of business, the court approved the transfer of \$125,000 from the occupational tax fund to the general fund to pay the \$100,000 on the principal for the SourceCorp construction

loan at Community Trust Bank and \$50,000 from the occupational tax fund to the jail fund for payroll and some current expenses. The jail transfer is contingent on the monthly check from the state being received before the funds are needed. To date, the general fund has transferred \$446,000 to the jail for the 2010-11 fiscal year. The jail's bills for June totaled \$91,530 and a portion of the transfer will be used to pay the most pressing debts.

The court will meet in special session Thursday (today) at 1 p.m. to hear a report from the three civilian commissioners appointed to redistrict the five magisterial districts, in order to bring the population represented more in line in each district. The action is required following

Hammond enrolled at the University of Louisville on Monday, began classes on Tuesday, has played in two exhibition games with the All-Stars and was honored as the female athlete of the year statewide on Wednesday.

Sara was honored as the female 2011 Dr. Rudy J. Ellis Sports Medicine Center High School Athletes of the Year during the Kentucky Athletic Hall of Fame 2011 Induction Banquet on Wednesday evening, June 8, 2011 at the Crowne Plaza Louisville.

"It's been a busy week for sure," Hammond said. "But it's been great. I'm having so much fun with (the All-Stars) and at school."

Hammond said she's had a lot of her high school

friends calling and texting her asking about what college life is like.

"It's a lot different from high school," she said. "I am an adult now and I have the freedom to do what I want to do. It's going to be a big adjustment but I'm lucky to have the coaches and my teammates there to help me through it."

Hammond set a new standard for girls' high school basketball players in the state of Kentucky with some elite honors. The Rockcastle County star was not only named Miss Basketball but she was ranked in the top 20 nationally and became the first female basketball player ever from the Bluegrass State to play in the prestigious McDonald's All-American game.

The 6-foot-2 Hammond was a two-time, first-team All-State pick and helped lead Rockcastle County to the school's first-ever girls' Sweet 16 title. Playing for the Rockets, she averaged 16.3 points, 12.4 rebounds, 3.9 blocked shots, 2.2 assists and 1.6 steals per game. Hammond also won the state's Gatorade Player of the Year award and the Associated Press Player of the Year Award. She was named as a third-team All-American by USA Today and in the McDonald's game with five blocks – the third most in history. ESPN's HoopGurlz ranks the University of Louisville signee No. 12 in the Class of 2011 nationally, which is the highest national ranking for any player statewide for more than a decade.

Hammond averaged 10.5 points and 8.2 rebounds a game as a sophomore and 15 points and 10.8

rebounds as a junior. During her high school career, Hammond finished with 2,121 points, 1,584 rebounds and 523 blocked shots. The rebound total ranks her No. 9 all-time in state history while the blocks total ranks No. 4.

Hammond also ran track during her early days, givyears of running because of AAU basketball. She placed at several state meets, including winning the 1,600 relay Class AA state championship team as a sixth
