Reapportionment report given to court by commissioners

The three civilian commissioners, appointed by the fiscal court to reapportion the five magisterial districts in the county, made a report at Thursday's special meeting of the court.

Appointed were Dr. Mike Hamilton, Larry Doyle and David Owens with County Clerk Danetta Allen also serving on the commission. Dr. Hamilton served as spokesman for the

group and told the court that the group's recommendation had been made with an eye toward the most minimal changes, including the least precinct changes, and of meeting the 10% variance allowed by law between the most populated and the least populated precincts.

PVA submits assessment to court for 2011

PVA Margaret Offutt's Summary of Real Property Tax Roll Changes for the 2011 taxable assessment was presented to the court at a special meeting of the fiscal court last Thursday.

The report shows a total of \$223,435,082 valuation for residential - lots, land and improvements. the valuatin for farm - land and other improvements totals \$77,088,550 and a valuation of \$63,485,164 for commerical, industrial, telecommunication and leasehold interests. The figures make up a total real estate

valuation of \$364,008,906. There are a total of 145 homestead exemptions and 593 with disability exemptions in the county for a to-

Arrest made in theft charge

A Mt. Vernon man was arrested Thursday following the theft of a wallet from the trunk of a vehicle parked at B&L Grocery on KY 70 last Tuesday.

Donnie L. Lunsford, 35, was arrested following an investigation by State Trooper Lloyd Cochran who was able to get a positive identification from the store's video.

Lunsford was charged with theft by unlawful taking and theft of identity and lodged in the Rockcastle County Detention Center. water plant, effectively slowing the pumping capacity to nearly every water district in the county except Livingston.

Mayor Bryant sent a letter to all city employees stating that as of June 1, Jill Medley, City Project Manager, had also assumed the duties of Administrative Assistant to the Mayor. Chad Mahaffey, 34, was released just after midnight last Thursday when a jail employee apparently mistook him for another inmate with a similar name who was scheduled to be released.



Reynolds gives court road update


At last Friday's special meeting of the Rockcastle County Fiscal Court, County Attorney Billy Reynolds presented an update of the condemnation proceedings on Lambert Road in northern Rockcastle County.

Reynolds told the court that \$7,300 would be their liability for compensation for land taken to widen the road. This is in addition to the \$9,000 total the court had to pay



Remembering Independence Day

The Fourth of July has been one of my favorite holidays since I was a young boy. For as long as I can remember, getting to set off fireworks has been one of my favorite forms of entertainment. I even recall saving my money so that if my family ventured into another state that allowed the sale of fireworks, I could purchase a big bag to store in my ammunition box that I hid under my bed.

In those early years, my mother (Bee) and dad (Hobe) occasionally took trips to the Smokey Mountains and that gave me the opportunity to pick up some firecrackers and Roman candles to put in my stash. I distinctly remember telling Daddy to stop at the first roadside fireworks stand. Bee always made sure that I was careful not to purchase something that was overly dangerous when I was deciding exactly what to buy.

One of my earliest memories of attending a large fireworks display occurred when my favorite uncle, Charles Brown, invited me to go with his family to see the Kiwanis Fireworks Show, which at the time was held at Stoll Field on the campus of the University of Kentucky. I had never been to anything like this before, and for approximately two hours I was completely spellbound by the fabulous display of exploding rockets above the football field. I can remember him recounting to Bee that I said, "Look at that one!" after almost every explosion. Now that I am thinking of that night, I suppose it was one of the reasons that I always loved fire-

Another memory of mine involving fireworks is when a great friend of our at my discretion. I saved them off in my grandfather's (Pop) front yard in the evenings when it got really dark. People in the neighborhood would tell us that they had seen the show for days after it was over.

When I became a teenager and was able to drive, I always had a date and attended some fireworks display either at the Valley Drive In Theater or some other place that held demonstrations. my two sons shared my fondness for pyrotechnic explosions. Each summer we gathered on Independence weekend and fired off our rockets into the sky. We also made it an occasion to barbecue that night just before the rocket display. Both Andy and Todd loved the experience, and the look on their faces made it all worth while. Every time I traveled to a state that allowed the sale of fireworks, I purchased enough for the coming July. I still have a sack of Todd's fireworks in one of my closets. I simply cannot make myself toss them

I spent the summer of 1967 on campus at Pikeville College working a full time job that mostly involved painting dormitory rooms to help pay tuition. My roommate was a fellow from a hollow near Betsy Layne Kentucky and he was, if such is possible, more of a hillbilly than I was.

Walt Fraser had grown us, as had I, in a home without indoor plumbing, his father was a disabled coal miner, as was mine and his family depended on its food supply from a few hill side acres of vegetables, a small orchard, hogs, chickens and the occasional slaughtered steer. The lifestyles of our youth mirrored another's.

Walt also had a relative in Pikeville who allowed him to park an old, rusted '49 Ford pickup. When he got homesick for Betsy Layne, he could simply hop in the truck and drive, 15 crooked miles and go home for supper a couple times a week and of course on weekends. However it was over 70 miles from the head of Blair Branch to Pikeville so I did not enjoy that luxury. So I started going home with Walt for a home cooked meal now and then and discovered that, like my own family, his dad owned a good work horse and a temperamental mule.

In short order, Walt and I began plowing garden spots for his neighbors. I would use the big mare horse whose name was, Mert to go from garden to garden and break ground with a bull-tongue plow that Mer pulled along in a box sled.

Walt followed on a riding harrow another plow loaded atop the harrow. The mule named Jack, would mind every word Walt told him but he would only pin his ears back and switch his tail when I tried to use him. Walt harrowed up the soil and laid it off in straight furrows while I plowed up the next garden.

We could easily get at least 4 times as much work



done by teaming up than Walt could have managed by himself and we could make more money on any given Saturday than we could all week painting dorm rooms. We even worked on Sundays for folks who would allow us to break the Sabbath. We paid Mr. Fraser a generous cut for buying feed and tending to the nags and we could still clear \$40 to \$60 each on any given week-end. Good money for two hillbillies in 1967.

So late one Saturday toward the end of July, we had spent all day plowing fall gardens. I was headed back up the road with the plow in the sled and Old Mert was

ambling along but we stopped to wait as Walt finished up the last little garden which was surrounded by a 5 foot split paling fence. Suddenly I saw a long, fat black snake sneaking along the fence row. I knew that Walt was deathly scared of snakes, so I grabbed the snake by the tail and in a single motion heaved it toward Walt.

It landed smack dab in the middle of Jacks's back and I then discovered that the mule was as terrified of snakes as Walt. Jack gave a mighty jump, jerked the plow out of Walt's hands, tore across the garden and soared over the fence. The plow hung on the top rail of the fence but that did not stop Jack. A ten foot section of fence hit the road which only scared Jack more and up the holler he went with pieces of palings flying everywhere and Walt running behind him yelling WHOA, WHOA, WHOA!

Walt ran out of breath but Jack headed straight for the barn. I had never heard Walt utter a four letter word in our acquaintance but he cussed me until he ran out of breath. He would pause for a minute or two and start again and he let me know that my share of the day's work would be used to pay for the fence and new handles for his favorite plow which was as busted up as the fence.

He also let me know that my plowing career was over and that I was no longer welcome in Betsy Layne. In fact, he stayed sullen the rest of the summer and we spoke to one another only when we had too. I apologized over and over again but there was no forgiveness in Walt's heart when it came to snakes.

Walt used his summer plowing money to buy a little Corvair and when classes started up in late August, he moved out of the dorm and commuted to school from home. We rarely saw each other and rarely spoke when we did. He dropped out at the end of the first semester and I never saw him again. As far as I know, he's still plowing gardens.

The Mayor told the council that the staff changes are meant to enhance the day-to-day operations of city government. In the letter to employees, Bryant stated that these changes were not "meant to isolate the mayor from employees, nor to prevent reasonable contact with the mayor. Due to the heavy workload I have with multiple departments, it is necessary to have a structure and organization that are conducive to accomplishing our goals and serving the

citizens of our town."

Council members expressed concern that these changes had been made without their knowledge and wanted to be informed in the future of any personnel duty changes.

nel duty changes.

In other business, the council heard reports from their insurance carriers, Van Meter Insurance and Kentucky League of Cities, about the undervaluation of the city's property. It had come to the Mayor's attention several weeks ago that the city's properties were valued at only \$2,000,000 which he said seemed rather low to him. He contacted the representative from Van

Meter Insurance who then contacted the Kentucky League of Cities whose representative came down and did a new property value assessment for the city.

The results of the findings were that the city was underinsured on their properties by a whopping \$14 million dollars. Increasing the city's insurance from \$2 million to \$16 could not have happened at a better time due to last Saturday's lightning strike at the water plant. According to the Van Meter Insurance representative, if the city had not had the foresight to have their properties re-assessed, they would have been out approximately \$70,000 to replace the two pumps that were destroyed by the light-

The city also received a check from Kentucky League of Cities in the amount of \$1,154.30 for a 50/50 match for a safety grant

The city accepted a bid of \$1.9 million from Grants Excavating to begin work on the Rose Hill Water/ Sewer project and a low bid of \$62.50 a ton from Kay and Kay Construction for blacktop to repair and maintain city roads.

Police Chief Terry Jackson reported that his department had, in May, issued 46 citations; arrested 27 people; apprehended four DUIs; written 13 citations for traffic offenses; 3 speeding citations; made 20 arrests for other criminal charges; captured 4 wanted persons; investigated nine traffic accidents and opened 12 investigations and cleaned or closed six.

Fire Chief David Bales reported that the fire department had made 22 runs and used 52,000 gallons of water in May, including being paged to: five accidents with injury and possible entrapment; three investigations of controlled burns; six structure fires; two ve-

hicle fires; two fire alarm activations; one smoke investigation; one EMS Assist; one set up of landing zone for helicopter and one mutual aid with Brodhead Fire Department for a farming accident.

state of emergency around 1 p.m. Saturday and the Health Department decided about 6:30 p.m. to shut down all the restaurants in the county, as well as car washes and laundromats, due to concerns over the safety of the water and also to conserve water. Although the businesses could have reopened about 2 1/2 hours after they closed, most had already sent their workers home and did not reopen until Sunday morning.

In a turn of good fortune, the city recently underwent a property value reassessment and raised their insured property value from two million to sixteen million. If the city had not completed this change before the lightning strike, their out-of-pockets costs to replace the two pumps could have been as high as \$70,000.

An insurance adjuster was in Mt. Vernon Tuesday to assess the damage and replacement parts have been ordered. Both pumps should be back in operation by next week.

the three land commissioners appointed to appraise the properties named in the condemnation suits.

Two cross-claims were filed to intervene in the condemnation suits, Reynolds said. These claims are by financial institutions who have an interest in two properties condemned and ask that they receive any money the property owners receive their easement. Reynolds said he would be before the court this Friday asking for interlocutory judgments which, if granted, will allow the county to proceed with repairs to the road.

The court plans to begin work on the road at the far end from U.S. 25 and, in October of 2010, took bids for that area. Carpenter's Custom Bulldozing of Orlando was the successful bidder for grade and drain work, shoulder repair, etc. at \$45,900. The bid was not awarded at that time since it was contingent on easements being obtained.

ance between the populations in the five districts with Bill McKinney's District #3 being the largest with 3,952 and Ralph Allen's the smallest with 2,592. The report's recommendation for reapportionment gives McKinney the smallest in population at 3,310 and Gary Burdette -District 4 - the largest with 3,480 (3693). Populations in other districts are: Lee Earl Adams with 3,447 (2888); William Denny, 3,393 (3931) and Ralph Allen 3,426.

Some of the major changes to the topography of the districts include McKinney no longer representing Brodhead which was put into Lee Earl Adams' district and Ralph Allen acquiring a larger part of Mt. Vernon and all of Livingston.

Hamilton told the court

that the commissioners had to use the official census figures for their reapportionment even though they knew there were errors in the figures such as one resident on Chestnut Ridge Road and several streets in Mt. Vernon with zero popu-

If the report is accepted by the fiscal court, and the general consensus seemed to be that it would be, the reapportionment will have to be sent to Frankfort by July 19th for approval. Once that approval is given, Allen will then have to meet with the election commissioners to see if any present precincts cross magisterial district lines and adjustments made there. There is a variance allowed between precincts but "it is a much bigger variance than the 10% allowed for magisterial dis-

tricts," Allen said.

Allen said once the precincts are established, that information will be sent to Frankfort for approval and then the whole process will be on hold until the state legislature makes any changes in district lines necessary. However, Allen said there would not be any precinct changes in place before this year's November General Election.

At some point, an ordinance will be drawn up, and published, by the commissioners and Allen detailing the boundary lines for each new magisterial district.



Local judges participate in HB 463 training

Wood and Jeffrey Scott Lawless who serve Rockcastle and Pulaski counties, participated in a District Judges Seminar on June 3 about how district judges are to handle pre-

Judges Kathryn G. trial release and bond determinations based on House Bill 463, which took effect June 8, 2011. The AOC offered the seminar in Frankfort for all district judges and trial commissioners and circuit judges

who share on-call rotations with district judges.

HB 463 is the most concentrated overhaul of Kentucky's penal code in more than 30 years and was supported by all three branches of government. The legislation is designed to curb the cost of incarceration without compromising public safety.

"House Bill 463 directly affects how district judges do their jobs, especially in the areas of pretrial release and bond," said Campbell County District Court Judge Karen A. Thomas, who also serves as president of the Kentucky District Judges Association, chair of the District Judges Education Committee and chief regional district judge for the Northern Region. "The seminar was helpful in preparing the judges for the significant changes that come with the new law. These changes require judges to set lower bonds and authorize substantial credit for days served in jail in lieu of requiring defendants to pay costs and fines."

The three-hour seminar

HB 463 and in-depth training on the tool that pretrial officers use to assess risk among pretrial defendants. Pretrial officers use the results of the risk assessment to help judges determine whether to grant pretrial release to defendants. The Administrative Office of the Courts operates the statewide pretrial services program.

Under HB 463, judges are required to consider the pretrial risk assessment when setting bonds and to grant pretrial release to low- and moderate-risk defendants, which are those who pose a low risk of flight, are likely to appear for trial and are not likely to be a danger to others. The legislation limits bond amounts for misdemeanor

offenses and mandates that defendants receive credit of \$100 per day toward bond and \$50 to \$100 a day in jail credit toward any fines owed except in certain circumstances. HB 463 calls for law enforcement officers to cite individuals for most misdemeanor offenses rather than arrest them.

High blood pressure and ways to treat it

Blood pressure is the force of blood through the body in arteries. High blood pressure often has no signs or symptoms. The only way to find out if you have high blood pressure is to be tested for it. Many Americans do not fully understand the value of the information held in these numbers.

Blood pressure is recorded as two numbers—the systolic pressure (as the heart beats) over the diastolic pressure (as the heart relaxes between beats). The systolic number is on top and the diastolic number is on the bottom. For example, normal blood pressure is written as 120/80 mmHg (millimeters of mercury) and expressed verbally as "120 over 80.''

ment of High Blood Pressure has classified blood pressure measurements into several categories:

"Normal" blood pressure – Systolic pressure less than 120 and diastolic pressure less than 80 mmHg

"Prehypertension" - Systolic pressure of 120 to 139 and/or diastolic pressure of 80 to 89 mmHg

Stage 1 Hypertension -Blood pressure greater than systolic pressure of 140 to 159 and/or diastolic pressure of 90 to 99 mmHg or greater

Stage 2 Hypertension -Systolic pressure of 160 or greater and/or diastolic pressure of 100 mmHg or greater

Most doctors will diagnose a person with high blood pressure based on two or more elevated readings that are taken on several occasions. A consistent blood pressure reading of 140/90 mmHg or higher is considered high blood pressure, another term for hyperten-

High blood pressure is dangerous because it makes the heart work too hard. It also makes the walls of the arter ies hard. High blood pressure increases the risk for heart disease and stroke. the first- and third-leading causes of death for Americans. High blood pressure can also cause other problems, such as heart failure, kidney disease, and blind-

Adopting healthy lifestyle habits is an effective first step in both preventing

and controlling high blood pressure. If lifestyle changes alone are not effective in keeping your pressure controlled, it may be necessary to add blood pressure medications. Your healthcare provider may prescribe more than one medication to get your blood pressure controlled. It is important that you take the medication as pre scribed and tell the provider of any and all other medica tions you may already take. Once high blood pressure develops, it usually lasts a lifetime. The good news is treatment can control high blood pressure.

Lifestyle changes can prevent and control high blood pressure. You can prevent and control high blood pressure by taking action. These include:

•Losing weight if overweight (losing even 10

pounds can help) •Increasing physical activity (walking 30 to 60 minutes each day)

•Following a healthy eating plan that emphasizes fruits, vegetables, and lowfat dairy foods

•Choosing and preparing foods with less salt and so-

•Stopping the use of to-

bacco products, especially smok ing cigarettes

•Limiting the use of alcoholic beverages.

Reduce your risk with physical activity. Regular physi cal activity can also reduce your risk of developing or dying from heart dis-

ease, diabetes, and colon cancer. Physical activity doesn't have to be difficult or take up too much time. A 10-minute walk once a day will put you on the path to better health.
