# **Voters give** emphatic No to sale of alcohol in Rockcastle

Rockcastle Countians voiced their opinion on the sale of alcoholic beverages in the county with a resounding "No" in Tuesday's special election.

42% of the total 11,529 registered voters in the county turned out -- 1,712 gave their approval to the measure while 3,108 voted no, a 65% to 35% ratio. Ironically, in last year's governor's race, only 25% of registered voters deemed the state-wide races important enough to go to the polls.

The measure lost in every one of the county's 14 precincts, coming the closest in the Bullock precinct where the measure lost 59-65.

Reportedly, about \$30,000 was spent on advertisements, mailers, yard signs, etc. was spent by anti forces and the campaign was obviously very effective.

David Sargent, pastor of Freedom Baptist Church and one of the leaders of the anti forces, said Wednesday, "Rockcastle Countians spoke loud and clear concerning alcohol sales on Tuesday. The majority showed they do not want the dangers alcohol sales would bring. We're all for economic development in Rockcastle but we understand that economic prosperity depends on a good work ethic, not selling alcohol. Our focus now shifts to eliminating the drug problem and bringing everyone together to make Rockcastle even greater than it is. I appreciate the efforts of everyone to keep Rockcastle dry and more secure."

The measure cannot be brought up again for three years when the very same procedure will have to be used. Steve

# Sunday accidents claim the lives of two people

Two people are dead and five injured as a result of two fatal crashes this past weekend in Mt. Vernon that happened within fourteen hours of each other.

In the first accident, a collision at the intersection of Hwy 461 and Hwy 150 around 2 a.m. Sunday claimed the life of a Wayne County college student.

According to State Police records, a 2003 Chevy


S-10 driven by Ronald Klein, 19, of Berea was traveling east on Hwy 150 when it struck a 2007 Chevy Cobalt driven by Dipesh Soma, 27, of Albany who was traveling south on Hwy 461.

Ashley Cross, 19, of Monticello, was in the passenger seat of the Cobalt and was ejected from the vehicle. Cross was pronounced dead at the scene by Rockcastle County

Coroner Bill Dowell. Jordan Hays, 24, of Berea, a passenger in the S-10, refused medical treat-

ment at the scene while Soma and Klein were both

One of the first things I did when I sat down at the computer Tuesday morning was go online and start reading all the news articles about UK winning the national championship.

I avoided all the predictable negative articles from other ignorant and jealous sports writers from around the country. Instead I focused on articles that portrayed the championship night and the celebration of it by the team and fans.

Darrius Miller, who played in the NIT his freshman year, is said to have admitted to reporters that during that time he thought he would never have the chance to play in the national title game. Now, as a senior, he has returned to Lexington as the only player to be named his state's Mr. Basketball and also be a part of a team who won a high school state championship, conference championship



Wing Vent Windows I am sure most of you can remember the cars of our vouth which had the smalltriangle vent windows in the corner of each front door. All three of the cars that I drove in high school and college had these wonderful air vents that allowed fresh air to circulate throughout the automobile when they were open. Those cars were: a 1954 Chevrolet Bel-Air, a 1958 Chevy, and a 1963 Chevy Impala Super Sport. Of course, those were the

Terrence Jones and Doron Lamb have both said that one of the main reasons they returned to Kentucky for their sophomore season was because they didn't want to leave until they won a national title. In my opinion, it's the

inner drive of players such as Miller, Jones and Lamb that creates a championship team. Talent alone can't get you a national championship and I think that was apparent to us with our highly talented but young 2009-2010 Kentucky Wildcats team.

Instead it takes talent, experience and heart to win a national championship. To me, no other team deserved a national title as much as the 2011-2012 Kentucky Wildcats did. Individually, they were all stars in their own right, but when they come together as a team they were unstoppable!

For me, personally, one of the most climatic moments at the end of the game came when Miller passed the trophy off to Jones who gazed at the trophy for a few seconds and then emotionally shouted "I'm never letting go of this." Jones may have not realized it at the time but as UK fans, we are never going to let go of it either! days when almost no cars had air conditioning, and the vents could be adjusted so cool air would be directed toward the driver or passengers.


As a child, I remember riding with my grandfather as he drove around the fivecounty area selling groceries for Louisville Grocery Company and Aubrey's Red A Feed in Louisville. At that time, we were driving his '54 Chevy and it did not have air conditioning. When it was extremely hot, Pop rolled the wings open so the air would blow directly on us, and I remember how it felt to have that fresh air rushing onto my face as we rode along on US25.

How many times did you hear someone say, "Open the vents!" They were also used, when only slightly opened, to allow stale air or cigarette smoke to exit the vehicle. In those days, most of us smoked, and that smoke went flying out through the vents as we drove along. (In the late '50s, a full 42 percent of the population were smokers. Today, that figure has dropped to only 20 percent).

The air blast from vented windows when they were wide open was usually sufficient, even on a warm summer day, to keep everyone cool even though we had no air-conditioning. I remember driving a few of my friends to Somerset to the swimming pool, and on our return, two of us had our swimming trunks hanging on the winged vents blowing in the wind. By the time we reached Mt. Vernon, our trunks were completely dry.

By opening the wings and opening the oval-shaped vents in the kick panels under the dashboard, the circulation of air in our cars was often enough to keep our cars pleasantly cool even in hot weather – if you were driving at a rapid rate of speed.

Girls loved these small windows because they could remain cool without having their hair-spray-coated locks blown into disarray. When the larger windows were rolled completely down, a girl's hair would go flying every-which-away - unless the wings were open. By the way, this was the main reason that girls carried scarves. Those scarves were worn to tie-down their hairdos from windy conditions whatever the source. Another cool thing about having vented windows was that they allowed us to use our trusty pocket knives to (Cont. to A4)



#### In search of Stiggal's Tavern location...

Dear Editor,

Marty Wyatt, a local resident at Brodhead is in search of the historic location of Stiggal's Tavern and is giving what information he has on it in hopes some local resident may remember something.

Brodhead began as Stiggal's Station in 1794 and became a safe house for early settlers coming along the Wilderness Trail headed to Louisville and Lexington.

George Stiggal was the owner and was a member of the Virginia Militia receiving property at Brodhead for his service. His wife was Ann Wilkerson Stiggal. Ann was the daughter of John Wilkerson. John Wilkerson was one of the original settlers at Boonesborough. Stiggal's Station became a grover's station where livestock was put up during the drives to market. It was also a Tavern where weary travelers stopped to sleep for the night and were fed also restocking themselves with basic essentials for their trip such as cornmeal, meat and other food items.

John Woodyard, born in 1801, came to Brodhead sometime between 1840 and 1850 and would be instrumental in developing Brodhead. He donated property in the 1870s for the first school at Brodhead. He also donated the property for Brodhead Baptist Church, giving 1.75 acres for the Masonic Lodge, church and a graveyard in 1872. He also donated the property for the Christian Church and graveyard on Main Street across from the Post Office. John Woodyard is buried behind the Christian Church.

In 1912, the Stiggal's Tavern was by a James "Jim" Owens Sr. according to a newspaper article of that

# **Rockcastle Early Childhood & Kindergarten** REGISTRATION & SCREENING

### **Program Options**

There are two programs in Rockcastle County that offer free early childhood education services to qualifying four year old children.



(Three year old children may be eligible with an identified disability.) The programs are: The Rockcastle County Public Preschool and Kentucky River Foothills Head Start.

### What to Bring for Registration

Please bring your child's state birth certificate, social security card, immunization certificate, proof of income and proof of medical coverage (i.e. medical card or insurance card) to register. Call your school with any questions and to make an appointment to register your child.

#### Health Requirements

The following health requirements must be met in order to enroll in the early childhood program and kindergarten.

- Physical exam
- Blood pressure and lead screening
- Dental exam
- Vision exam
- Immunizations

### Eligibility

To be eligible for **<u>Rockcastle County Public</u>** Preschool, your child must be 4 years old by October 1st and meet one of the following requirements:

- 1. Be eligible for Free Lunch
- 2. Have a disability
- 3. Three year olds may be eligible with an identified disability
- Non-qualifying four year olds may attend 4. the Early Childhood program as space allows

To be eligible for <u>Head Start</u>, your child must be 4 years old by October 1st and meet one of the following requirements:

- 1. Meet Federal Income Guidelines
- 2. Have a disability
- 3. Be eligible for Public Assistance (SSI, K-TAP, Child Care Subsidy)
- Meet guidelines for being considered a 4. homeless family
- 5. Reside in a foster home

#### What is a disability?

A delay in one or more of the following areas is considered a disability:

- 1. Speech and language
- 2. Large and fine motor
- 3. Cognitive skills
- Social and emotional 4.
- 5. Self-help skills

#### **Registration Dates**

Students will only be enrolled by verifying residence within a school's attendance zone.







Alcohol, or No Alcohol, That Is The Question..., Part II

The history of Prohibition (the national ban on the manufacture, sales, transportation, etc. of alcoholic beverages) was examined last week. To review, we had learned that originally it was intended to be only temporary due to the demand of grain going to the war effort (World War I) in 1917. The ban began in 1919. However, by this time the war had ended and Prohibition had become a moot point as far as I'm concerned. We also learned that in only ten short years of not receiving the revenue from the alcohol tax (among other factors), the Great Depression ravaged the United States. We also saw that when one group tries to enforce their idea of morals on others through countrywide laws, it results in failure, in the end. In 1933, only fourteen years after it began, the experiment ended in failure, and sales of alcohol became legal again in the United States, except in some areas where it was felt better to remain "dry", where some believed that they knew better than what had been learned nationally.

This week, I will look farther into the real beginnings of Prohibition. "In 1657, the General Court of Massachusetts made the sale of strong liquor...illegal." However, they stated that





"Drink itself was not looked upon as culpable, anymore than food deserved the blame for the sin of gluttony. Excess was a personal indiscretion."

In 1784 a popular physician, Benjamin Rush, wrote in "The Inquiry into the Effects of Ardent Spirits upon the Human Body and Mind" that "...the excessive use of alcohol was injurous to physical and psychological health ... " This led to a Temperance Association being formed in Connecticut in 1789, with Virginia to follow in 1800, and New York in 1808. Women in particular "jumped on the wagon" and embraced the idea of "true motherhood", electing themselves as "moral authorities". By 1835, the American Temperance Society had been formed, and reached 1.5 million in membership, of which up to 60% were female.

In 1873, the Women's Christian Temperance Union, led by Garrard County's own Carrie Nation, was formed and advocated Prohibition as a method of avoiding abuse from alcoholic husbands. One of its chief methods of achieving its goal was in education. They wanted to "get to the children" to create an sentiment that alcohol was evil. They wanted to organize a "union of women of all denominations for the purpose of educating the young, forming a better public sentiment...and removing the dram-shops from our streets by law." Here we have the vehicle of how alcohol became "evil" through the generations and saturated itself into religion. This was particularly enacted in the South. Will Rogers often joked, "The South is dry and will vote dry. This is, if everybody is sober enough to stagger to the polls."

Two other amendments to the Constitution were championed by the "drys" to help their cause. The Federal Income Tax replaced the alcohol sales tax that funded federal government. Prohibition has ended but the tax still remains.

John D. Rockefeller, Jr. was initially pro-Prohibition, but later had a change of mind, stating "...drinking has generally increased, the speakeasy has replaced the saloon; a vast army of lawbreakers have appeared, many of our best citizens have openly ignored Prohibition; respect for the law has been greatly lessened and crime has increased to a level never seen before."

At one time, prior to Prohibition, Rockcastle had its share of drinking establishments. Evidently, when Prohibition was repealed and counties were given the choice of being either "wet" or "dry", Rockcastle re-mained "dry". However, I've been told by reliable sources, for whatever reason, that there is a small area of Livingston that was exempt and remains "wet" to this day.(And yes, I've been told the exact location) During the Prohibition days, there was a man, a Mr. Goff, who ran a floating saloon on the Rockcastle River near Livingston. When neighboring Laurel and Rockcastle were "dry", he kept in business by staying on the river in order to avoid prosecution by either county. I understand the saloon thrived quite a while.

I've concluded my study into the history of alcohol and Prohibition in the U.S. and Rockcastle County. I've learned quite a bit, and hope you have, too. I do realize that this is a source of debate and it hasn't been my intent to anger anyone. .

In late May, 1975 I flew to Travis Air Force Base from Okinawa where I served for a year as a Hospital Corpsman with units of the Ninth Marine Regiment occasionally deploying to forward areas. There was a bus waiting for us near the plane and, as we boarded it, the driver warned us to keep all the windows closed until we were well away from Travis. As we left the base, a handful of demonstrators were gathered to welcome us home-they threw things at at our bus: rocks, bags of excrement and held up signs proclaiming us baby killers and murderers and shouted foul names. I was confused and saddened at the time. I am a Corpsman, I thought. My job is to save lives. In the field, I treated everyone—Marines, civilians, and even enemy troops without regard to who they were or what their beliefs were. If they were wounded, I believed it was my duty to help them. In April of 1975, I participated in Operation Baby Lift evacuating more than 3,000 orphans from Vietnam while the Viet Cong shelled Tan Son Nhut. About forty eight hours before I landed at Travis, I was in combat on Koh Tang Island involved in an intense 14 hour firefight to free the crew of an American merchant ship taken over by the Khmer Rouge. Through all those times, my only weapon was a .45 caliber pistol and I had never fired it except to protect myself or a patient. Much later in life, I met two people who were part of my life that April-May, though none of us knew it at the time. The first person's name was Kim. When I met her, she was a Lieutenant (junior grade) in the Navy who had grown up in Wisconsin, graduated from the U.S. Naval Academy in Annapolis, and was one of those orphans airlifted out of Saigon that April. Kim now works with the Wounded Warrior Project in Washington taking care of our troops who are suffering today from the horrible wounds that it seems only wars can inflict. The second person was a vehement anti-war protestor named Lori. She now works for the U.S. State Department as a diplomat and is extremely effective at her job. Lori and I disagreed on many issues but she was very bright and capable and I enjoyed working with her. I underestimated her when I first met her because she freely discussed demonstrating against "The War."



Meeting those two people reinforced in me two valuable life lessons.

First: People have convictions. They believe in them and their beliefs and convictions should be respected, whether or not we agree with them. The most profound and fundamental disagreements can be overcome if one has genuine respect of another person's beliefs.

Second: and perhaps more importantly, every life counts.

After arriving at the residence, officers knocked on the door and then heard banging and crashing coming from inside the home. Bryant then proceeded to kick the door before Hoover eventually opened it.

Once inside the house, officers noticed a strong chemical odor as well as visible smoke throughout the home. According to Bryant, the odor and smoke was indicative of an HCL gas generator, which can be used in the production of methamphetamine.

Bryant observed Tillery in the closet of the master bedroom, along with a coffee grinder on the floor with what appeared to still have pill residue in it. According to Bryant, coffee grinders are commonly used to grind up pseudoephedrine pills so they can be used to manufacture methamphetamine.

Inside the bathroom, officers found an active onestep meth lab, along with an active HCL gas generator with attached tubing coming out of the top of the cabinet. Officers also found a second HCL gas generator on the back porch of the residence.

Near the rear of the home, officers found two more active one-step meth labs inside a black plastic garbage bag.

Officers also found two small plastic bags containing suspected methamphetamine inside Hoover's change purse. Hoover and Tillery were

both charged with manufacturing methamphetamine and conspiracy to manufacture methamphetamine.

Both Hoover and Tillery remain lodged in the Rockcastle County Detention Center on a \$25,000 cash/property bond.

transported to the Rockcastle Regional Hospital. Klein was treated and released with minor injuries and Soma was transported to University of Kentucky Medical Center and, according to WLEX-18, is listed in serious condition.

The cause of the accident is still under investigation by the Kentucky State Police.

In the second accident, a seven-vehicle crash on I-75 northbound at exit 62 around 4 p.m. Sunday afternoon claimed the life of an Ohio man.

According to state police records, three tractor trailers and four cars all collided with each other as traffic was starting to slow down due to the heavy rain.

Keith Holbrook, 55, of Beaver Creek Ohio, was pronounced dead at the scene by Dowell. Holbrook's passenger, Teresa Holbrook, 55, also of Beaver Creek, Ohio, was airlifted to the UK Medical Center where she was treated and released with

minor injuries.

Roberta Butler, 76 and Mitch Butler, 75 both of Hamilton Ohio, were also airlifted to the UK Medical Center. Both were treated and released with minor injuries.

Heavy rain and wet roads were reported to be contributing factors in the collision. The accident is still under investigation by the Kentucky State Police and no drugs or alcohol are suspected at this time.

for the county, twenty-five 30 and 40 cubic yard roll-off dumpsters were required to carry off the trash that Rockcastle Countians dropped off during the seven hour event. Last year, 18 dumpsters were needed for the same event and the 20 dumpsters originally provided by Bee Garbage this year were not enough with the last loads having to be dumped on the ground until five additional containers could be brought in to finish the haul.

PRIDE (Personal Responsibility in a Desirable Environment) pays a portion of the cost of this event. However, this year their part was reduced from \$7,500 to \$4,750, bringing the county's share to an estimated \$8,000 as opposed to last year's less than \$2,000.

County Judge/Executive Buzz Carloftis said after the event, "participation in this event by the county is voluntary and I am glad for the participation and that the county had funds to support this program." Carloftis went on to say that this program is an example of why ever household in the county needs garbage pick-up service. "This is only a fraction of what the county, and of course taxpayers, have to pay to clean up illegal dumps in the county."

However, the county did save some money since a couple of entrepreneurs were on hand to take anything metal off the hands of participants, before it hit the trash heap, saving the cost of dumping those articles.

Taylor, owner of EST Tools and Machines in Brodhead and chairman of the Rockcastle County Industrial Authority, a proponent of the measure, said Wednesday that he was "really glad that the voters of Rockcastle County got to voice their opinion in this election. I would like to see this same enthusiasm put toward combating other problems our county faces, such as the methamphetamine problem."

Votes on similar issues were held in Berea, Pulaski and Laurel on Tuesday.

In Berea, the East Berea precinct went 2-to-1 to allow restaurant sales of mixed drinks, beer and wine. According to Teresa Scenters, publisher of *The Berea Citizen* the vote was allowed under a law passed by the state legislature and having to do with alcohol sales in precincts containing historic sites. The East Berea precinct contains historic Boone Tavern. However, Scenters said there will not be immediate drink sales at Boone Tavern since final approval rests with their board of trustees.

In a precinct vote in Pulaski County which contains Eagles Nest Country Club, the no vote narrowly won and, in London which is "moist" voters turned down a proposition which would have allowed package liquor sales in London.

Concerning the local election, County Judge/Executive Buzz Carloftis said Wednesday, "I think this was the first time, since 1939, that this issue has been brought up for a vote. The fiscal court, which represents everyone, remained neutral and never took a stand. I am surprised that the court was never approached by either side and personal preferences of individual members of the court were never voiced at a fiscal court meeting."




