

Brodhead man arrested for meth lab Thursday

rested last Thursday for manufacturing methamphetamine, after the Kentucky State Police made a traffic stop on Coffey Cemetery Road in Brodhead.

Arrested at the scene was Chaz M. Cable, 29, of Brodhead.

According to Deputy Sheriff Matt Bryant, officers from the Rockcastle County Sheriff's Department and Mt. Vernon Police Department were responding to a possible burglary on Chestnut Grove Road when they observed Cable pulling out of a location nearby.

Trooper Jason Vanhook, who was also responding to the burglary call, made a traffic stop after observing Cable turning around in the middle of the road without using turning signals.

Upon receiving consent to search the vehicle, officers found syringes in both compartments of the driverside and passenger-side doors. Officers observed that one of the syringes was loaded with a liquid and Cable told officers it was pain pills.

Inside the trunk, officers found a green duffle bag

Red Hill Horse Camp hosts 37th annual 100 mile ride

The Rockcastle County Saddle Club will hold their 37th Annual 100 Mile Horse Ride at the Red Hill Horse Camp in Livingston next week.

The 100 mile ride is a four day event that begins on Wednesday, June 13th and ends on Saturday, June 16th with all proceeds going to the Rockcastle County Saddle Club.

The Red Hill Horse Camp was founded by Livingston native Gene Philbeck, who has been an avid horse rider since he was a young child.

"All my life I have been involved with horses," Philbeck said. "No matter what kind of new hobbies I tried, I have

always come back to horse riding."

Philbeck said he saw the need for a horse camp here in Rockcastle County after having to travel miles away to other horse camps out of the county.

"I wanted to create a local camp for horse riders here in Rockcastle County." Philbeck said. "That way they wouldn't have to travel out of the county to go to a horse camp."

However, Philbeck said he never envisioned the horse camp growing into what it has become today.

"My original intent was to only have a place for our family, friends and local saddleclub to ride," Philbeck said. "Now the camp has grown to where the majority of our customers are actually from outside the county and state."

The horse camp consists of over one-hundred miles of horse trails that go through the Horselick Creek and the White Oak areas in the Red Hill Community.

The horse camp has fifty camper and tent hook-up sites with both water and electric available upon request. The camp also features showers, restrooms, horse stalls and a four person cabin to rent for those who choose not to bring a camper or tent.

The Red Hill Horse Camp holds four three-dayrides each year and is also open to group rides or single rides year round by reservation only.

With more horse riders coming to the camp, along with a high return rate of previous riders each year, Philbeck says he plans on

expanding the facilities at the camp in the near future. Philbeck is currently

building new horse stalls and also plans on building (Cont. to pg. 9)



I am occasionally reminded by a few of my readers, especially my brother Al, that there was good music before rock and roll appeared on the scene. Even though I usually concentrate on the music of the late 50's and 60's, I do remember lots of songs that my mother (Bee) and brother listened to in the late 40's. Bee was extremely fond of Perry Como, Frank Sinatra, and Bing Crosby. I can also remember Al listening to Al Jolson on the radio frequently.

The radio show Your Hit Parade is an American icon that was broadcast from 1935 to 1955, offering the most popular and bestselling songs of the week. Dozens of singers appeared on the radio program, including several that I actually remember – Dorothy Collins, Gisele MacKenzie, Johnny Mercer, Dinah Shore, and Barry Wood. They performed the top 15 songs that a survey selected from sheet music sales, phonograph records, the songs most heard on the air, and the most played songs on automatic coin Juke Boxes. The show proclaimed, "These songs are an accurate, authentic tabulation of America's taste in today's popular music.'

The radio show had a countdown (with fanfares) of the songs leading to the top three finalists, and a number one song as the week's finale. The program was sponsored by American Tobacco's Lucky Strike brand of cigarettes. The show was even called The Lucky Strike Hit Parade by many of the listeners; it aired each week on Saturday evening at 10 p.m. as a 60minute program.

My mother was a devoted listener to the popular radio show. I can still see her relaxing in her big, blue rocking chair as she listened to the weekly countdown.

The radio show became a television program on the NBC network in 1950. Bee was excited to be able to watch the singers perform the chart toppers rather than just listening to them. She loved the new television show so much that she made it a weekly "to-do" about it, creating a time for us to watch the show together. She purchased a ring-binder notebook in order to keep a weekly log of the songs performed each week. Before each show, she always prepared a snack that we could share during the program. Although I was very young at the time, I still remember those times that Bee and I spent together. But I also loved watching our new television set so much that I really didn't much care what show was being broadcast. The little, black and white, wooden television itself was spellbinding to me.

The TV show aired from 1950 until 1959. In 1953, it won a Peabody Award "for consistent good taste, technical perfection, and unerring choice of performers." In 1956 the show won an

Emmy for choreography, and in 1957 another Emmy for art direction. I am certain that Bee saw each one of these shows. And it's likely that I saw them as

On August 5, 1957, my dedication to Your Hit Parade changed suddenly and dramatically when Dick Clark's American Bandstand premiered on television. Each afternoon, Monday through Friday at 3 p.m., Dick played the week's most popular rock and roll songs while teenag-

The Roots of Rockcastle by: Tonya J. Cook

Rockcastle's Civil War Hospitals, Part II

In the last issue of the Roots series, the subject of Civil War hospitals was discussed. There were several major hospitals located within the state, but none here in the county, only field hospitals. The major hospitals were

located in the larger cities of Lexington, Louisville, Ashland, Bowling Green, Covington, and others. The hospitals were always located near railroads to allow for the transportation of the soldiers and supplies. However, smaller field

hospitals sprang up throughout the countryside of Kentucky and other states. Almost any structure was used; schools, churches, private residences, and public buildings served the wounded.

Probably the most-noted field hospital in Rockcastle was located at the Great Saltpetre Cave. The cave was discovered in 1798 by John Baker and has gone through several owners and served many purposes during the years.

cium nitrate, a chief component of gunpowder that was used not only in the War of 1812 but the Civil War, as

During the Civil War, there were miners of the calcium nitrate who are said to have lived on-site. Also onsite, there was the hospital that treated numbers of wounded soldiers in the area. There is said to be a small stream of water running through the cave that benefited its dwellers and the wounded at the hospital.

Another field hospital of the day was the private residence of a Dr. Cooper in Livingston. He was the first doctor in the Livingston

Before the War, Dr. Cooper had built a white, twostory clapboard-sided house just across the river in Livingston where he would tend the wounded from Camp Wildcat. The house changed owners over the years. One owner was Bill Moore, who sold it to Faye Hacker. Over the years, someone put red brick over





Travel safe and smart this summer Summer is upon us, and

for many, the season means at least one family vacation or weekend getaway. According to a 2011 TripAdvisor survey, 90 percent of Americans were planning to take two or more leisure trips within the next year and 24 percent were planning five or more trips. Of those surveyed, 79 percent said they plan to spend at least \$3,000 on these vacations. As you start planning your next vacation, you can take precautions to keep yourself, your family and your finances safe when you travel.

Whether you plan your own trip or use a travel agent, you should watch out for travel fraud. Ask friends and family for referrals when looking for a reputable travel agent. When working with an agent, always ask about the items that are not included in the travel package so you can plan for those extra expenses. Remember that companies or individuals that cold-contact you are often scam artists. If it sounds too good to be true, it probably is. Using your credit card to book a trip or pay for a travel package can allow you to dispute any

Travel insurance is not a requirement, but can protect you in the event that you need to cancel your trip or have any unforeseen expenses, such as medical problems or emergency evacuations, while vacationing. 





Bible Talk

This Sunday and every Sunday will be a time when Christians remember the one who died for them so long ago on Calvary: "And upon the first day of the week, when the disciples came together to break bread, Paul preached unto them, ready to depart on the morrow; and continued his speech until *midnight.*" Ac.20:7. This verse reveals the pattern of when the Lord's supper is to be done, upon the first day of the week. How often does the first day of the week come? Every week of course. In Luke 22:19, Jesus said "This do in remembrance of me" when he instituted the Lord's supper and demonstrated that his people should follow this example. The 2 emblems in the Lord's supper should bring to mind the tremendous sacrifice that Jesus made for our sins. As we eat the bread, we remember the body of Christ, which was given for us. And as we drink the cup, we remember the blood of the covenant, which was shed for the remission of our sins. There are 4 views in partaking of the Lord's supper:

Backward - As we partake of the Lord's supper, we look back to the death of Jesus on the cross of Calvary. All the suffering and pain he endured is brought to remembrance as we ponder the 2 emblems in the Lord's supper. Our minds should flood with the images that the gospel accounts describes of the arrest, the trials, the beatings, the vicious words and Jesus being nailed to the cross.

Inward - We are to look into our own hearts as we partake, so that we do it in a worthy manner. 1Cor.11:28, "Let a person examine himself, then, and so eat of the bread and drink of the cup." If we fail to look inwardly and partake in a worthy manner we are warned, "Whoever, therefore, eats the bread or drinks the cup of the Lord in an unworthy manner will be guilty concerning the body and blood of the Lord." 1Cor.11:27.

Outward - We also look outwardly in partaking of the Lord's supper. 1Cor.11:26, "For as often as ye eat this bread, and drink the cup, ye proclaim the Lord's death till he come." The flavor of this word "proclaim" is seen in the definition: "to announce, declare, promulgate, make known, to proclaim publicly, publish." Each Sunday when Christians partake of the Lord's supper, we are proclaiming to the world that a Savior has died for humanity.

Forward - We also look forward to the return of the Lord Jesus Christ. 1Cor.11:26, "For as often as ye eat this bread, and drink the cup, ye proclaim the Lord's death till he come." Christians will faithfully continue this memorial until the 2nd Coming of our Lord Jesus Christ. Whether the Lord's return is this month or 100 years from now, the faithful saints will continue to look for the coming of the Savior back to this world. The Lord's supper affirms our faith in this promise.

What a privilege it is to share in the body and blood of the Lord every first day of the week, in this wonderful memorial called the Lord's supper. Let us contemplate these 4 views that Paul speaks about in 1Cor.11 on his discussion of the proper observance of the Lord's supper.





Rockcastle County High School students Rebekah Ponder and Madisan Miller have been named 2012 Rogers Scholars and will be eligible to receive exclusive scholarship opportunities from 16 colleges and universities.







amount for occupational tax. In the contract between RCIDA and the company, SourceHOV agreed to pay the tax for 200 employees from August of last year, regardless of the number of employees they had.

Hopkins said she had been told, by court clerk Patricia Martin, that the company was fulfilling this obligation but Clontz held firm that they were not and Hopkins agreed to communicate with the company about the discrepancy.

Hopkins told the court that Anchor Packaging was "overjoyed" with the progress of the clean-up of the Plasticware building and that Anchor is in the process of getting the machinery up and running.

The executive director said that a grand opening, with tours of the facility, was tentatively scheduled for June 26th, in conjunction with state officials.

Over 500 applications have been received at the adult learning center for positions with Anchor, which has helped give the center a Star Facility designation because of the KEES testing that is being done for potential employees, Hopkins said.

Hopkins told the board that she was "super excited" about a marketing trip to Boston, Mass. June 11-15 which will give her a chance to meet with manufacturers, particularly in the auto and tool and die industry.

A ribbon-cutting ceremony is also being planned for Weltrans, Inc. which is in the process of completing their facility, getting signage installed, etc. No date has been set for the cer-

A transfer station at the industrial park on Hwy. 150 was also discussed with Hopkins telling the board tht it would be an "incredible selling point" for the park if an area could be developed for semis to load and unload materials from trains on the spur that runs through the park. The cost of the station was estimated at between \$100-\$150,000.

Vernon Water would have notified the public when the violation occurred and Brodhead Water Works had to also notify there customer also. This was a oversight, Mt. Vernon has made adjustments sending reports into DOW, so this matter will not happen again.






