# **Kevin Fletcher named Mt. Vernon Police Chief**

In a surprise move Monday night, the Mt. Vernon City Council approved the appointment by Mayor Mike Bryant of Patrolman Kevin Fletcher as Chief of Police.

Mayor Bryant told the council that he had arrived at his decision after much consideration and had origi-

nally planned to make the appointment at a later date. However, Bryant said that a request by a council member to make the appointment now had "accelerated" his action.

The appointment was not approved by the council without some intense discussion. Councilmember Jamie Bryant, when asked, told the mayor that she was "not happy about this again." Bryant went on to say, "If you want approval from the council then I need some prior notification of more than 20 minutes."

Bryant was referring to her dissatisfaction with the fact that a significant increase in water rates was introduced for passage at a

# Mt. Vernon pharmacist murdered last Thursday

A Mt. Vernon pharmacist was murdered last Thursday morning while jogging on US 127 near Jamestown in Russell County.

According to Kentucky State Police Reports, Sarah B. Hart, 31, of Jamestown went jogging with her sister around 5:30 last Thursday morning when Hart said she wasn't feeling well and stated she was going back to her car.

Once Hart's sister completed her jog, she returned to the car to check on Hart and called police after she could not find her.

After a prolonged search, crews later discovered Hart's

body about 11:15 am in a high weeded field off US 127.

Preliminary autopsy results from the Kentucky State Medical Examiner's office indicated that Hart was 10-11 weeks pregnant at the time of her death and died as a result of asphyxiation after being strangled.

State Police arrested Christopher W. Allman, 28, of Jamestown later the same day and charged him with Hart's murder. Authorities

have also said the death of Hart's unborn fetus could lead to additional charges against Allman once the final autopsy (Cont. to pg. 11)

### **Grand Jury** indicts nine

Nine persons were indicted recently by a Rockcastle County Grand Jury with most offenses centering around burglary and drug charges.

Indicted were:

Jeffery R. McLemore, 26, of 40 Hill St., Mt. Vernon, for Burglary, second degree and theft by unlawful taking over \$500 stemming from an incident at the home of Kathy Robinson in March of this year.

Bond for McLemore was set at \$75,000 cash/property. Daniel Blackburn, 41, of 1 Misty Lane, Mt. vernon, was indicted for burglary, second degree and theft by unlawful taking from a November 2011 incident at the home of Dillie Cottengim.

### Mt. Vernon man arrested for burglary

A Mt. Vernon man was arrested last Wednesday for burglary after breaking into the home of Doris Settles at 335 Woodland Place in Mt. Vernon.

Arrested was Joshua B. Baker, 28, of Mt. Vernon.

According to the Rockcastle County Sheriff's Department, the burglary occurred last Monday around noon while Settles was attending her brother's funeral.

However, it wasn't until last Tuesday morning that Settles discovered various items missing from her home, including her Capital One credit card and approximately \$4,000 worth of jewelry.

Last week, one of our very own pharmacists here in Rockcastle County was murdered while returning to her car after her morning

As the story developed over the weekend, it kept getting more upsetting as the autopsy showed that Sarah Hart was 10-11 weeks pregnant when she was strangled to death by her alleged attacker Chris Allman.

This really hit home for me and many others as well because even though Hart was from Russell County, it's like she was from Rockcastle County too.

When Ι describe Rockcastle County to people who have never been here, I always tell them we are a small tight-knit county similar to the town of Mayberry in the Andy Griffin Show.

When you work in any area of customer service in Rockcastle County, you see your co-workers and customers on a regular basis and become well acquainted with them as you go through the vears.

It was no different with Sarah as she had many coworkers and customers at Mt. Vernon Drug who cared for her and who are now grieving over her passing.


A lot of attention in the media is now focused on Allman, who is going through the court system and will be learning his fate within the next few months.

But my primary concern isn't the fate of Allman, instead it's with Hart's husband and three young children who now have to go on without their wife/mother as a result of this tragedy.

I can't imagine what those four are going through after losing Sarah along with her unborn child who they will never get to meet here on Earth.

My thoughts and prayers go out to the immediate family as they work to continue their lives without Sarah being a part of it.

The only piece of news that puts my heart at ease is when I was told by a friend



of Sarah's earlier this week that the family is at peace with the whole situation as they believe she is not actually dead because they know Sarah was a Born Again Christian.

It's things like this that gives people who have loved ones pass away, in these type of tragic situations, the strength to go on.


Now that Sarah has been laid to rest, discussion over Allman's fate is heating up more and more every day.

The capital punishment (death penalty) debate comes to a head every time someone is murdered and it is made known to the public through the media.

People who take a pro death penalty stance believe a murderer should be given a death sentence for the crimes they committed. People who are against the death penalty believe we should not justify someone's murder by killing the murderer who committed the crime.

Regardless of what happens to Allman, to me one thing is certain. The day will come when he will be judged by a power higher than any of us and have to answer for the crimes he has committed while here on Earth.

This is the ultimate retaliation. Even though Allman may escape what some believe is the appropriate punishment here on Earth, he won't be able to escape it in eternity.



American Jukeboxes -"Three plays for a quarter"

To many of us baby boomers, jukeboxes are pure Americana. Seeing and hearing them anywhere today always makes us feel less like old-timers and more like youngsters again. They give a cozy and comfortable ambiance regardless of where they might be found.

There were several restaurants and diners in Rockcastle County in the late 50's that had jukeboxes to entertain teenagers. Three plays for a quarter was inexpensive enough for most teens to amuse themselves while munching on burgers and fries. These were the good old days before boomboxes, iPods, and tape players. The jukebox allowed us to choose our own music and helped us to express who we were - teenagers who loved rock and roll.

When I first thought of writing about jukeboxes, I did some research to find out something about the history of these coin-operated music machines. What I discovered was very enlightening. First of all, the word "jook" is an old African-American term, meaning to dance; taverns with music machines were labeled as juke joints. And there was no doubt that juke joints were designed for dancing, with the jukebox providing the music.


Following the Depression, jukebox sales rose dramatically. Leading manu-Wurlitzer, facturers Seeburg, and Rock-Ola, devised spectacular creations of wood, metal, glass, and plastic to set the scene in the establishments for which they were intended. Some of the most impressive jukeboxes even had "bubble lights" to show off their de-

signs. The first restaurant that I can recall with a jukebox was the Ideal Café on Main Street in Mt. Vernon (an establishment once owned by my mother and father). Even though I was very young at the time, but I remember my brother Al telling me that the man who was in charge of supplying and updating the records would sometimes give him the records that were being replaced.

When I became a teenager and began listening to rock and roll music, my friends and I gathered at Kelsey's Restaurant to feed the jukebox with our quarters so we could hear the likes of Chuck Berry, Carl Perkins, Jerry Lee Lewis, Bill Black, and especially Bill Haley and the Comets, as they sang their most recent hits. At that time, we could only listen to our favorite artists on the radio or on jukeboxes; otherwise, we had to purchase our own, and most of my friends did not even have a phonograph player.

The booths at Kelsey's were filled on most weekends with teenagers who gathered to chat, eat, and find out what new recordings had been added to the jukebox. Sometimes we would have six or seven of our friends crammed into a booth as we took turns feeding the "box" with our change. Most of the time, we sang right along with the artists.

When I started to drive, my friends and I found new



Loretta and I just pulled four days within the friendly confines of St. Joseph's hospital in Lexington.

But this time I was not the patient. I stayed with her and slept on a recliner beside her bed simply because that's where I wanted to be, whether I was needed or not.

Lo had to have her thyroid gland removed and the surgery turned out to be rather more involved and complicated than we or the doctors had anticipated. I will spare you the more precise details. Suffice to say that a nerve was in the way because it wasn't where it was supposed to be and there was a mass of scar tissue to contend with from surgery she'd undergone 30 years ago.

The end result was far more intense and lasting pain than usually happens with this sort of surgery and, for the last week, my wife has literally been rendered speechless. The good news is that they didn't find cancer which was our big worry going in. The other good news is that she can take synthyroid, a medication that replaces all the stuff her thyroid produced naturally.

However, her vocal cords took a beating during the surgery and it may be weeks before she gets her voice back. It's like having the worse case of laryngitis imaginable. And if you know my wife, you also

know that she does so love to do some talking.

For the first several days, post surgery, she was in such intense pain that she stayed pretty much knocked out with opiates. She would not have been coherent if she had been able to vocalize. But the pain has gradually subsided and/or she has adjusted to it to the point that she only needs strong medicine at bed time and she has absolutely no plans for getting the prescription refilled.


I'm not the least bit worried that Loretta will become addicted to pain killers. My wife is one of those people who stay so naturally high on life that she neither needs nor wants any artificial stimulation. I've have never seen her even slightly inebriated on alcohol, for instance, and, to my knowledge, the stuff she's been taking for this go around with pain is the only thing she's ever ingested that made her loopy.

In the meantime, I am scared that she will become addicted to facebook. Loretta literally has to be communicating with someone, somehow, during most of the time she's awake. It's not uncommon for my buddy Ralph to call to ask me something and for Loretta to answer the phone, whereupon they spend 30 minutes in conversation.



NOW, THEREFORE, BE IT ORDAINED BY the City Council of Mt. Vernon, Kentucky as follows:

Mr. Bowman's letter last week touched on some important issues regarding the sports facilities here in Rockcastle County, and I appreciate his concern. His letter made it apparent to me, however, that there are obviously a great number of parents whose children play ball at the County's fields in Brodhead who are not aware of the support the fiscal court has given to the program over the years. We (the fiscal court) have given the program \$5,000 cash support during each of the past several years in addition to providing the weekly and daily maintenance of the property, the purchase of blacktop, and the rehabilitation of the structures, etc., at the Brodhead fields. Having said this, I am very aware of the condition of our county's facilities compared to those of neighboring counties. While impressed with Lincoln County's fields, I was totally blown away by the sports complex in Whitley County. Comparing Whitley's complex to Lincoln's is like comparing the Brodhead fields to Lincoln's. There is just no comparison, and Whitley's is impressive by any measure anywhere - even to having an amphitheater for nonsports events. My brother who is a coach agrees: We have not seen anything like it anywhere.

I hope the parents understand that I made a tremendous effort last year to move forward with a new sports complex, but a number of citizens (including CCFFG members) fought the proposal, and the fiscal court defeated my proposal. Having said this, we must not give up our efforts to provide stellar facilities for the youth of our communities in Rockcastle at some point in the future. The young people in our county are no less deserving than those in our neighboring counties. And although the proposals I set forth were turned down, I do appreciate the fiscal court for permitting the County to provide assistance to the Brodhead ball fields.

As I recall, the food was delicious, the jukebox had the latest hits, and the parking lot was large enough to accommodate all of our cars. Most of the time when we had enough food and music, we simply moved outside and sat on the hoods of our automobiles to watch our friends drive up and down the busy highway.

We're now back in the days of the 1920s and 1930s. There were no phones, electricity, or paved roads. Marguerite remembers each of these coming to her corner of the world. She recalls the first electric appliances the family owned: a clothes washer and toaster. The toaster was thought to be a wonder! Imagine toast without an oven! This was around 1940. The family home was already wired and ready to go, anticipating the soon-coming electric. She remembers the poles going up, and the wires soon followed, connecting electric to the homes. What excitement the first night that was aglow with electric light bulbs!

Soon came the phones. Of course they were all "party lines", but nonetheless Maretburg was now connected to the outside world. The road soon was paved, which allowed the women of the area to wear heels. Prior to this, walking on the old, muddy, uneven roads was difficult. Mary Ida Hunt-Jones had the first television in the area that could be remembered. Progress had come. Sometimes the most simple memories make a lasting impression. Marguerite could remember her mother making big country meals for the thrashers who would come and work in the fields. She remembers her mother mowing the yard with an old push mower that only had a few blades. Then, there were Mom's apple trees and many flowers bringing their yard to life. The farm had vegetable gardens and wheat fields that supplied wheat for bread, and sheep. There was a dog, "Ole Pat", who did his share of work at the farm and kept up with Marguerite. He followed along wherever she went, even to the local Maretburg school. Her relationship with God is very important to her, and was deeply-rooted from youth. There where Alfred and Sarah McGowan from Ireland who came as missionaries, and taught in local homes. These sessions were simply known as "meetings". The neighbors would gather at the various homes to be taught from the Bible. Some of the "parishioners" were Wade, Julia, Frank, Virgil, and Mae Hunt. John and Sybil Hunt had a cabin built on their land for the traveling missionaries. Alfred and Sarah McGowan spent quite a bit of time in the area. What truly fond memories to treasure, to keep a warm feeling in our heart and they're only a thought away, stored within the "Roots" of Rockcastle.

were in high school, we took our breaks and visited Mom and Pop's lunch counter, where we could feed the jukebox as we sipped on Cokes and ate chips. Sometimes a few of us gathered enough courage to dance to the sounds of rock and roll. On a rare occasions even more dramatic events occurred in the back room of that quant little establishment. If you were there, I suspect that you recall precisely what I am talking about. Needless to say, it wasn't anything that one would place inside a community newspaper – even today.

The only other restaurant in Rockcastle County that had a jukebox that I can remember was the Renfro Valley Lodge. Usually, when I frequented that eating establishment, I was with my family. Of course, they did not have much appreciation for the sounds of rock and roll, so we chose more subdued tunes by the likes of Perry Como, Johnny Mathis, or Nat King Cole. I distinctly recollect my mother, Bee, giving me some quarters and telling me to play Nat King Cole for her.

During my youth, jukeboxes created the scene for jumpin' and jivin' at our hangouts, and we loved the atmosphere. It is hard to imagine America without them. The eye-popping allure of bubble lights, neon tubes, and chrome hypnotized us out of our spare change. The owners of these establishments were smart enough to keep the latest hits on their machines, and we bought into the craze. The magnetism of these music machines kept us coming back for more and more and more.

For many years it was a dream of mine to own a Wurlitzer to place in my home. That would have been quite a rush – but, alas it



However, they are an increasing problem within the United States.

What is a bed bug?

The Centers for Disease Control and Prevention, the Environmental Protection Agency, and the U.S. Department of Agriculture all consider bed bugs to be a public health pest. Bed bugs are not known to transmit diseases but they can cause redness and swelling from their saliva during feeding. Bed bugs feed on blood and humans are their preferred food. Pets can also be hosts. Generally, bed bugs are nocturnal, meaning they come out at night.

#### Travel tips

With the increased problem, you may want to check your hotel room for signs of bed bugs. Here are some tips:

•Look at the sheets on the bed and the seams on the mattress and box spring. Do not forget to check the head of the bed.

•Look inside the dresser drawers, in the closet and along the baseboards for signs of bugs, shed skins or stains.

•Look for any rusty or reddish stains on the mattress or sheets.

If you find any signs of bed bugs:

•Request another room (far away from the current room). •Keep suitcases off of the floor on a luggage stand, table or other hard surface.

When you get home, wash all clothing in the washing machine as soon as possible. Examine luggage for signs that you may have brought home bed bugs.

If you have Internet access, it may be worth reading hotel reviews to see if anyone has previously reported bed bugs at the hotels you are considering. "Armor of God." The Bible School is for all ages, including adults. Everyone is welcome.

#### Election

The election of agricultural producers to the Farm Service Agency (FSA) county committees is important to all farmers and ranchers, whether beginning or long-established, large or small operation. It is crucial that every eligible producer participate in these elections because FSA county committees are a link between the agricultural community and the U.S. Department of Agriculture.

County Committee (COC) members are a critical component of FSA operations. The intent is to have the COC reflect the makeup of the producers and to represent all constituents. This means wherever possible, minorities, for the 2012 COC Election.

To become a nominee, eligible individuals must sign nomination form FSA-669A. The form includes a statement that the nominee agrees to serve if elected. This form is available at USDA http:// www.fsa.usda.gov/ Internet/FSA\_File/ fsa0669a\_commiteeelectform.pdf

Nomination forms for the 2012 election must be postmarked or received in the local USDA Service Center by close of business on Aug. 1, 2012.

Agricultural producers who participate or cooperate in an FSA program may be nominated for candidacy for the county committee. Individuals may nominate themselves or others as a candidate. Additionally, organizations representing minority and women farmers or ranchers may nominate candidates. Nomination forms are filed for the county committee of the office that administers a producer's farm

•"You've been selected by a national foundation to receive a scholarship." Check with a guidance counselor to find out if the foundation is legitimate. Be especially wary if you're notified that you're a finalist in a scholarship contest you didn't enter.

•"We'll do all the work." It's highly unlikely that the company will fill out all the applications for all the financial aid sources it sends you.

•"I just need your credit card or bank account number to hold this scholarship." Never give these numbers to a person or company you're not sure about. You could find your credit card maxed out and your bank account cleaned out.

•"You're guaranteed to get money for college or your money back." Read the fine print. If it sounds too good to be true, it probably



Hart had been a pharmacist at Mt. Vernon Drug for almost five years and worked three days a week and every other Saturday.


Kendall Kilbourne, Mt. Vernon Drug owner/pharmacist, said everyone was shocked when they first heard the news of her death.

Baker was also separately charged with possession of marijuana, drug paraphernalia, identity theft and criminal possession of a forged instrument.



### **The Cost of Drug Addiction**

Second in a series of articles concerning the scourge of drug addiction in our county. This series is being printed with the support of Cumberland River Mental Health; County Judge Exec. Buzz Carloftis, UNITE and Mayors Walter Cash, Mike Bryant and J.C. Griffin

Yesterday, as a couple of us made our rounds, i.e., walking through the neighborhood, stopping and talking, gathering the news and enjoying refreshments, a father called me into his garage to his work bench. He proceeded to show me a plastic container with an assortment of syringes in it. Then in a halting voice, "These were found along the roadside between here and the traffic light" -- some two blocks away. "My children walk this route nearly every day." Inquiring what they were, I already suspected them to be illicit drug purveyors. "Not only do these needles deliver illegal dangerous brain cell destroying drugs, they might well be contaminated with viruses including aids -- possibly a secondary death sentence from the same container. My children might have picked them up not recognizing the danger," he continued. "What can I do? How can I

protect our little ones?" His shoulders shook as he sobbed at this last inquiry. I had to say that I didn't know Most of us live above the scourge, occasionally observing the broken lives.


We hear the parental reports of thousands of dollars spent on rehabilitation, often to no avail. Reports circulate of children in jail because parents can no longer support them and their addiction. Parents have had to take out mortgages to cover bad checks. Reports of drug related emergency room visits are often circulated -one near death, one crippled, another dead. But where does this begin?

We have long had marijuana, LSD and a limited selection of these destructive agents. Now heroin, cocaine and any other socalled hard drug are available at most crossroads. Routes running from Rockcastle County to Mexico, to Florida, to eastern cities, even to the Near East are clearly established. Terrorists fund their operations with funds from these sales. Cartels of the darkest nature funnel drugs in one direction, money in the other. These are the guys who reportedly leave adversaries hanging from bridge overpasses just across the Mexican border.

No one in their right mind would support such people. To what personal end does such support lead: loss of friends, family, health, employment and interest in enjoying sports, music, literature, movies, concerts and the list goes on. Each individual might do well to look down, see the needles and filth that oozes among our people, to see the misery spreading like a fog around every household threatening every family in the land.

What are we to tell the acquaintance down the block with the dirty syringes? Who do we go to for advice? At what juncture does this destructive pendulum begin to swing the other way? How can the abuser be halted before the slide has reached addiction? How can the individual be armed to resist ever trying the deadly stuff? It is obvious that pushing the pendulum will require a significant change in behavior and behavior is governed by attitude.

Note: Rockcastle ranks in the second highest use area in the state for use of cocaine.



Several years ago when she was in her mid-50s, I asked my sister if she thought life had been unfair to her – if she had gotten a "raw deal." She quickly replied, "No. I have had a good life."

In 1998 she was diagnosed with breast cancer which necessitated radical surgery and chemotherapy. In 2001 her husband died suddenly in his early fifties, leaving her with a child in college and one in high school. In 2005 the cancer returned in her liver and bones, and she began chemotherapy again. In 2008 the cancer spread to her brain. She received chemotherapy, radiation and multiple gamma knife surgeries on her brain. On March 13, 2012 she breathed her last in the Hospice Unit at St. Joseph's Hospital in Lexington. She was free from pain and both her children were at her side. Mary Alice Whitehead was 59. While I and others might think she had been unfairly treated by life, she did not see it that way. She chose to focus on the good things that she had. She had a loving husband for more than 20 years. She had two children of whom she was extremely proud, and a new son-in-law about whom she felt the same. She had a career as a social worker and counselor that allowed her to use her gift for helping people. She had a rich network of friends and a church family whom she loved and who loved her. She definitely believed the glass was half full.

One of her mottos was "Accept the diagnosis; defy the prognosis." While she accepted that she had cancer, she did not accept the bleak assessment that she would live only a few months or years. She fought to live so that she could see her daughter married and her son receive his Ph.D. and she was present for both those occasions.

Another of her mottos was, "I will live until I die," or as she put it, "I'm not dying from cancer – I am living with cancer." She lived a full life with friends and family as long as she was able. It was only in the last year that the physical symptoms began to overwhelm her, but even then she told me, "I am still happy to be here." Perhaps her ability to see the positive and not dwell on the negative was what attracted so many people to her. Before and after her memorial service, I heard from her friends and coworkers how devoted they were to her and how much they had benefitted from having her in their lives. Her strong will allowed her to defy the prognosis and live longer than anyone predicted. The care that she received also prolonged her life. Her children lovingly provided for her needs. My mother at age 91 moved in with my sister to take care of her. Dr. Romond, Dr. Young and the staff at the University of Kentucky Hospital provided compassionate, cutting edge care

that extended her life. Her friends, family and church family kept her well fed and well loved.

After her disability forced her to retire, she took on a new role as my confidante and advisor. I spent weekends with her doing what we Whiteheads love to do: eating, reading, talking and watching sports on TV. Her insights helped me in my personal and professional life. Mary Alice, I will miss you. I hope I can retain just a little bit of your positive spirit. And I am sorry that you weren't here to see it, but the Cats won it all.





Newspapers w/inserts, magazines, books & catalogs, office paper, junk mail, phone books, plastic bottles & jugs (#1-7) (any size soda and water bottles, laundry detergent jugs, bleach and fabric softener jugs, milk and water jugs, cooking oil bottles and jugs, shampoo bottles,



dish liquid and alcohol bottles (please rinse out jugs), metal cans (rinsed), empty aerosol cans, aluminum cans, glass bottles and jars, sheet glass, ceramics, computers, radios, phones, vacuum cleaners, clocks, cameras, camcorders, vcr/dvd players and satellite boxes.

Rechargeable batteries such as those found in: cordless power tools, cellular phones (the whole phone can be recycled), cordless phones, laptop computers, digital cameras, two-way radios, camcorders and remote control toys. If its says rechargeable on it, then it's recyclable!
