

# Sheriff asks court to fund fourth "drug" deputy

Dale McNew, a deputy sheriff for Sheriff Mike Peters, was before the court Thursday to ask the court to fund a fourth deputy which would be used strictly for targeting drug problems."

McNew said the additional support would. amount to \$3,088 per. month, or \$37,056 a year, but would be offset somewhat by approximately \$12,000 the sheriff's department expects to return to the court in excess fees once the property tax audit is completed.

McNew also said with the addition of a drug enforcement deputy, the sheriff's office could possibly receive more forfeiture funds from the state and those funds could also help offset the cost.

The extra deputy would also entail the county having to increase the maximum salaries approved for the sheriff's office from \$250,000 to \$255,000,

McNew said.

After some discussion, the court decided to table the request for later consideration.

During the meeting, the court also did not take any action on three claims presented them by Rockcastle County Coroner Marvin Owens.

One of the claims was for \$1,181 which were the expenses involved in a conference Owens attended. Another, for \$696, was for trips to Frankfort to deliver bodies for autopsies at \$170 each and the third was for \$85 to Town and country for gas expense.

There was also a claim presented for \$350 by Dowell & Martin Funeral for picking up one of the bodies and transporting it back to the county for

# Court picks realty firm to sell former Anchor building

At last Thursday's monthly meeting of the Rockcastle County Fiscal Court, the court made a decision as to which realty company they would sign a contract with to market the former Anchor building.

The action came after the court asked RCIDA Executive Director Holly Hopkins if she had a recommendation as to which of the two companies, who made a presentation to the court, they should hire.

Hopkins said that she did not that she felt the court "couldn't go wrong with either company."

The biggest difference between the two presentations was that one, Newmark Grubb Knight Frank told the court in their presentation that they thought the building would sell for around \$2.6 million while the other, Binswanger, said they felt the top asking price should be \$3.6 mil-

The building has been appraised at \$3.1 million and replacement costs would be \$14 million,

Morehead. Stallsworth performed a total of 912 commercial motor vehicle safety inspections in 2014. He removed 245 driver and 306 commercial motor vehicles from the roadway that met the out-ofservice criteria. He maintained a driver out-of-service rate of 27 percent and a vehicle out-of-service rate and that he owes everything of 46 percent.

Stallsworth also issued a



Great friend and fellow columnist, the late Dick Ham, told me this one when we were temporary roommates and residents in physical rehabilitation together at Telford Terrace in Richmond. It has been making the rounds on the internet, recently, but Dick first told it to our therapist and me in the autumnof 2012.

Seems this city fellow was driving down a rural highway because MapQuest told him he could cut about 20 miles off his trip and save time loo if he got off the interstate.

He was tooling along, worry-free, and was way out in the country where houses seemed to be at least 3 miles apart and about all there was, on either side of the road, was grazing cattle, to-bacco patches, stacks of baled hayand cornfields as far as the eye could see.

About the time that he realized he was in the middle of nowhere, he saw a homemade sign coming up on the right side of the road. Written with a can of spray paint on large piece of plywood and braced up with half a dozen old tobacco sticks, in a bright yellow, metal-flake color that looked like it might glow in the dark, the sign announced, "TALKING DOG FOR SALE—CHEAP".

Figuring he had already saved more than half an hour by taking the detour, the fellow could not resist the urge to find out more about this dog. So he pulled into the driveway, got out of his fancy little sports car, sauntered up onto the porch and yelled through the front door, which was standing wide open and had a big floor fan running full tilt, blocking entrance, "Is anybody here?"



World Book Encyclopedia
In 1952, when I was eight
years old, my mother (Bee)
and I were living in a small
house on my grandfather's
hillfop farm in Rockcastle
County One day a salesman
appeared at the door and
proceeded to explain that he
was a World Book Encyclopedia representative. He
asked to demonstrate the latest edition of the encyclope-

Bee invited him inside, and we sat in the living room of our house as he displayed the new books that were available. He asked me my name and questioned me about my personal interests. When I mentioned dogs, he handed me a copy of the "D" encyclopedia. While they continued their conversation, I became engrossed in a massive collection of color photographs of the different breeds of dogs.

After about an hour (and I'm sure after noting how captivated I was with the one that he had handed over to me), Bee decided to purchase a set of those wonderful books. She had been a teacher and was well aware of the value of such a resource being available to a young child who had barely begun his education.

I was elated because I could now have an entire library of knowledge right in my own home. I had the ability to look up any topic of my choosing! It was a real blessing; very few of my friends had encyclopedias personally available to them.

The books arrived within a few weeks, and I became completely hooked upon the vast information at inv fino gertips. On numerous occasions, I would take a copy of a single book from the collection and sit on my bed, slowly turning the pages in an attempt to soak up the knowledge that was on each page. I found it all fascinating.

Over time, many of my friends came to my home in the evenings after school to use our encyclopedias for their homework assignments. Having those books was just amazingly cool. I can't begin to count the

Throughout my elementary and high school days, I used the books for my class assignments. They kept me from having to go to the school library to do my research. I had my own set of research materials right in my home. I even used those books when I came home in 1962 on weekends from the University of Kentucky. I remember doing a biology paper on the subject of ecology for which I received an "A".

I received my BS degree in December of 1965 and began teaching in January of 1966. I was hired by Campbellsville High School to teach chemistry, to serve as an assistant football coach, and to be the head golf coach. I was so happy to find a job like I had been dreaming of in collège. In those days, teachers were paid on a contract of nine and a half months. We did not receive any pay in the summer, making it was necessary to get summer jobs.

The first summer, I'noticed an ad in the local paper searching for teachers to sell World Book Encyclopedias, I quickly applied and was hired immediately. The training took a full week, and I was then sent out on my own. I spent that entire summer knocking on doors trying to get my "foot in the door" to demonstrate these books to parents - usually mothers who were at home with the kids. If you could get inside, the encyclopedias would almost sell themselves. I have no idea how





are truly thankful. wherever you are. Gloria Robbins



Leger told the court that he felt they should determine what Mr. Owens' \$500 a month salary covers and if the expenses submitted were after the \$300 he receives monthly for expenses were deducted or before. He also told the court that they "don't want to set a precedent of reimbursing funeral homes."

The claims were tabled until the court's called meeting near the end of the month.

· During the meeting, the court also voted to begin the and recreation board.

RCIDA board member Sam Hamilton told the court that he was very much in favor of the idea that it would help plan for the development of future needs besides being able to keep up with what is being spent. "It would involve a total assessment," Hamilton said.

Hamilton also said that a board could help plan additional events for the fairgrounds such as gospel singings, free movie nights and for possible tournaments which would bring money into the county to local businesses and entry fee revenue to the board which would help offset costs of the events.

The board should be aimed at "getting people involved who want to do something in the county," Hamilton said.

However, the court took no action on two names submitted by the tourist commission to fill two vacancies on their board. The court decided to ask for more names to be submitted so the court would have more choices for the appointments.

The court did approve a new phone system for the courthouse which will provide a central number for callers who can then select phetamine and the second from a menu which office they need to speak to. It will of a controlled substance also give the different offices in the courthouse the ability to transfer calls. which they cannot do at present. Callers who know which office they need can

also dial that office's number directly.

Judge Bishop told the court that the new system would immediately save the county \$249 monthly on their current telephone service. The county will realize an even bigger savings when their monthly lease fee (\$366.84) is paid off in five years and can be bought out for \$1.

The court also approved hiring up to four part-time workers for the county road department for the summer. Judge Bishop said the workers were needed to help road department employees catch up on mowing rightof-ways. The jobs will pay \$10 per hour but will not include any benefits. The temp workers will be able to work up to 98 hours a

The question also arose during the meeting of providing the 12 workers, who do not participate in the county's health insurance program, a \$500 medical card which they can use to defray medical costs.

Judge Bishop noted that each employee who does not participate in the health insurance program saves the county about \$3,500 per year and he felt this extra benefit would be a good thing, "if we can afford it."

The issue was tabled for a decision at a later date.

The court also approved an expenditure of \$47,500 in July for front money for the sidewalk project at Livingston. The money will be used to pay invoices to the construction company and engineering fees from June 22nd when the project is expected to begin and which will be billed out to Livingston July 1st.

The invoices must be paid before being submitted to the state transportation cabinet for 80% reimbursement under the terms of the grant.

The county is providing the 20% needed for the city's share of the grant mostly by providing in-kind labor and equipment from the road department. The expected total cash outlayed for the county will be approximately, \$22,451, Bishop told the court.

In other action, the court approved the expense reports for May for the RCIDA of \$9,270.47 and the Rockcastle County Development Board Program of \$2,798.42.

The court also approved \$2,175 for project materials for the Americorp team which will be in Livingston. working on Trailtown projects from July 23 to August 27th.

The team will be housed in the old school building which has kitchen and bath-

room facilities. Other items approved, included: \$2,803 for the preparation of tax bills by County Clerk Danetta Allen; \$1,560 for insulation of the Quail Park building; a \$5,000 donation to the Little League program and \$2,495 to reduce the size of a water line at Climax Vol-

unteer Fire Dept. in order to reduce their monthly bill from \$150 to under \$30 per

As a final item of business, the court approved transferring \$200,000 from the occupational tax fund to the general fund of which \$75,000 will be transferred to the detention center to pay expenses through June

The budget shows \$1,304,757 for water department operation and maintenance, \$80,000 for street maintenance and \$367,024 for sewer department operation and maintenance.

The council unanimously adopted the budget for the 2015-2016 fiscal

Mayor Mike Bryant presented the 2016 blacktop bids to the council. Bryant said they only only received one bid, from Elmo Greer and Sons; for \$82 a ton. Bryant said the quote in the blacktop bid would cover any blacktop projects in the city for 2016. The council approved the bid.

In the final item of business, Bryant presented a resolution to apply for a Kentucky Office of Homeland Security grant for new weapons for the police department.

City Administrator Josh Bray said that there is no amount on the grant and that the amount is based on funding at the time. He also said the grant was a 100% grant and not a matching grant.

Bray said they will apply for several shotguns and rifles for the police department. He said if they are awarded the grant, the police department will also receive 500 rounds of ammunition per weapon.

The council unanimously approved a resolution to allow the police department to apply for the homeland security grant.

Fire Chief David Bales gave the council his department's activity report for May. According to the report, 26 runs were made for 1 structure fire, 2 vehicle fires, 2 vegetation fires, 1 smoke investigation, 11 vehicle accidents without extrication, 3 vehicle accidents with extrication, 2 false alarms, 2 service calls, 1 mutual aid given and 1 automatic mutual aid given.

Police Chief Brian Carter also gave the council his department's report for May. The report showed 365 total calls for service, 9 non-injury accidents, 1 injury accident, 36 total arrests, 5 drug charges, 18 traffic violations, 15 other criminal charges, 23 warrants served and 1 DUI.

Carter also informed the council that former Assistant Chief Barry Adams resigned his position last Thursday. Carter said that he resigned because of "personal reasons."

Cliff Councilman Mullins asked Carter if he was seeking a replacement or if they planned on accepting applications for the assistant chief position. Bryant said that he and Carter were going to meet later this week and discuss how they will fill the posi-

We have hired differently in the past. We are not for sure if we will hire through an internal promotion or if we will hire someone from outside the department," Bryant said. "We're going to meet later and discuss how to go forward with filling the position,"



groundcovers? Here are some that work well for me, but I am sure there are oth-

Let's start with a serviceberry (amèlanchier), either a tree form or a clump. Let's locate it to sort of lean towards our waterfall or stream. We'll get lovely white blooms in March, and juicy fruit in June if we beat the birds to it. (You can't say that about a crepe myrtle or a Japanese maple.)

If the water feature is out in the yard and away from big trees, away from any woodland, I always want to add at least one small tree as I landscape it. Ideally, positioned to keep part of the day's sunlight off the stream or pond, which will help with low oxygen and algae problems. Besides the sarvis, Saskatoon, shadbush or service berry, (depends on where you're from) what other trees that bear food would work for that one (or two or three!) tree you plan to put in the waterfall or water garden landscape?

I've used pawpaws, they resemble a deciduous magnolia. You need two in a clump or another tree in the yard somewhere for good pollination. A quince or a dwarfish apple could work. A simi-dwarf self-fruitful cherry or a cornelian cherry dogwood would be a lovely addition. More exotic options: jujubes, olives, various citrus trees, or a mayhaw or a mountain ash bred for its fruit. Medlar or mulberry—the medlar tasts like apple butter with cinnamon sprinkled on. Do a little checking to see if a plant will live and prosper in your climate as you add fruiting trees around your pond and waterfall. For an evergreen, use Korean nut pine, Swiss stone pine or in the SW United States, the pinyon pine - pine nuts are

delicious! Next, add some shrubs of varying sizes forla natu-orl ralized look. I automatically go to the blueberry. There are blueberries that grow from Orlando to Ottawa, from a foot to 8 feet tall, and some keep their colored leaves most of the winter at least in USDA planting zones 7-10. A rather new fruiting bush I highly recommend for zones 3 through 5, and worthy of trial in 6 and 7, is the honeyberry or haskap. I also will use currants, gooseberries, seaberries, bearberries and the upright thornless blackberries. Oregon grape holly is an ev-

ergreen that is lovely and has edible blue berries (even if not too tasty, they are good for you). The right edible shrub in the right location can make for both good landscaping and yummy snacking. (Metaphorically, I always love killing two birds with one stone.)

OK, let's add a blossom or two. Ever add daylily blossoms to your salad? I prefer them a couple days before the bloom opens myself. They can also be batter dipped and deep fried. In Asian cuisine they are both staple and delicacy. Asparagus, onions, fennel, flowering kale, Swiss chard are all reasonable edible items that look nice in the landscape. And you can always find a way to hide one tomato plant or one hot pepper plant if you don't want to showcase it.

Finishing our layered naturalizing look, add creeping groundcover plants. Watercress is great in the bog or waterfall box, but cranberries can really naturalize a streambank or pond edge (see photo). Creeping rosemary for zone 7 and southward is wonderful at naturalizing pond edges. Wintergreen (gaultheria), also known as mountain tea or feaberry, is a cute little creeping evergreen for the shade. (Cranberries prefer sun.) Sheep sorrel or oxalis are tasty in a salad and do wonders to naturalize a waterfall edge. Creeping raspberries, lingonberries, kinnikinnick, pineberries and Alpine strawberries would all be naturalizing as well as bear edible fruit.

Now, if you have a fence or some lattice or an arbor near your waterfature, here are some climbers to use. Scarlet runner beans if you an annual.

Passionfruit, magnolia vine, hardy kiwi, hops, ornamental grapes and goji berries all look nice and also fruit. Tasmanian vine for the tropics. With all these fresh

goodies your trips to the produce stand should be reduced a great deal, and the landscaping will be lovely too. Checking to see what's • ready to eat would be extra incentive to get out and enjoy the water feature. Why go with a nandina or a Japanese maple or a boxwood around your pond when you can have a whole food forest to munch on and the most natural looking waterfall in your whole town!

# Young wildlife best left undisturbed

curled up in tall grass. A litter of rabbits discovered alone in the backyard. A baby bird furiously flapping its wings but struggling to get off the ground.

It's human nature to want to take matters into your own hands in such instances. After all, we see and read stories about firefighters rescuing kittens from burning houses or technical rescue teams saving horses and livestock that have fallen into icy ponds. In nature, however, human intervention is not always what is best for wildlife.

"This is the time of year when white-tailed deer and other animals have their young," said Gabe Jenkins, deer and elk program coordinator with the Kentucky Department of Fish and Wildlife Resources. "It's best to leave them alone."

The Information Center at Kentucky Fish and Wildlife's headquarters fields about 100,000 phone calls and upward of 40,000 emails from the public each year. Invariably, spring brings an influx of communications from well-intentioned people concerned about young wildlife seemingly abandoned by their

Newborn deer spend much of their time bedded down until they are about a month old and strong enough to follow their mother. Their reddishbrown coat patterned with pale spots helps camouflage them in dappled sunlight.

"Just like human babies, they're small, weak and need time to grow," Jenkins said. "They eat, they sleep and that's about it. The more they venture out and move around, the greater the chances are of them being preyed upon. Mom puts them in a spot or leaves them. The more she comes back and spends time there the more she brings her scent to that spot. The fawns are essentially scentless."

The mother deer will visit her fawn to nurse and typically does not stray far from it between feedings. The separation may alarm somebody who discovers an unattended fawn but it helps divert predators' attention away from the baby deer.

'Momma didn't abandon them," Jenkins said. "She placed them there. She knows where they're at, or is very close, and she will come back."

mother for several hours with no response, is obviously injured, or where the mother deer was observed being hit by a car, a call should be placed to a wildlife rehabilitator.

"We don't want you to go pick it up and hold it or keep it," Jenkins said. "They are wild animals.'

Orphaned and injured wildlife may be possessed only by a permitted wildlife rehabilitator. A searchable list of these rehabilitators is available on Kentucky Fish and Wildlife's website at fw.ky.gov. Click on the "Wildlife" tab and choose "Injured & Orphaned Wildlife" from the dropdown menu. Only persons with a captive cervid permit may keep deer in captivity.

Landowners who encounter a deer fawn that is in the way while cutting hay or mowing can be moved a short distance out of the way. The mother should still be able to find the fawn when she returns to nurse it.

Encounters with rabbit nests in suburban settings are fairly common this time of year.


"Rabbits can start nesting as early as February and they'll go throughout the spring and summer months," said Ben Robinson, small game biologist with Kentucky Fish and Wildlife. "Maybe somebody stumbles across a litter of rabbits in their yard or in their field and they call and wonder what to do. Many times nothing needs to be done."

Placing a flag or a stake near the area can help mark the nest site for reference when mowing in the future.

"Unless something traumatic has happened to the mother, they're probably close by," Robinson said. "So they're going to do just fine taking care of those babies. So the best thing you can do is leave them alone."

Wildlife have successfully reared their young for ages relying on instincts that have evolved over time. It's best to observe them, not handle them. People are no substitute for natural wildlife parents.





# Water filtering stations installed at RCHS

Along with the buzz of end-of-year activities and graduation, Rockcastle County High School students and staff were excited about a new addition to the school.

Early in the semester, the RCHS Student Council started pursuing the purchase of a filtered water bottle filling station. As a member of the Rockeastle Healthy Community Coalition, senior member Anna Poynter went to the coalition for help.

Rockcastle Area Technology Center tested 63 students for the ACT Work Keys Assessment and attained their highest ever pass rate of 95.23%, ranking them #1 in the state.

Of the 63 students taking the assessment 68.3% earned a Silver Certificate and 27% earned a Gold Certificate, the highest percentage of gold certificates awarded state-wide.

•Silver for a minimum level score of 4 on all three assessments. Demonstrates the skill levels needed in 65% of today's jobs.

•Gold for a minimum level score of 5 on all three assessments. Demonstrates skill levels needed in 90% of today's jobs.

•Platinum for a minimum level score of 6 on all three assessments. Demonstrates the skill levels needed in 99% of today's jobs.

# Agricultural News By: Warden Alexander, FSA Director

Farm Service Agency County Committee Nomination Period Begins June 15

The U.S. Department of Agriculture today announced that the nomination period for local Farm Service Agency (FSA) county committees begins on Monday, June 15,

It is important for county committees to reflect America's diversity, all eligible farmers and ranchers, including beginning farmers are encouraged to get involved in this year's elections. FSA has' seen an increase in the

number of nominations for qualified candidates, especially among women and minorities - a trend the Agency would like to see continue.

To be eligible to serve on a FSA county committee, a person must participate or cooperate in an agency administered program, be eligible to vote in a county committee election and reside in the local administrative area where they are nominated.

Farmers and ranchers may nominate themselves or others. Organizations representing minorities and women also may

nominate candidates. To become a candidate, an eligible individual must sign an FSA-669A nomination form. The form and other information about FSA county committee elections are available at www.fsa.usda.gov/elections. Nomination forms for the 2015 election must be postmarked or received in the local USDA Service Center by close of business on Aug. 3, 2015.

While FSA county committees do not approve or deny farm own-

Members serve three-year terms. Nationwide, there are about 7,800 farmers and ranchers serving on FSA county committees. Committees consist of three to 11 members that are elected by eligible producers.




